Hello Deb,

Thanks for your time yesterday to brief me on the s.12 initiative and to discuss the path forward for this work.

As we had spoken about, this submission should go to Cabinet Committee on Sustainable Shared Prosperity, and would need to go to the Deputy Ministers Committee for review first. I had advised Fazil Mihlar after our call that we would like to have this on the DMCSSP agenda for March 19 if possible. This would potentially put it on the CCSSP agenda for April 10 and allow for a Treasury Board timeframe sometime in May. Francois Bertrand from JTT will be in touch to coordinate around the DMCSSP schedule.

MOTI's presentations for Priorities and Accountability Committee have typically been platform items, and have had regular check-ins with our office as materials were developed. If there is anything we can do to help you prepare for DMCSSP / CCSSP, let us know.
