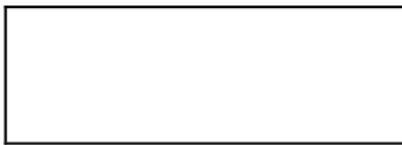

We will be observing this in Surrey this year(venue to be announced) on Feb 21st and was hoping to repeat this in Victoria Parliament on Feb 22nd. We have a smaller prototype art piece that we erect yearly, which takes about 1 hr. And people usually take pictures in front of it/give flowers to recognize the International Mother Language Day. Can you be any help in regards to doing this at the Parliament?

Hi Vanessa,

Can you tell me where the budget approval process is at for LNY Dim Sum on Feb 4? Joleen is getting much higher price quotes this year than last. She has looked at 7-8 venues, all of which are proposing around \$600-\$800/table of 10. We are going to do some negotiating to hopefully bring that down, but has the BEA already been submitted?

I expect that the \$600/table quote would put us between \$12,000-\$18,000 for food for 200-300 people. This is compared to an estimated \$8000 in food costs based on last year's per person food quotes. Overall, this would bring the

event budget to \$13,000-\$19,000 as the only other costs are small honoraria for performance. Attached is the original budget I had proposed with revisions.

We can always reduce expected attendance from 300 to 200 guests. That would bring total expenses (@\$600/table) to \$13,000. My hope is to bring the table cost down to about \$400/table, but we'll see what is possible.

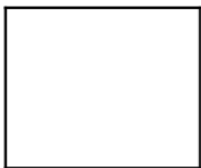
