SUMMARY OF OPPORTUNITY FOR DISCUSSION WITH GOVERNOR INSLEE

There is a shared opportunity to:

- Reduce/eliminate tanker traffic in the Salish Sea (inbound and outbound)
- Reduce/eliminate oil-by-rail shipments from Alberta to BC/WA
- Reduce/eliminate the shipment of bitumen/heavy oil by both pipeline and rail in BC/WA
- Ensure a long-term supply of fuel to WA refineries
- Reduce GHG emissions locally and globally
- Make a significant contribution to orca protection and reduce spill risk

The opportunity consists of:

- Revisiting the TMX project to a) reduce the size of expansion and b) reroute the expansion through the Sumas connector into the WA refineries
- Upgrading heavy oil at source in Alberta using BC hydroelectric power to reduced GHGs and avoid shipping bitumen

Next steps:

- Convene a BC/WA working group to develop the opportunity
- BC to engage with Canada and Alberta on the opportunity

BACKGROUND

- Currently there 5 refineries in Washington state (BP, Shell, Philips, Tesoro,
 Trailstone) that consume about 573 kbpd (thousands of barrels per day) of oil and
 have capacity of 638 kpd. The oil to these refineries is supplied by tanker imports
 primarily from Alaska (245kbpd), rail shipments primarily from the Bakken
 region (150 kbpd), and pipeline imports on the Trans Mountain (TM) Sumas
 pipeline from Alberta (176 kbpd).
- The TMX proposal is to increase capacity from 300 kbpd to 890 kbpd which
 would result in an increase in tanker exports from Burnaby BC to about 300+
 tankers per year. This would increase the total loaded tanker trips in the Salish Sea
 to 500+ tankers annually, which includes the tankers supplying the Cherry Point
 refineries.

While there are multiple scenarios to reconfigure the TMX project, the above option is based on a smaller expansion of TMX to 590 kbpd (+290 kbpd). Under this option, the increased shipments on TMX would displace Alaskan tanker imports and Bakken rail imports, resulting in the opportunity to eliminate tanker traffic in the Salish Sea.

TMX: Federal Re-Approval

Issue:

- The Federal Government is expected to announce re-approval of the Trans Mountain Expansion on or about June 18th.
- A re-approval may increase pressure from some stakeholders for the BC government to identify and use new tools to address the risks of the project.
- Judy Wilson (Secretary Treasurer of UBCIC) and Rueben George (member of the Tsleil-Waututh Nation) have both spoken publicly about their concerns with the federal consultation process.
- It is anticipated that one or more First Nations will launch new legal action challenging the Federal Government's consultation and re-approval. Timing and details of this are unknown.
- BC filed the Notice of Appeal with the Supreme Court on June 14th. It's a procedural filing and did not include the detailed arguments BC will make in the case.

Approach:

 BC Government should highlight consistent, balanced approach and point to ongoing reference question and possibility of further litigation from First Nations.

Our overall frame on TMX:

- BC has taken a balanced approach, respecting the rule of law and our legal obligations while defending BC's interests against risks to our environment and economy.
- We joined the pre-existing federal court case to argue that the federal government failed to adequately consider the serious risks to British Columbia when they approved the project.
- Where there were questions raised about the province's jurisdiction to introduce environmental regulations, we took the responsible approach and referred the question to the courts for resolution. We are taking that question to the Supreme Court of Canada to resolve.
- BC has been processing permit applications in a fair and timely manner as they are received from the company.

Draft Key Messages on re-approval:

- Our government has a responsibility to defend the interests of British Columbians and that's exactly what we've been consistent in doing.
- It's why we launched our reference question in the first place, and it's why we'll take our case to the Supreme Court.
- We note that a number of Indigenous governments have [announced/raised the possibility of] new legal challenges to the federal approval.
- We will continue to defend our environment, our coast, and the tens of thousands of jobs that rely on them.

Other Related Issues

Potential First Nations Ownership Stake

 Two different First Nation groups (Project Reconciliation and Iron Coalition) have indicated interest in coordinating First Nations in BC, Alberta and Saskatchewan to acquire a majority ownership stake in TMX.

Draft Response

- There are many First Nations whose rights and title are impacted, with a diversity of views.
- There are some First Nations who have expressed support and there are others who are opposed and took the project approval to federal court.
- It's not the place of the province to weigh into potential business deals between nations, companies and the federal government.
- What I can speak to are the actions our government is taking to protect our land and waters and the thousands of good paying jobs that depend on them.
- Regardless of who owns the pipeline, our government has a responsibility to defend our coast, environment and jobs from the risk of an oil spill.

Reference Question (note: not specific to TMX but relevant context)

- On May 24th, BC announced that it will appeal the decision of the BC Court of Appeal on the reference question to the Supreme Court of Canada.
- The Province filed the Notice of Appeal on June 14th. Timing of presentation of arguments and hearings will be in the hands of the Court.

Draft Response

- Our government said from the outset that we would stand up for British Columbia's environment, economy and coast.
- We've been clear that no matter the outcome of this case, the issue would likely end up at the Supreme Court of Canada.
- In fact, we invited the federal government to work with us to send it directly to the Supreme Court of Canada in the first place.
- We continue to believe that we have the authority and the responsibility to defend our environment and economy, so we are appealing to the Supreme Court of Canada.

Bill 12

- BC has filed a legal challenge and sought an injunction against Alberta's Bill 12 which purports to give the AB government powers to direct the flow of oil and refined product to BC.
- AB has argued that the BC Attorney General lacks standing to challenge the law in Alberta. In response, the Attorney General is filing a Statement of Claim in Federal Court while seeking an abeyance pending determination of the AB Court challenge.

Draft Response

- We are confident that the government of Alberta won't be able to use these supposed new powers because they are unlawful. That's why we filed in court immediately.
- We will stand up for British Columbians against this unconstitutional threat.

Draft QAs

Your government said you'd use every tool in the toolbox to stop Trans Mountain. Are you considering other tools at this time?

- We have been clear and consistent in standing up for British Columbians' interests.
- We are continuing to pursue our reference question to confirm the Province's authority to regulate to defend the environment, our economy and our coast.
- We want to ensure we have the ability to address the risks posed by any significant increase in the volume of dilute bitumen traveling through our province.
- That is our focus and that is why we will be appealing to the Supreme Court of Canada.

Will you participate in another federal court case against the approval?

- We have been clear and consistent in standing up for British Columbians' interests.
- While some First Nations have talked about the possibility of a further court challenge, we haven't seen any details at this time.

How many permits has your government approved for this project?

- Our government has been processing permit applications in a fair and timely manner as they are received from the company.
- That's something the company itself has acknowledged.
- As of early June, we've approved 310 permit applications.

Construction is meant to start in the Lower Mainland this summer. Are you concerned about protests?

- Decisions about construction locations and timelines are up to the federal government and the company, not us.
- We know people feel passionately about this and have a right to express themselves within the rules of the law.

A new poll shows 60% of British Columbians support the expansion project. Why does your government continue to oppose this project?

- Our government strongly believes that this project is not in the interests of British Columbians.
- An oil spill on our coast would put thousands of jobs and billions of dollars in economic activity at risk.
- We will continue to defend our environment, our coast and our jobs.

Wouldn't building the pipeline bring down gas prices?

- The pipeline expansion is intended to increase exports of diluted bitumen not meet the needs
 of British Columbians.
- The company told regulators during the NEB review that it would lead to no increase in gasoline shipments.
- The Chief Economist of the NEB said last month that the expansion could actually increase gasoline prices.
- We have asked the BC Utilities Commission to conduct an investigation into the unexplained increases in gas prices and seek answers from oil companies.
- The Premier has asked the Prime Minister to look at adjusting the mix of what's in the current pipe to give BC drivers some relief.

What is the difference between Alberta's' Bill 12 and B.C.'s proposal? How can you fight Alberta's attempt to control shipments while trying to do the same?

- Our reference question is about protecting the environment and thousands of BC jobs. Alberta's legislation is about restricting trade.
- Alberta's legislation is designed to pressure and punish British Columbia as such it is clearly unconstitutional.
- When there was a dispute about the extent of our jurisdiction, we decided to send the question to court to confirm our rights.
- Meanwhile, Alberta proclaimed a piece of legislation they know to be unconstitutional to threaten people in B.C. We will defend them.

What do you say to communities who face the risk of a heavy bitumen spill?

- Our government has been clear that we are very concerned by the risk that an oil spill poses to our environment, our coast and the tens of thousands of jobs that depend on them.
- We have a responsibility to defend the interests of British Columbians and that's exactly what we've been consistent in doing.
- It's why we launched the reference question in the first place, and it's why we're taking the case to the Supreme Court of Canada.
- We will continue to defend our jobs and our coast.

What's the status of the reference question?

- We filed our Notice of Appeal with the Supreme Court of Canada on Friday June 14th.
- The scheduling is now in the hands of the court.

What's the status of the Bill 12 court challenge?

- We filed in court immediately to strike the bill down and protect British Columbians in the meantime.
- I don't believe the Alberta government will try to use the supposed new powers because they know they are unconstitutional.
- BC will be responding to arguments filed by Alberta in due course.

How much are all these court cases costing British Columbians?

- A serious spill of diluted bitumen could threaten billions of dollars of economic activity and tens
 of thousands of jobs.
- We have an obligation to stand up for British Columbians and defend our environment and our economy.
- When it comes to the reference question, we asked the Federal Government to join us in a joint reference to the Supreme Court which would have been faster for all of us but they declined.

Are you worried that B.C.'s opposition to TMX will lead to an increase in oil by rail, especially in light of Alberta's move to obtain more railcars?

- Our government takes the movement of oil by rail very seriously.
- We are committed to protecting people and the environment from the risks of diluted bitumen regardless of how it is shipped.
- We've already brought in new regulations to improve spill preparedness and response for rail shipments.
