Dear Shelley,
I apologize for the late reply. My inbox is a bit overwhelmed these days...
To answer your question regarding the funding of the learning program, here is a quick overview:

- **Action Canada** - fully funded by Government of Canada (Canada History Fund) and other private sector organizations both in cash contributions/ donations and in-kind contributions (e.g. this year: Power Corporation of Canada, ViaRail, University of Guelph, etc.). Fellows don't have to pay any fees/ tuition. Travel costs and any other expense related to the program are also covered by the Fellowship.
- The other three programs (reconciliation, disruptive tech and policy leadership) are all based on a cost-recovery model which means that the registration fee for each program (between \$1,800 - \$9,500) is fully covering the cost of the program (speakers, labour, catering, room rental, etc.).

I hope this answers your question regarding the funding.

No pre-knowledge is required. We are seeing to learn how we might be more useful to various stakeholders - and I will begin by explaining where we're at today.

It may be that Don chose to ask someone from labour because one of our main points of concentration over the next several years will be a Future of Work project. We'd be glad to tell you more about these plans.

Thank you for your telephone message following up with my request to meet with key leaders in the Deputy Minister to the Premier Office. I am so thrilled just to have a connection with you, so that I can tell you about my work.

The questions I am asking centre around women's experiences advancing to leadership and whether they have used informal relationships (friendships, informal mentoring and networking) as a way to get around standard organizational barriers that have thwarted, postponed, sidelined or prevented upward mobility.

This is a feminist analysis, however the reason it is so important is because I propose there is a culture of female-to-female marginalization, perhaps in certain sectors of the organization, that is at the foundation of leadership mobility where women find themselves competing for a limited number of positions available to them at the top of the hierarchy. To date, organizational studies based in a gender analysis have focused on the male/female and masculine/feminine dichotomy. While this work makes a distinction between masculine and feminine leadership, the analysis has shifted to how the distinction has impacted the culture of support for women's advancement among women themselves.

The goal of the research is to understand women's experiences in a very concrete way. I will contextually analyze the results of the study as it relates to the state of the Public Service today. From a strategic standpoint, the ultimate goal is to build an organizational structure that supports modern leadership values, and establishes an environment of exceptional leadership where women are not only safe to support each other but can also freely celebrate each other's successes through a collective conscience, discourse and culture.

In June of 2018, I emailed Lori Halls, Deputy Minister, BC Public Service Agency. I sent Lori a proposal of my research and asked her if she would be willing to act as my "client" for the project and she agreed. As my client, I will produce a report for Lori that will make policy recommendations for the organization that is based on my findings. Lori also introduced me to leadership within the Gender Equity Office (GEO).

With the help of the GEO, I have succeeded in securing close to 40 interviews with women who hold positions in BC Public Service senior leadership. To date, I have conducted 15 interviews and will continue to meet with women until I have met with all who have agreed to participate in this study. s.22

There are many women in senior leadership roles with the Deputy to the Premier's Office who would add immense value to this project. Not just that, the project itself and its cause significantly benefits from having the Deputy to the Premier's Office advocating for the work I am doing. It goes without saying, if the Deputy Minister to the Premier himself would find time to meet with me, hear about my project and advocate for the work I am doing, we could get so much done together. I am incredibly passionate about this work, Shelley, and Deputy Minister Wright will see that in me immediately. The Women Deliver 2019 Event, taking place at UBC is approaching in June - this is a beautiful opportunity to bring women in Public Service leadership together to showcase, celebrate, support and acknowledge our achievements, progress and vision. BC can lead the way.
