Per our call this afternoon, the attached document outlines the spirit and intent of the 'Excellence in Location Production' Forum we're are holding May 31-June 1 in Vancouver.

While the document outlines our plans, I would like to add a side note that speaks to the importance of these events :)

As I mentioned to you when we chatted -- we have been engaging with various stakeholders across industry, municipal governments, provincial agencies and ministries, community stakeholders across same -- to integrate the interests of all concerned and make BC's production industry something that people across the province understand, can share in and contribute to our leading reputation across the international production community.

With content creation for film, tv and all media platforms exploding, location production around the world is on a steep trajectory -- so there has never been a more important time for all stakeholders across every interest group to converge on priorities and best practices that will keep us flourishing in the best possible way over the long haul. Everything we've been working on with the Industry Stewardship Project points in this direction.

The subject matter in this instance is 'Excellence in Location Production' to highlight the delicate art of location management as critical to success in physical production in the broadest sense. Without success on location, there is no success -- and it's the key area where the pain points of high volume production will most readily reveal themselves. It is essentially the most public side of production, not including when the content hits the screen.

The following rule in the Standing Orders states that Members must rise uncovered to address the Speaker. "36. Every Member desiring to speak is to rise in his or her place, uncovered, and address the Speaker." However, please note that specific details pertaining to religious attire are not outlined. See also attached for some explanation on S.O. 36 from MacMinn's Parliamentary Practice in British Columbia (Fourth Edition).

My colleagues and I are unaware of a strict ban on religious headwear in the Chamber. For clarification on the dress code, the Office of the Speaker would be the best source to follow up with. If you would like us to contact this office for information please let me know. The updated dress guidance was released on April 1, 2019.

Hi Naveen,

I have been looking into your question regarding the decriminalization of homosexuality in British Columbia.

In terms of *decriminalization*, it was up to the federal government, as they have jurisdiction over criminal law via the criminal code. If you'd like more information on the actions taken by the federal government on this issue let me know. That being said, the decriminalization of homosexuality did not guarantee equality or outlaw discrimination. Here are some legal actions B.C. took in this regard:

- In 1992 the B.C. *Human Rights Amendment Act* was passed. This amendment added "sexual orientation" as a prohibited ground of discrimination in all areas (employment, tenancy, public services, contracts, purchase of property, publications, and membership in professional unions and associations).
- The 1995 passage of the B.C. *Adoption Act* allowed same sex couples to adopt children.
- In 2000, several B.C. acts were amended to provide for legal rights to same sex couples. See this press release: <https://archive.news.gov.bc.ca/releases/archive/pre2001/2000/july2000/0115.asp>

- In July of 2003 the B.C. Court of Appeal lifted its ban on same-sex marriage, making B.C. the second province to legalize marriage for same sex couples.


