B.C. Premier John Horgan said Tuesday that the PM is right to weigh the social and gender impacts on rural communities where work camps are established.

"There's been no shortage of work done on the negative impacts of putting a whole bunch of people in one place that don't necessarily live there or have the same connection to community," Horgan said.

The conversation is relevant to his province, where a \$40-billion LNG Canada project promises to bring up to 10,000 to the small rural community of Kitimat, many of whom will be housed in work camps.

Findings

- There is substantial evidence of a serious problem demonstrated in the correlation between resource extraction and violence against Indigenous women, girls, and 2SLGBTQIA people. Work camps, or "man camps," associated with the resource extraction industry are implicated in higher rates of violence against Indigenous women at the camps and in the neighbouring communities.

- This increased rate of violence is largely the result of the migration into the camps of mostly non-Indigenous young men with high salaries and little to no stake in the host Indigenous community.
- Industries that create “boom town” and “man camp” environments are implicated in increased rates of drug and alcohol-related offences, sexual offences, domestic violence, and gang violence, as well as sex industry activities in the host communities. These occurrences disproportionately impact Indigenous women, girls, and 2SLGBTQIA people.
- The influx of people as a result of “man camps” near or within Indigenous, remote and rural communities further results in stress on already limited social infrastructure, such as policing, health, and mental health services.
- In addition to the adverse social impacts that Indigenous women, girls, and 2SLGBTQIA people experience as a result of these industries, it is clear that Indigenous women, girls, and 2SLGBTQIA people do not have equitable access to the economic benefits these industries can provide.

Here are a few examples of permits not yet issued:

Section 10 Water Use Application: This is an application for short-term water use for specific purposes, such as dust control, equipment cleaning or pressure testing a section of pipe once it is in the trench. This is issued by the BC Oil and Gas Commission.

Fish and Wildlife Application: This is an application for the collection and re-location of fish and/or wildlife that are in the construction area of the pipeline. Collection of the wildlife and/or fish is carried out under the supervision or by qualified professionals, and the collection is completed to provincial standards. Collection takes place prior to the start of construction. The animals are relocated as soon as possible to similar nearby habitat. The Ministry of Forests, Lands, Natural Resource Operations and Rural Development issues these permits and requires that the applicant take great care in the collection and re-location of the fish and/or wildlife.

Access Point Application: This is issued by the Ministry of Transportation and Infrastructure for instances where a third party is seeking to access a road or access point from the highway right of way. In some instances, the access already exists and no site preparation or construction is required. In other instances it can be more complicated and site preparation and construction may be required or the access point is adjacent to sensitive habitat or a cultural site. The requirements placed on the applicant increase with the complexity of the specific site.

1. Ensure adequate marine towing capacity: Create a transparent Comprehensive Emergency Towing Strategy that includes a clear requirement regarding response times to ensure there is adequate emergency towing capacity available.
2. Geographic Response Plans (GRPs): Provide funding for Indigenous groups, the Province and local authorities to complete coastal and terrestrial geographic response plans (GRPs) and shoreline sensitivity mapping.
3. Make information open and transparent: Make available information about the types and volumes of liquid hydrocarbons being transported by rail, pipeline, and marine vessels. Local authorities have repeatedly voiced concern regarding

the lack of information available regarding oil moving through their communities. May require federal regulation.

4. FN/LG spill planning and response capacity: Provide funding (e.g. grant program) to First Nations and local authorities to increase spill planning and response capacity (plans, training, equipment, etc.).
5. Guarantee compensation and loss of use: Clarify and clearly articulate how interested parties and Indigenous people will be compensated for work done in the event of spill and for damages and loss of use in event of terrestrial or marine spills. BC and the federal government will need to work together to ensure that recent changes to Ship Source Oil Pollution Fund and federal compensation mechanisms for pipelines meet the needs of the province and communities.
