Your work anchors our communities.

Your labour has built so much more:

- Community
- Resilience
- Hope
- Opportunity
- A stronger province for everyone.

Together with the building trades, our government is going to build a Better B.C. that:

- puts people first
- Builds a strong economy with jobs and opportunity for everyone.

For too long, B.C.'s economy hasn't worked for people.

Rampant speculation in real estate hurt people, businesses and communities.

The affordability crisis has many people working 2 or 3 jobs.

Businesses can't find the skilled workers they need.

The problems facing people today are the result of past choices.

The old government took hundreds of millions out of ICBC, and abused BC Hydro's deferral accounts to the tune of \$5 billion dollars.

How many schools or hospitals could we have built with that money?

We'll never know, because the old government squandered the opportunity.

They were focused on the people at the top, while life got harder for everyone else.

These problems can't be ignored any longer.

Our government is working hard to fix them.

We're taking action to make housing more affordable, to build supply, curb demand, and provide more security for renters.

We're building an affordable child care program to give families relief and the chance to go back to work.

We're fixing public services like health care and education that were neglected for too long.

As important as that work is, it's not enough to fix what's been broken.

As a government, we are called upon to do more.

We have a responsibility to invest in people and help them reach their full potential.

That's why we are rolling up our sleeves and getting to work building our province.

Our government has committed an unprecedented \$20 billion to public infrastructure.

We worked with industry to create a new financial framework for LNG.

With LNG Canada, construction is underway on the biggest private sector investment in Canadian history.

It will generate billions in government revenues, and thousands of jobs for people in the North.

B.C. is booming. It's an exciting time.

But it's not just what we build...

it's how we build it.

We are building BC by investing in skills training.

B.C. has a major skills shortage.

There will be 60,000 job openings in the trades in the next 10 years.

Unions have been doing their part to train the next generation of workers.

- Toured an IBEW Training Centre in Port Coquitlam
- Drove a rig at an IUOE Training Centre in Maple Ridge

What's been missing is a government that shares your commitment to skills training.

Our government eliminated tuition on Adult Basic Education to bring down barriers for training and re-training.

We're upgrading skills training facilities and equipment at post-secondary institutions throughout B.C.

We've invested \$30 million in Indigenous Skills Training.

And we're working hard to encourage more women to enter the trades.

Last year on International Womens' Day, I was proud to stand with members of the Building Trades as we announced a pilot program to encourage more women to enter the trades.

We've got a long way to go, but together we can break down barriers and get rid of bullying and harassment on the worksite.

Our government is with you every step of the way.

We are building BC through community benefit agreements.

We want people to <u>benefit</u> from the projects we build.

This includes good jobs for local workers and on-the-job training for apprenticeships,

with priority given to women, Indigenous Peoples and others underrepresented in the trades.

The Opposition criticizes us for using Community Benefit Agreements.

Yet in 2014 when they were in government, their Working Group on LNG recommended using public infrastructure projects to train apprentices and grow our skilled workforce.

Through on-the-job training on public projects, more apprentices will certify, which means more skilled workers will available to work on projects like LNG.

The old government chose to ignore that.

We're acting on it.

That same report recommended that B.C. harness the success and skill of private sector unions to train apprentices.

"There are lessons to be learned from the approach unions are taking, which could be applied with success to other institutions."

Again, the old government ignored it.

We're acting on it.

We're putting your expertise to work, and B.C. will benefit.

You're going to train the skilled workers we need to fill the skills shortage,

and deliver safe, reliable public infrastructure that lasts.

I'm excited about the progress we're making.

This spring, the first CBA on the Highway 1 four-laning project will get rolling.

Later this year, we'll start construction on the new Pattullo Bridge.

And we've just announced the Broadway Skytrain will be built with a community benefits agreement.

### There will be more.

Government will be looking at how we can use CBAs for other public projects.

## We are building BC through clean energy projects.

In December, we introduced our CleanBC climate action plan, developed in partnership with the BC Green Caucus.

With CleanBC we will fight climate pollution and grow a low-carbon economy with jobs and opportunity for people.

Whether it's generating clean energy, retrofitting buildings or designing new technologies,

Making B.C. cleaner will create good jobs that support working people and sustain our communities.

The building trades will help get us there.

## Finally, we are building BC with better, safer and fairer working conditions.

Our government is restoring balance to BC labour laws.

We have made changes to WorkSafeBC, including:

- new leadership on the Board
- stronger enforcement
- more inspections
- and more safety training

This spring, we will bring forward legislation to update the Labour Code.

Work is underway to renew and update employment standards.

And the Ministry of Labour is finalizing its recommendations for how government can better protect people from the harms of asbestos.

#### President Sean McGarvey

Sean McGarvey, President of the NABTU, started his career with the International Union of Painters and Allied Trades (IUPAT) in 1981 in Philadelphia, and subsequently worked his way up through various leadership positions within the IUPAT.

In 2005, he was elected secretary-treasurer of NABTU. In 2012, McGarvey was unanimously elected to the office of president.

McGarvey currently serves in various capacities for the following organizations:

- Co-Chair; Oil and Natural Gas Industry Labor-Management Committee a unique partnership between NABTU and the American Petroleum Institute (API)
- Member; U.S. Council on Competitiveness
- Secretary-Treasurer; Union Labor Life Insurance Company (Ullico)
- Treasurer; National Alliance for Fair Contracting, Inc.
- Chairman of Board of Directors; National Coordinating Committee for Multiemployer Plans (NCCMP)
- Chairman of the Board; CPWR, The Center for Construction Research and Training
- Labor Co-Chair; Center for Military Recruitment, Assessment and Veterans Employment (CMRAVE), which operates the Helmets to Hardhats program
- Board of Directors; Diabetes Research Institute (DRI)

McGarvey also serves on several other union construction industry labormanagement committees.

McGarvey holds a Bachelor of Arts degree from the National Labor College and is a graduate of the Harvard University Trade Union Program.

**ATTENDEES:** Tom Sigurdson, Executive Director, British Columbia and Yukon Territory Building and Construction Trades Council (BC Building Trades (BCBT)), Sean McGarvey, President, North America's Building Trades Union (NABTU), others TBD.

**ISSUE(S):** Mr. Sigurdson has requested a meeting with Premier Horgan to introduce Mr. McGarvey and discuss topics of interest including the Community Benefits Agreement.

#### **BACKGROUND:**

The BCBT was established in 1967and is organized into regional councils. The regional councils initiate and oversee the BCBT's activity within their geographical boundaries. There are five regional councils in BC. The BCBT is an umbrella organization for construction unions in BC. Currently there are 17 unions in the province who are affiliated to the BCBT. Together, these unions represent 35,000 members and skilled craft workers throughout BC and the Yukon Territory.

The NABTU was founded by the American Federation of Labor (AFL) in 1907 and is organized in state, provincial and local councils. The NABTU's purpose includes organization and formation of local councils, apprenticeship training, health and safety practices, negotiations of wage and working conditions and legislative activity.

In April 2016, NABTU called on the AFL-CIO to cut its ties with environmentalist Tom Steyer, who founded NextGen America Climate Action, a super PAC to "prevent climate disaster and transition to clean energies", opposing fossil fuel pipelines. In April 2017, President McGarvey applauded President Trump's plans for the Keystone Pipeline and other infrastructure projects, when President Trump spoke at NABTU's 2017 legislative convention.

#### DISCUSSION:

Mr. Sigurdson's letter to Premier Horgan indicates that Mr. McGarvey's visit to BC will focus on the Community Benefits Agreement. The Community Benefits Agreement

(CBA) has been developed to create employment, training and apprenticeships, and more trades opportunities for Indigenous peoples, women and youth around the province. Major projects under the CBA will include the new Pattullo Bridge and projects within the Trans-Canada four-laning program. Community benefits will also provide predictable and aligned compensation, provide labour stability and certainty, and provide safe working conditions free of discrimination and harassment.

The B.C. Infrastructure Benefits Inc. (BCIB) was established in July 2018, and on January 2, 2019, the BCIB board of directors was announced. BCIB is the Crown corporation responsible for executing the Province's Community Benefits Agreement.

#### SUGGESTED RESPONSE/KEY MESSAGING:

- Government is very pleased that the Community Benefits Agreement has been developed to create employment, training and apprenticeships, and more trades opportunities for Indigenous peoples, women and youth around the province.
- Major projects under the Community Benefits Agreement will include the new Pattullo Bridge and projects within the Trans-Canada four-laning program.
- Government is confident that the Community Benefits Agreement will benefit
  British Columbians by providing predictable and aligned compensation, labour
  stability and certainty, and safe working conditions free of discrimination and
  harassment.
