Hello everybody! I hope the first day back in session hasn't been too rough! The past week has been a flurry of recurring issues resurging, in addition to BCTF bargaining:

**Bargaining for teachers** – We've had a fairly steady flow of emails from teachers and occasionally parents about the state of negotiations between the BCTF and BCPSEA. Many are requesting government intervention or are expressing disappointment at how the government is handling the situation overall.

**DST** – Although these have slowed down significantly since the release of the DST report, we still receive a few emails a week largely requesting the change happen more quickly. Some are lamenting the thought that the government is waiting for other jurisdictions (primarily the US) to make the first move. To be clear, all of these writers support the government's move towards abolishing the time change, but are critical of some aspects.

**Caribou/Wolf Cull** – These are largely offshoots of a form letter campaign that comes and goes throughout the year. This is a recurring topic that we receive year round.

**Massey Tunnel** - Following the news from the mayors council, we saw a small uptick in massey tunnel commentary. This was accompanied by a small resurgence in a form letter campaign from the ICBA (you may have seen their video of the Premier last week).
