Hi All,

As many of you are aware, prior to COVID-19 it had been our intention to make some adjustments to the Chair and Vice Chair responsibilities of some Cabinet Committees to fairly distribute the additional workload of serving in lead Committee roles. These changes will now proceed.

Minister Scott Fraser and Minister Doug Donaldson served as Chair and Vice-Chair of the Environment and Land Use Committee (ELUC) since government took office. Going forward, Minister George Heyman will serve as the Chair ELUC and Minister Scott Fraser will serve as Vice-Chair.

Now that ELUC Ministers are familiar with their roles and responsibilities, it is no longer necessary to have both Committee Chair's Deputy Minister and the Chair of DMCNR provide support at committee meetings. Going forward, John Allan will support ELUC as the Chair of DMCNR. Other DMCNR members will attend where topics warrant wider participation, or for presentation of your submissions to the Committee.

At DMCNR, Tom Ethier joins in his new role as Deputy Minister of Agriculture and Kevin Jardine shifts to represent both his new role as Deputy Minister of Environment and the Environmental Assessment Office at least until his former position is staffed. As my objective has been to maintain small, functional DM and ADM Committees, Wes Shoemaker will remain on DMC, but will not remain on DMCNR. Wes will join DMCNR from time to time to provide updates on the Agri-Industrial Land initiative going forward.

I would also like to use this opportunity to clarify expectations for distribution of draft Cabinet Committee materials. In some cases I understand that draft Cabinet Committee materials have been circulated to all ADMs in DMCNR member ministries rather than to appointed ADM Committee members. There will be some topics that benefit from reaching out to certain ADMs with specific expertise, and I support doing so when warranted. More broadly though, the purpose of streamlining ADM Committees was to free up corporate executive time for other priority work. While it is beneficial to keep ADMs up to speed on work in progress in other Ministries, this should be achieved by having your ADM Committee representatives provide brief updates at Ministry Executive committee meetings. To ensure that materials are being distributed to appointed ADM Committee, I would ask that you review email and SharePoint distribution lists and keep these up to date.

OPEN LETTER

To the Honourable John Horgan, Premier and the Honourable Lana Popham, Minister of Agriculture

We the undersigned are extremely concerned about the impact on agricultural land and the farming community of government's decision to implement Recommendation #4 of the 2020 Food Security Task Force report, titled 'The Future of BC's Food System'.

We understand that a deputy minister has been appointed to lead an initiative to convert up to 0.25 % of the ALR to non-farm use as an agri-industrial zone, thereby permanently eliminating the potential for soil-based food production on up to 11,500 ha of agricultural land.

As a group of individuals with wide-ranging experience in soils and land capability, farming, agricultural land preservation and land use planning, our concerns are several.

It is a serious mistake to assume that simply directing agri-tech to 'lower capability' Class 4-6 lands within the ALR will minimize impact. Capability class is only a reflection of range of crops, not productivity, specialty crop suitability or value to agriculture. In many parts of the province, these lands are integral to farm

operations. For example, many Class 5 lands in the Lower Mainland are the mainstay of the blueberry/cranberry industry; Class 4 and 5 lands in the Okanagan comprise the backbone of the wine and tree fruit industry; Class 5 forage lands in Bulkley Nechako and Peace River regions are the foundation of a livestock industry; and the Class 6 natural grasslands of Interior BC provide critical spring and fall grazing for many ranches.

For government to facilitate and promote non-farm uses within the ALR – with no requirement that they be tied to food production on surrounding lands – ignores the well-documented negative impacts such uses can have on surrounding farms and the feasibility of bringing more farmland into production. The ALC has almost 50 years of experience in building criteria into its decision-making on applications for non-farm use within the ALR to ensure impacts of allowed uses are minimized.

Another major concern with this initiative is the complete lack of consultation and involvement to date of the Agricultural Land Commission, the entity with the provincial legislative mandate and responsibility to protect the scarce 5% of our provincial land area capable of food production. The ALC's March 9, 2020 letter to government, expressing serious concerns with the Task Force recommendation and requesting to be consulted prior to a decision being made, appears to have been ignored.

Establishing an agri-industrial zone within the ALR directly contradicts the 2018 Minister's Committee report, titled 'Revitalizing the Agricultural Land Reserve and the Agricultural Land Commission', which recommended an 'agriculture first' policy within the ALR; curbing speculation and non-farm impacts on the ALR; limiting activities that damage and alienate land from farming and ranching; and ensuring that the ALC is 'at the table' when it comes to decisions on lands within the provincial ALR. We strongly support these Committee recommendations.

We urge government to redirect its promotion of an agri-tech industry to outside the ALR. In situations of demonstrated need for this use within the ALR, the ALC has the legislative mandate and experience to decide where and under what conditions such uses could be allowed. In our opinion, to circumvent the ALC endangers, rather than enhances, BC's food security.

 - (ii) the assessments of the land and improvements as set out in the revised assessment roll, as defined in the *Assessment Act*, in the extension area:

- (i) the volume of rail cars passing through the Village of Port Edward in the year, as reported by the Prince Rupert Port Authority or the Canadian National Railway Company;
- (ii) the volume of all cargo, by type, exported in the year from each export terminal in the extension area, as reported by the Prince Rupert Port Authority;
- (iii) the data, if any, about air quality, including data relating to odour and dust, and about noise, light emissions and vibrations at each terminal within the extension area, as reported by the operator of a terminal or the Prince Rupert Port Authority;
- (c) the report must contain an estimate or prediction of any of the information described in paragraphs (a) (i) to (iv) or (b) (i) to (iii), and an estimate or prediction of any change in that information, that the City of Prince Rupert references, or relies on, in a publicly-available report or plan of the City of Prince Rupert;

"eligible person" means an adult

- (a) with whom a director has entered into an agreement,
- (b) who was, on or after March 17, 2020, enrolled in a program referred to in the agreement, and
- (c) who did not voluntarily cease enrollment in the program during the suspension period;

"end of the COVID-19 emergency" means the later of the following:

- (a) the date on which the provincial health officer provides notice under section 59 (b) of the *Public Health Act* that the COVID-19 emergency has passed;
- (b) the date on which the last extension of the declaration of a state of emergency, referred to in paragraph (b) of the definition of "COVID-19 emergency", expires or is cancelled;
- "enrolled", in relation to a life skills or rehabilitative program, includes to be registered or otherwise listed as a person who is taking part in the program;
- "program" means any of the following types of programs that are referred to in an eligible adult's agreement:
 - (a) an educational or vocational training program;
 - (b) a life skills or rehabilitative program;
- "suspension period" means the period that begins March 17, 2020 and ends as follows:
 - (a) if the end of the COVID-19 emergency occurs on or before the 15th day of a month, on the last day of the month;
 - (b) if the end of the COVID-19 emergency occurs after the 15th day of a month, on the last day of the following month.
- (2) This section applies despite section 8.4 and anything to the contrary in an eligible person's agreement.

- (3) The running of the 48-month period set out in section 8.4 (a) is suspended, in relation to an eligible person, during the suspension period if a director is satisfied of either of the following:
 - (a) the eligible person is not participating in a program because the program is temporarily suspended for a reason related to the COVID-19 emergency;
 - (b) the eligible person
 - (i) is not participating in a program because the program is suspended as scheduled, and
 - (ii) is not employed or otherwise self-supporting for a reason related to the COVID-19 emergency.
- (4) If an eligible person to whom subsection (3) applies turns 27 years old either during the suspension period or, if the eligible person's program resumes, during the current term of the program, the limit set out in section 8.4 (b) does not apply and the director may continue payments under the agreement until whichever of the following applies:
 - (a) on the date on which the director is satisfied that the eligible person's program will not resume;
 - (b) if the eligible person's program resumes, the end of the month in which the current term of the program ends.
