Subject: Councillor Jack Hundial - Raising Concerns on the McCallum led Surrey Police Force

Dear Sirs,

I am writing this memo to express to you my concern as an elected official in Surrey. An overwhelming number of Surrey voters are unhappy with the process, pace and direction of the police transition. I asked that the work on this transition to be made public and transparent to the taxpayers of Surrey immediately.

I have been advised that the work of Mr Oppal and the recommendations from the ADM Butterworth-Carr were based on debatable assumptions from the City of Surrey. Apparently detailed input from the RCMP, who have policed Surrey since 1951, was either not requested or excluded. If this is so, and they have not effectively participated in this process, it is a major flaw in the process and this represents a public safety risk.

The public consultation that was done by the City of Surrey showed a very low level of support for this transition and was only made public after Councillor Locke and myself petitioned the BC Privacy Office for its release. A further survey was conducted by Maple Leaf Strategies on Sept 6 - 8th, 2019 and again showed a 44% very favourable and 37% somewhat favourable impression of the RCMP for a total of 81%. I have attached that survey, including a question that was not previously released.

I am quite sure that you are receiving the volume of email from the public directly to you, also voicing their concerns stating they are not in favor of this transition without all of the details, costs and benefits being put to a referendum. In fact, in 1950, it was a referendum in Surrey that was placed before the voters which brought in the RCMP due to escalating costs with a local police.

This coming week, you will be receiving a petition from 42,000 Surrey residents, with another 8,000 signatures from Surrey residents coming in March, 2020. These have been generated by a grass roots volunteer community group named Keep The RCMP in Surrey. Over the past week, emails have been arriving in excess of 4,200 asking for this process to be stopped and made inclusive of the Surrey taxpayers, prior to a Police Board being established. I am expecting in the coming weeks and months ahead, more polls and emails will be coming in with similar statements. This is because the public is being excluded of the process and decision making. This is not a fleeting issue. The community is deeply concerned about public safety.

As stated previously, a campaign promise without all of the facts and community support is not conducive of an open and inclusive government. The residents of Surrey have been clear that they do not want to be bullied into this transition.

I was pleased to hear Premier Horgan state recently on CityTV that no transition would be done without the public knowing the costs. The budgeting for this transition has cannibalized our budgets for the last 2 years, with no new substantial investment into community amenities, facilities or road improvements. In fact, over a dozen scheduled projects have been canceled or scaled back due to this police transition. The voting taxpayers are already feeling the financial burden.

As you may recall, each candidate was asked to take a position if they support the RCMP in Surrey or not in the October 2019 federal campaign. I expect this question will be asked again of all candidates in the upcoming provincial campaign and also into our next civic election in October 2022. This will be a key question and one that continues to gain media attention.

Up to now there has been a very closed and somewhat secretive process based on unfounded assumptions. It is my request that you please consider carefully your next steps. If this is forced on voters, they will remember at election time and if the McCallum led Surrey Police Force doesn't roll out perfectly - and improve public safety - all parties involved will almost certainly be held accountable.

Please find attached a letter and a chronological timeline regarding the Surrey Police Transition. Over the past 16 months Cllr. Hundial and I have received thousands of emails and tens of thousands of social media engagements regarding the Surrey Police Transition. It is important for all MLAs to understand the concern of the majority and growing number of residents of Surrey should the provincial government continue to move forward on the Surrey Police Transition from the RCMP to a municipal police force.

While it may seem like this issue will not impact your community, please know that should this go forward the City of Surrey will be hiring almost 900 police officers in the next 2 – 3 years. Not only will this recruiting process impact every other municipal police force in Metro Vancouver, it potentially will see Surrey recruiting in other jurisdictions in BC. Further, the Justice Institute, which is the only training institution for municipal police officers in BC, is at currently at

capacity. In order to meet the staffing levels needed by a Surrey Police Force, will require the JIBC to expand their current capacity therefore requiring additional financial input from provincial budget.

In closing, this is a critical issue for Surrey voters, as our next municipal election is only 962 days away (October 15, 2022). In the meantime, the provincial government will be holding an election. Given the level of engagement on this issue, it is important that the communication is genuine, transparent and that peoples' voices are heard because, in the end, in Canada, we police by consent.

Surrey Residents Want Input into Their Policing

Surrey residents have lost confidence and trust in the process to transition from the RCMP to a Municipal Police Department due to the lack of communication and transparency. It was acknowledged by the Solicitor General that the report done by the City of Surrey and Vancouver Police Department was inadequate, requiring the province to review it for gaps in the proposal. Mr. Oppal was asked to review the proposal and address the gaps in the report. We understand his report has now been deposited with the Director of Police Services, Brenda Butterworth-Carr. In keeping with the closed process surrounding this report from the onset, Surrey Council has not seen the recent Oppal report.

On February 14, 2020, Premier Horgan received a petition with over 40,000 signatures. Over the course of the year, several polls have determined that the majority of Surrey residents want to maintain the RCMP as Surrey's Police Department. (Maple Leaf Poll - 64%, City of Surrey's own Consultation Report - 73% and now the National Police Federations' Poll - 77%). These polling results were achieved even though the public did not have a clear indication of the cost impact to the taxpayer. Certainly, these results point to a discrepancy between Mayor McCallum's interpretation of the 2018 local government election results and do not support his comments that the Surrey residents are in favour of a move from the RCMP.

On May 23, 2019, Premier Horgan stated "The public needs to have a clear understanding: Why there would be a requirement to change, what the cost of that change would be, and would it be a diminishment or an improvement in the delivery of services to people?" He went further to say, "I can't answer those basic questions because I don't know, and if I can't, I assume the public can't either."

Then on May 24, 2019, it was reported that Premier Horgan stated *"I would* argue, and I've made the case to Mayor McCallum, that the public needs to have a clear understanding why there would be a requirement to change, and what that cost would be, and would there be a diminishment in service to people,"

Premier Horgan went further to say that the *province "has a significant role to play in the delivery of public safety services in Surrey"* and will need to look closely at the details of Surrey's proposal before it decides whether to allow the change.

It has been unclear throughout this process what the level of service would be nor has there been a comprehensive comparison of the current service of the RCMP with a new, untested Surrey Police Department. Certainly, cost implications have never been clearly outlined and communicated to council or the public.

More recently, on January 23, 2020, it was positive to hear Premier Horgan speak in support of the concerns of Surrey resident and especially taxpayers when he stated: *"Traditionally municipal forces cost more than the RCMP and again those are issues that the public need to know before they make a final decision. I think the Mayor appreciates that, he would prefer to move faster, I know that, but I think it is our responsibility to make sure that when Surrey makes these choices, they do it with full information. That is what the Oppal process has been all about. And there will be costs, so I think it is important that people know that before they take a leap of faith"*

Costs to residents

We appreciate that the provincial government is concerned about Surrey taxpayers. Policing across the country is plagued with escalating cost, therefore, managing those cost is critical to residents and ultimately public safety in general.

The original Police Transition Report did not provide a solid pathway regarding the cost impact to residents. Further, we have learned that all cost projections were done on a "best case" scenario. We already know that the reported cost projections for I.T. in the report will not be achieved and that those costs will be significantly higher than originally budgeted.

The RCMP are a good value for Surrey

Comparisons between cities will provide a general guideline to better understand the cost implications to Surrey taxpayers should we change our model from the RCMP to a local police force. The chart below is extrapolated from a report by the Ministry of Public Safety. These are cost per capita in three "like" jurisdictions that have local police forces. This is based on 2018 statistics.

There can be no question that the police transition will increase taxes for Surrey residents. The question is by how much. These numbers do not include the capital costs of the transition nor does it include any costs from a risk management (insurance) perspective. Cities fund the risk management where there is a local police service whereas the costs for the RCMP are borne nationally. Suffice to say risk management can be a significant and unknown cost to the city when there is a requirement to compensate for personal or property damage done in the line of duty. Similarly, with employee costs like the health employer tax, the RCMP funds those nationally however, they are funded by cities with local police departments.

Hiring police officers is a challenge throughout North America. It should be predicted that Surrey will be faced with that same challenge to recruit the number of officers required for a police service even to meet the minimal requirement as stated in the Police Transition Report of 805 officers. While it has been stated that some members will come from the current Surrey RCMP detachment, that has not been confirmed. There is a further concern that some of the officers will come from other police departments like West Vancouver, Vancouver and New Westminster because the cost of living in Surrey is more in line with a police officer's wage.

Training for all municipal police departments in British Columbia is done through the Justice Institute of British Columbia (JIBC). The funding and ability for the JIBC to train officers is limited and just keeping up with the existing need for officers in B.C. In the BC Budget 2020, there was no additional funding to the JIBC to meet the need of a new police department the size of Surrey. The RCMP training facility in Regina has more flexibility and can increase or decrease intake as the national need dictates.



In the end, if this issue is that Surrey is concerned about local input into policing in our city, that can be achieved through a Local Police Board for the RCMP. While this is a new option, it is working successfully in several jurisdictions in the country. Stephen Thatcher, Assistant Commissioner of the Lower Mainland District Commander, 'E' Division, RCMP said *"a type of police board, in the form of an advisory or local police committee to support the mayor and council in working with the RCMP is a potential option for the City of Surrey."* The province is in a position to listen and provide Surrey citizens with an opportunity to have their voices heard. Likewise, it is important that First Nations peoples are consulted in a meaningful way – government to government – in accordance with all that is right and just.

Now that the police transition file is out of the hands of the local government and the purview of the provincial government, we trust that the province will consider the wishes of the residents of Surrey.

Police Transition – Chronological Timeline

2018

- Nov. 2 Mayor Elect Doug McCallum, Bob Cheema and Chief of Staff Donna identified on Minister Farnworth's calendar meeting to discuss traffic fine sharing and redacted item(s).
- Nov. 5 Motion to start the process to move to a Surrey Police Department. Cllr. Hundial's caveat it must provide better police service and be fiscally affordable.
- Dec. Budget 2019 guts services and all new infrastructure in order to meet the cost implications of the Police transition. Infrastructure projects like the Cloverdale Arena were cancelled even though they were shovels in the ground and the Road Levy tax stopped.

2019

- May Surrey sends the Police Transition Report to Victoria. Council had little or no input into the report. All work was singularly the purview of the Mayors office. Council was provided 45 minutes to review the document prior to it being deposited with the Solicitor General.
- May 15 Public Consultation process and locations announced.
- May 23 First Public Consultation event occurs large turn out. "Keep the RCMP in Surrey" campaign begins.
- May 31 Cllr. Pettigrew leaves Mayors' Safe Surrey Coalition.
- June 18 Press Release exposes the lack of resources in the Police Transition Report dedicated to abused children and youth at Sophie's Place.
- June 23 Mayor announces that Surrey's Public Consultation determined that 93% of residents want a Surrey Police Department.

Request was made for the raw data from the public consultation process.

- June 27 Cllr. Locke leaves Mayors' Safe Surrey Coalition.
- July 15 Mayor folds the City of Surrey's Public Safety Committee in favour of a Police Transition Committee (PTC). Only members of his own coalition assigned to the PTC. The PTC has never met.
- July 18 Cllr. Hundial leaves Mayors' Safe Surrey Coalition.
- Aug. 12Press Release expresses concern that the Police Transition Report does not respond to

Sept. 24	Cllr. Locke received an abridged version of Surrey's Public Consultation raw data stamped "Confidential – Not for Distribution". (3 months post the request)
Oct. 1	Cllr. Locke met with Surrey Lawyer re misinformation communicated to the public regarding the public consultation. Was told that because the data was stamped "Confidential – Not for Distribution" and it would be a breach to refute the Mayors' statement.
Oct. 30	Applied to the Provincial FOIPPA office to have the data released. After several email and phone calls it was determined that the process should go back to the City of Surrey's FOI office.
Dec. 16	Budget 2020 is completely focussed on the Police transition with no opportunity to build infrastructure. The road levy is cancelled once again, and few new projects permitted.
	Motion to stop the process of the Police transition until a proper feasibility study has been done that specifically included cost to the taxpayer. Defeated 5/4 split.
Dec.23	Data was released at 4:30 that indicated that the Mayors' comments regarding public support for a Surrey Police Department were inaccurate.

Jan. 21	Surrey Resident Richard Landale does an in-depth analysis of the police transition titled "Qualitative Review of the Policing Transition Citizen Engagement Survey". The author points to a flawed process that did not put a clear question to the public and Thematic Analysis principles inaccurate rationalization of the data information.
Feb. 4	Cllr. Brenda Locke Signed the petition to "Keep the RCMP in Surrey".
Feb. 10	Motion put forward to halt the Police Transition process until proper, government to government consultation had been achieved with both lands based and urban First Nations. Ruled out of order as the Mayor claimed relationship with First Nations is not an issue for local government.
Feb. 12	Cllr. Jack Hundial signed the petition to "Keep the RCMP in Surrey".
Feb. 14	"Keep the RCMP in Surrey" delivers 40,000 signatures on a petition to Premier Horgan at his Vancouver Cabinet Offices.
Feb. 18	National Police Federation survey states that 77% of Surrey Residents want to keep the RCMP.

Coronavirus Update

Background:

- On March 3, four COVID-19 cases in B.C. were announced (all having travelled to Iran) bringing the total BC cases to 12. Four have fully recovered and others are in self-isolation at home.
- Media attention is focusing on the situation in Washington State where there have been 9 deaths, 27 positive cases and 231 people under public health supervision. King County has declared a state of emergency.
- On March 3, the Prime Minister said that the federal government will ensure provincial health authorities have the resources they need to contain and treat cases. The Public Health Agency of Canada is increasing lab capacity and making sure provincial hospitals have the necessary surge capacity and supplies.
- Travellers from China and Iran are asked to self-isolate for 14 days, and all international travellers monitor themselves for symptoms.
- As of March 3rd, Dr. Bonnie Henry and Minister Dix are also now recommending:
 - Everyone stay at home if they're feeling unwell, and wash hands regularly etc.
 - Employers and schools consider ways to increase cleaning and hand hygiene.
 - Employers think about how to manage absenteeism through remote working etc., and schools put mechanisms in place to support students who are away.
 - Event organizers ask people to stay away from events if they're feeling unwell, returning from affected areas or have underlying health conditions

Economic Impacts of Coronavirus

Background:

- On March 3, the OECD announced a reduction in global growth projections from 2.9% to 2.5%, with a potential further reduction to 1.5% if the coronavirus runs "rampant."
- The OECD recommends countries boost medical services and invest in stimulus.
- The US Federal Reserve slashed interest rates by half a percentage point on March 3rd in response to coronavirus.
- Federal Finance Minister Bill Morneau will be speaking with his provincial counterparts Wednesday morning to discuss provincial responses and their particular impacts.

- On March 2, the Attorney General introduced legislation that will prevent any B.C. government from directing ICBC to make payments to government from its excess optional insurance capital.

- If this action hadn't been taken, ratepayers would have been required to pay off \$1.1 billion in deferred costs through rates.

Agreement with Wet'suwet'en Hereditary Chiefs

Background:

- After three days of talks, the Wet'suwet'en Hereditary Chiefs initialed a tripartite Memorandum of Understanding with the Federal and Provincial governments.
- The proposal focuses on expedited implementation of Wet'suwet'en rights and title, breathing new life into the 23-year-old Delgamuukw-Gisday'wa decision.
- The proposed arrangement will be reviewed by Wet'suwet'en clan members through their governance protocols for ratification.
- Opposition and media have focused on the lack of details on the arrangement and the government's acknowledgement that there was not an agreement on either the Coastal GasLink pipeline or an end to blockades.
- Some elected Wet'suwet'en band councillors have expressed concern that they were not involved in drafting the arrangement and that they may not be adequately consulted by Hereditary Chiefs on ratification.

Strata Insurance Costs

Background:

- Todd Stone's bill would: define a standard unit to reduce what is covered by strata insurance; provide early notification of coverage expiration; and require individual strata owners to have their own separate insurance for their unit.
- The Insurance Bureau of Canada has created a commercial insurance task force to look at strata insurance. IBC says rates are increasing by about 30% attributable to increased property value, severe weather, and a major underwriter scaling back.

- On February 19, the Environmental Assessment Office (EAO) sent a letter to Coastal GasLink requesting additional information and clarification related to a report required by Condition 1 of the CGL's Environmental Assessment Certificate.
- The EAO requires this information before the report on Condition 1 from CGL can be approved and it must be provided to EAO in 30 days.
- Condition 1 of the project's Environmental Assessment Certificate requires CGL to provide a report on potential effects to the Morice River Technical Boundary prior to construction.
- In its letter, the EAO said it needs further information on a number of details, including how CGL is incorporating Aboriginal Traditional Knowledge and how the feedback from Indigenous nations has been responded to and addressed.
- The EAO also wrote to Freda Huson to inform Dark House and reiterate the importance of Dark House working with CGL to ensure open and constructive dialogue.
- The EAO has been working with Dark House and CGL to facilitate dialogue.
- Full construction activities can't proceed within the Morice River Technical Boundary area until the report has been accepted by the EAO.
- CGL remains able to access and proceed with non-construction activities within the Morice River Technical Boundary and construction activities in all Project areas outside the designated area including preparing the work camp in the Morice River area.

Vancouver School Board - Catchment "Lotteries"

Background:

- Due to some Vancouver schools being over capacity, parents have raised concerns when their children were unable to enroll in the schools closest to their homes as a result of losing VSB "catchment lotteries."
- Prominent Vancouver urban planner Brent Toderian raised these concerns in the media in February 2020 when his son was unable to enroll in Kindergarten at Crosstown Elementary, despite the school being a short walk from their home. Crosstown has three kindergarten classrooms, all of which are full.
- School districts are responsible for how students are distributed at schools throughout the district. At schools that are overcapacity, the VSB holds lotteries to ensure fairness in enrolment.
- People in the community are calling for the Province to fund a new school in Olympic Village as a way to ease crowding in nearby schools.

Jobs/Economy - January Labour Force Survey

Background:

- Labour Force Survey data released February 7 showed British Columbia gained 3,400 jobs in the month of January (-6,100 full-time jobs and +9,500 part-time jobs)
- BC's unemployment rate decreased to 4.5%, the lowest in Canada.
- Unemployment rate hit a low of 4.2% in Sept/Oct 2018. Last time unemployment rate hit 4.2% was in June 2008
- The Opposition attacked the government's job creation record citing a loss of 26,000 full-time jobs over the last four months
- Since the new government took office, BC has gained 67,000 jobs. (+41,000 full time, +26,000 part time).
- In the last year, average hourly wages have gone up \$1.73/hour (or 6.4%) and have increased \$3.43/hour (or 13.5%) since this government was sworn in.
- Canadian tech giant, Shopify, announced on Jan 28 that it will open a new permanent office in Vancouver creating 1,000 jobs. Shopify called Vancouver a "hub for great talent with potential for continued growth."

Strata Insurance Costs

Background:

- MLA Todd Stone introduced a private member's bill on February 25, 2020 that he claimed would address the recent increases in strata costs.
- The bill would: define a standard unit to reduce what is covered by strata insurance; provide early notification of coverage expiration; and require individual strata owners to have their own separate insurance for their unit.
- On Feb. 20, the Insurance Bureau of Canada told CKNW that they have created a commercial insurance task force to look at strata insurance. They're hosting meetings with stakeholders and local governments across western Canada.
- IBC says that rates are increasing by about 30% which are being attributed to increased property value, severe weather, and a major underwriter scaling back.
- While stratas are legally required to have insurance, the industry is private and the government doesn't have control over rates.

Background:

- Media may ask about local government reaction to the interim business property tax relief bill introduced by Minister Robinson on Monday, Feb 24.
- Kennedy Stewart has loudly criticized the bill, saying it's not the sub-class proposal they asked for and is not feasible to implement for 2020.
- The Ministry took the exceptional step of giving advance notice of the legislation in January and have already been working closely for weeks with municipal staff.
- BC extended the deadline for municipalities to pass bylaws to April 22nd, provided a model bylaw and user guide for municipalities and made procedural changes so municipalities can pass the bylaws faster.
- Government's bill authorizes municipalities to exempt a portion of a property's commercial value from taxation where there is at least one tenant responsible for property taxes (responding to concerns around the so-called "triple-net lease").

• On Feb 25th, Andrew Wilkinson was asked about his plans for healthcare in Surrey. He opened the door to cancelling the second hospital:

- In 2014 as Minister of Citizens Services, Wilkinson sold government property in Panorama that had been acquired by the BC NDP in the 1990s for a hospital. It was sold for \$20.5 million (below the appraised value of \$23.5 million).
- On December 9, Premier Horgan and Minister Dix announced a new hospital in Surrey, to be located at a site acquired in Cloverdale.
- The concept plan has been approved and is in government's capital plan.
- The business plan is under development. When that is complete, a cost will be attached in the capital plan and it will appear in the following budget.

Medical Assistance in Dying - End to Delta Hospice Service Agreement

Background:

- Fraser Health will stop funding the Delta Hospice Society on Feb. 25, 2021, providing the required 365-days notice to end their service agreement without cause.
- The termination follows the Society's board's refusal to comply with federal medical assistance in dying (MAiD) law and BC policy.
- In response, MLA Paton criticized the government decision but refused to say whether or not he thinks the facility's current policy is acceptable, leading MLA Kahlon to call on Paton to support patients' rights.
- Paton later clarified that publicly funded facilities should be prepared to offer this right to their patients.
- The 10 hospice beds represented by the existing facility will stay in Delta.
- Following the federal legalisation of MAiD, Minister Terry Lake had developed a policy that requires a hospice to allow patients to access MAiD in their facility, if their beds are more than 50% publicly funded.
- On Dec. 5th, Fraser Health provided an initial formal notice on areas of non-compliance and warned the Hospice it must come in line with federal laws.

Coronavirus Update

Background:

- Media has been reporting on the solid preparations in place in BC for a potential global pandemic, as well as the 6th and 7th B.C. patients who contracted coronavirus in Iran and through close contact with 'Patient 6' in B.C. respectively.
- Some people have asked why the schools and hospitals patients went to are not being identified. All those people who may be at risk have been contacted by Fraser Health. We want to protect people's confidentiality so they feel comfortable coming forward.
- BC is now asking ALL international travellers who are returning to B.C. to monitor themselves closely for symptoms.
- Minister Dix & Dr. Henry have said: "We are preparing for all possibilities that may occur in the coming weeks, including the possibility of a [global] pandemic."
- In total, seven people in B.C. have tested positive for COVID-19. The first individual has recovered, the others are recovering in self-isolation at home.
- There are 81,109 cases worldwide 78,191 of those in China. 2,718 people have died.
- Over 1,000 samples have been tested in BC more than any other jurisdiction due to our intentionally low threshold for testing to ensure more people are eligible.

- Minister Fraser and Minister Bennett are in Smithers for talks with the Wet'suwet'en Hereditary Chiefs.
- The Chiefs have said they agreed to the meeting as a first step after an agreement with the RCMP to stop patrols on the Morice Forest Service Road and to close their CISO outpost.
- Coastal GasLink announced that it had agreed to a two day pause of construction activity in the Morice River area to facilitate dialogue between the Chiefs and governments.

Protests and Alberta anti-blockade legislation

Background:

- Jason Kenney's Alberta UCP government has introduced the "Critical Infrastructure Defence Act" as Bill 1 of their new legislative session.
- The legislation would impose penalties of up to \$25,000 in fines for individuals or corporations who willfully obstruct or interfere with the construction or maintenance of critical infrastructure.
- After the OPP cleared the rail blockade in Tyendinaga, new protests and blockades occured in BC including on West Coast Express lines, at the Port of Vancouver, the intersection of Clark and Hastings, the Legislature in Victoria, and at a rail crossing in New Hazelton.
- In each of these cases, police have moved quickly to enforce injunctions and clear the protesters from blockades.
- Business and industry groups like the CFIB and national agriculture stakeholders have warned about the growing economic impact the blockades are having.

Foreign Funding and Protests

Background:

- The Opposition has alleged that foreign organizations are funding the ongoing protests and economic disruption in BC.
- The Opposition cited U.S. tax documents that they say show several American based organizations have provided about \$4.2 million USD to a range of Canadian environmental organizations associated with the protests.

George Massey Tunnel Replacement

Background:

- Public consultations were held on February 5-6 in Richmond and Delta to hear feedback on plans to alleviate congestion on both sides of the crossing, while providing an update on the next phase of the project that aligns with regional plans.
- In November 2019, the Metro Vancouver Board endorsed the 8-lane tunnel replacement proposed by the Task Force.
- The tunnel proposal includes 2 lanes dedicated to transit leaving 3 lanes in each direction for commuters.
- London Drugs CEO, Clint Mahlman, has expressed concern over the commercial capacity of the replacement and said he is considering relocating the London Drugs warehouse which would affect 350 jobs.

Ride Hailing & Taxi

Background:

- On February 26, the Surrey Board of Trade along with Surrey taxi companies called on the Province to eliminate the current taxi boundaries.
- Meanwhile, the Vancouver Taxi Association opposes the elimination of boundaries.
- On February 25, Vancouver and Surrey Councils ratified the Inter-Municipal Business Licence for ride hailing, with Surrey simultaneously reducing the fees of licenses for taxis to match the amount being charged to ride hail vehicles.
- On February 7, the Passenger Transportation Board approved two new ride hailing companies including Kabu who plans to begin operating in Metro Vancouver, Victoria and Nanaimo and expand into Kelowna and Kamloops by the end of the year.

Mayor's Council - Low Carbon Fleet Strategy

Background:

- On February 27, 2020, Mayors' Council endorsed Translink's proposal to convert all buses to zero emissions technology by 2050, beginning by replacing 50% of the fleet with clean, zero-emissions battery electric models over the next decade.
- Mayors are requesting \$447 million in provincial and federal funding over 10 years, separate from funding for Phase Three Plan of the 10-Year Vision.
- The plan would need an initial investment by 2021 to ensure that new buses and new facilities are part of the electric charging system.
- TransLink claims this will enable them to meet its 2050 goal of reducing its greenhouse gas emissions by 80%, with an interim target of 45% by 2030.

Vancouver School Board - Catchment "Lotteries"

Background:

- Due to some Vancouver schools being over capacity, parents have raised concerns when their children were unable to enroll in the schools closest to their homes as a result of losing VSB "catchment lotteries."
- Prominent Vancouver urban planner Brent Toderian raised these concerns in the media in February 2020 when his son was unable to enroll in Kindergarten at Crosstown Elementary, despite the school being a short walk from their home. Crosstown has three kindergarten classrooms, all of which are full.
- School districts are responsible for how students are distributed at schools throughout the district. At schools that are overcapacity, the VSB holds lotteries to ensure fairness in enrolment.
- People in the community are calling for the Province to fund a new school in Olympic Village as a way to ease crowding in nearby schools.

Jobs/Economy - January Labour Force Survey

Background:

- Labour Force Survey data released February 7 showed British Columbia gained 3,400 jobs in the month of January (-6,100 full-time jobs and +9,500 part-time jobs)
- BC's unemployment rate decreased to 4.5%, the lowest in Canada.
- Unemployment rate hit a low of 4.2% in Sept/Oct 2018. Last time unemployment rate hit 4.2% was in June 2008

Please find attached a letter and a chronological timeline regarding the Surrey Police Transition. Over the past 16 months Cllr. Hundial and I have received thousands of emails and tens of thousands of social media engagements regarding the Surrey Police Transition. It is important for all MLAs to understand the concern of the majority and growing number of residents of Surrey should the provincial government continue to move forward on the Surrey Police Transition from the RCMP to a municipal police force.

While it may seem like this issue will not impact your community, please know that should this go forward the City of Surrey will be hiring almost 900 police officers in the next 2 – 3 years. Not only will this recruiting process impact every other municipal police force in Metro Vancouver, it potentially will see Surrey recruiting in other jurisdictions in BC. Further, the Justice Institute, which is the only training institution for municipal police officers in BC, is at currently at capacity. In order to meet the staffing levels needed by a Surrey Police Force, will require the JIBC to expand their current capacity therefore requiring additional financial input from provincial budget.

In closing, this is a critical issue for Surrey voters, as our next municipal election is only 962 days away (October 15, 2022). In the meantime, the provincial government will be holding an election. Given the level of engagement on this issue, it is important that the communication is genuine, transparent and that peoples' voices are heard because, in the end, in Canada, we police by consent.

Strata Insurance Costs

Background:

- MLA Todd Stone introduced a private member's bill on February 25, 2020 that he claimed would address the recent increases in strata costs.
- The bill would: define a standard unit to reduce what is covered by strata insurance; provide early notification of coverage expiration; and require individual strata owners to have their own separate insurance for their unit.
- On Feb. 20, the Insurance Bureau of Canada told CKNW that they have created a commercial insurance task force to look at strata insurance. They're hosting meetings with stakeholders and local governments across western Canada.
- IBC says that rates are increasing by about 30% which are being attributed to increased property value, severe weather, and a major underwriter scaling back.
- While stratas are legally required to have insurance, the industry is private and the government doesn't have control over rates.

Reaction - Interim Property Tax Relief for Small Businesses

Background:

- Media may ask about local government reaction to the interim business property tax relief bill introduced by Minister Robinson on Monday, Feb 24.
- Kennedy Stewart has loudly criticized the bill, saying it's not the sub-class proposal they asked for and is not feasible to implement for 2020.
- The Ministry took the exceptional step of giving advance notice of the legislation in January and have already been working closely for weeks with municipal staff.
- BC extended the deadline for municipalities to pass bylaws to April 22nd, provided a model bylaw and user guide for municipalities and made procedural changes so municipalities can pass the bylaws faster.
- Government's bill authorizes municipalities to exempt a portion of a property's commercial value from taxation where there is at least one tenant responsible for property taxes (responding to concerns around the so-called "triple-net lease").

Start of Cullen Commission into Money Laundering

Background:

- Opening statements at the Cullen Commission ran from Monday to Wednesday this week with lawyers for those with standing presenting opening remarks. The inquiry will resume in May.
- On Monday, the Attorney General stated at a press conference that he was concerned about MLA De Jong holding documents back from the commission and being the Opposition's intermediary with the Commission.
- In response, MLA De Jong said that he has a binder full of documents that he will be providing to the Commission, but denied they will be altered or redacted in any way.
- The press gallery has said that politicians should stay out of the inquiry, and highlighted the timing of the final report being due in an election year.

Surrey Hospital - Opposition Leader Comments

Background:

- On Feb 25th, Andrew Wilkinson was asked about his plans for healthcare in Surrey. He opened the door to cancelling the second hospital:

- In 2014 as Minister of Citizens Services, Wilkinson sold government property in Panorama that had been acquired by the BC NDP in the 1990s for a hospital. It was sold for \$20.5 million (below the appraised value of \$23.5 million).

- The concept plan has been approved and is in government's capital plan.
- The business plan is under development. When that is complete, a cost will be attached in the capital plan and it will appear in the following budget.

Protests and Alberta anti-blockade legislation

Background:

- Jason Kenney's Alberta UCP government has introduced the "Critical Infrastructure Defence Act" as Bill 1 of their new legislative session.
- The legislation would impose penalties of up to \$25,000 in fines for individuals or corporations who willfully obstruct or interfere with the construction or maintenance of critical infrastructure.
- Former BC Conservative MP and Cabinet Minister James Moore has suggested all Premiers and the federal government impose similar penalties to deter protests and blockades on roads and railways.
- The Opposition in BC has also called on the government to show more leadership in ending and deterring the protests including action to target foreign funding of environmental groups supporting protesters who are blocking infrastructure.
- After the OPP cleared the rail blockade in Tyendinaga, new protests and blockades occured in BC – including on West Coast Express lines, at the Port of Vancouver, the intersection of Clark and Hastings, the Legislature in Victoria, and at a rail crossing in New Hazelton.
- In each of these cases, police have moved quickly to enforce injunctions and clear the protesters from blockades.
- Business and industry groups like the CFIB and national agriculture stakeholders have warned about the growing economic impact the blockades are having.

Alleged Foreign Funding of Protests

Background:

- During Question Period on February 26, the Opposition alleged that foreign organizations are funding the ongoing protests and economic disruption in BC.
- The Opposition cited U.S. tax documents that they say show several American based organizations have provided approximately \$4.2 million USD to six Canadian organizations associated with the protests.
- West Coast Environmental Law and the Wilderness Committee are the two BC organizations cited by the Opposition.
- The Opposition called on government to introduce legislation to ban candidates, parties and third-party advertisers from accepting contributions from foreign entities.
- They also called on government to ask the Canada Revenue Agency to withdraw the charitable tax status of the organizations associated with the protests.
- In May 2019, Opposition Leader Wilkinson tabled a Private Member's Bill titled the "Control of Foreign Funding and Electoral Influence Act."

Medical Assistance in Dying - End to Delta Hospice Service Agreement

Background:

- Fraser Health will stop funding the Delta Hospice Society on Feb. 25, 2021, providing the required 365-days notice to end their service agreement without cause.
- The termination follows the Society's board's refusal to comply with federal medical assistance in dying (MAiD) law and BC policy.
- In response, MLA Paton refused to say whether or not he thinks the facility's current policy is acceptable, leading MLA Kahlon to call on Paton to support patients' rights
- Paton later clarified that publicly funded facilities should be prepared to offer this right to their patients.
- The 10 hospice beds represented by the existing facility will stay in Delta.
- Following the federal legalisation of MAiD, Minister Terry Lake had developed a policy that requires a hospice to allow patients to access MAiD in their facility, if their beds are more than 50% publicly funded.
- On Dec. 5th, Fraser Health provided an initial formal notice on areas of non-compliance and warned the Hospice it must come in line with federal laws.

Universal Access to Contraceptives - Vancouver City Council Motion

Background:

- On Feb. 26, Vancouver City Council debated a motion calling on the province to fund universal access to contraceptives sponsored by Christine Boyle and Jean Swanson.
- The City of Victoria unanimously supported a similar motion in January. On Dec. 5, CTV reported that B.C. is open to the idea.
- Government has taken some action to make prescription drugs including the pill, hormonal injectables, and some IUDs cheaper for lower income people.
- As of January 1st, 2019, government reduced or eliminated Fair PharmaCare deductibles for 240,000 lower-income British Columbians for the first time in 15 years. Individuals earning up to \$30,000 no longer have a deductible, and thus can start to receive coverage for prescription medicines right away. Those with an income of up to 45,000 will start getting coverage sooner. Fair PharmaCare covers 70% of drug costs.
- Advocates say that it's good to have these kind of programs, but people end up not accessing support because of confusion around who is eligible and proof of income.

Coronavirus Update

Background:

- Media has been reporting on a rise of coronavirus cases in Iran and Italy, as well as the the 6th and 7th B.C. patients who contracted coronavirus in Iran and through close contact with 'Patient 6' in B.C. respectively.
- BC is now asking ALL international travellers who are returning to B.C. to monitor themselves closely for symptoms.
- Some people have asked why the schools and hospitals patients went to are not being identified. All those people who may be at risk have been contacted by Fraser Health. We want to protect people's confidentiality so they feel comfortable coming forward.
- Minister Dix & Dr. Henry have said: "We are preparing for all possibilities that may occur in the coming weeks, including the possibility of a [global] pandemic."
- In total, seven people in B.C. have tested positive for COVID-19. The first individual has recovered, the others are recovering in self-isolation at home.
- There are 81,109 cases worldwide 78,191 of those in China. 2,718 people have died.
- Over 1,000 samples have been tested in BC more than any other jurisdiction due to our intentionally low threshold for testing to ensure more people are eligible.

Caribou Recovery - Partnership Agreement

Background:

- On February 21, BC, the federal government, the Saulteau and West Moberly First Nations signed the Partnership Agreement.
- Tumbler Ridge and the Peace River Regional District have since issued news releases supporting the signed agreement and the amendments providing for a greater role for local governments.
- In response to the agreement being signed, the Opposition criticized government's for not making further amendments and the approach to community consultation.
- The Mayor of Chetwynd, Allen Courtoreille, and Blair Lekstrom say they are concerned that BC signed the agreement without providing information on the socio-economic impacts to people in the region.
- Following the Caribou Leaders' Table, the Socio-Economic Committee was formed to review the socio-economic report and provide recommendations to BC and Canada on further work needed to understand the impacts of the agreement and to plan necessary mitigation strategies.
- The Socio-Economic Committee is comprised of local governments, industry, First Nations, BC and Canada. Its first meeting was held in January 2020 in Chetwynd.
- Representatives from Tumbler Ridge, Dawson Creek, Fort St John, Mackenzie and Peace River Regional District are current local government members of the committee.
- Chetwynd declined to participate in the first meeting.

- On February 27, Minister Farnworth will announce that he has granted the City of Surrey approval for the creation of a municipal police board.

Minister approves establishment of a Surrey Police Board

VICTORIA – The Minister of Public Safety and Solicitor General, Mike Farnworth, has granted approval for the creation of a municipal police board for the City of Surrey—the next stage in the City of Surrey's plan to transition from the RCMP to a municipal police department.

Having considered the Provincial Municipal Policing Transition Study Committee's report, as well as the recommendation of the Director of Police Services, pursuant to s. 23 of the Police Act, the minister is confident that the key aspects of the transition plan that required more detail have been thoroughly considered.

Chaired by the Hon. Wally Oppal, the Provincial Municipal Policing Transition Study Committee included representatives from the City of Surrey, the Ministry, and independent consultants with specialized expertise. The committee was established in August 2019 to ensure the City of Surrey's transition plan addressed all key issues, and its work has now concluded.

The Surrey Police Board, once established, will be responsible for the creation and governance of the Surrey Police Department and responsibilities will include being the employer of the police and civilian employees, providing financial oversight for the police department, establishing policies and direction for the police department and managing service and policy complaints against the department.

To support the transition process, the Policing Model Transition Secretariat, established in Spring 2019, and the Director of Police Services will continue to provide oversight, leadership and support for the Province and the City of Surrey—ensuring that Provincial accountabilities, public safety, and police oversight are maintained throughout.

All parties involved acknowledge the complex scale of a transition this size and are committed to cooperation and collaboration with Public Safety Canada and the RCMP.

A timeline for the transition will be determined by key partners as this work progresses.

In 2018, the City of Surrey initiated termination of their agreement with the RCMP and transition to a municipal police force, in accordance with their powers under the Police Act.

Surrey Police Transition Process

Timeline:

- November 2018 City of Surrey voted unanimously to terminate their agreement with the RCMP and move to a municipal police force.
- May 2019 City of Surrey submitted its Surrey Policing Transition Report to Minister Farnworth for review and approval in his capacity as Solicitor General.
- August 2019 Minister Farnworth and Surrey Mayor Doug McCallum released a joint statement stating the City of Surrey was given the green-light required to establish Surrey's municipal police department.
- August 2019 Provincial Municipal Policing Transition Study Committee, chaired by the Hon. Wally Oppal, was established to ensure all key issues and complex details were thoroughly addressed in the City's transition plan.
- January 2020 The Committee submitted its report to BC's Director of Police Services.
- February 2020 The Director recommended to the Minister to establish a police board for the transition to a municipal police department in the City of Surrey.
- February 2020 The Minister granted approval for the creation of a municipal police board for the City of Surrey, the next stage in the City's plan to transition to a municipal police department.

Establishment of a Police Board:

- Under the Police Act, a municipal police board, which requires the approval of the Minister of Public Safety and Solicitor General to be established, is required to establish and govern a municipal police department.
- The establishment of a new police board will take place over the coming months.
- Parties involved in the establishment of a new police board include the Ministry of Public Safety, the Director of Police Services, the Minister of Public Safety and Solicitor General, Crown Agency and Board Resourcing Office (CABRO), Legal Services Branch (LSB), Cabinet, the office of the Lieutenant Governor in Council (LGIC), and the Order in Council (OIC) Office.
- The Ministry will initiate the process to establish a police board by posting a Notice of Position (NOP) on the Crown Agency and Board Resourcing Office (CABRO) website.
- The NOP will be posted for 2-4 weeks to recruit prospective candidates. Once closed, CABRO will route all online applicants to the Ministry for screening and to identify suitable candidates to interview.
- Ministry staff will interview candidates and provide a list of recommendations to the Director, who will then conduct secondary suitability interviews.

- Police Record Checks will be conducted on successful applicants. The Director of Police Services, in accordance with their statutory authority, will make recommendations to the Minister of Public Safety and Solicitor General about appointments to the board, based on the overriding principle of merit.
- Police board members must be appointed by an Order in Council (OIC) by the Lieutenant Governor.
- Once established, the Surrey Police Board and the Surrey Police Department will be subject to oversight by the Director of Police Services, who has the statutory responsibility to superintend policing throughout B.C.

Role of a Police Board:

- Police boards have four main governance functions:
 - Employer of the police and civilian employees;
 - · Provide financial oversight for the police department;
 - · Establish policies and direction for the department; and
 - · Manage service and policy complaints against the department.
- A municipal police board consists of:
 - The mayor who acts as board Chair;
 - One person appointed by the municipal council; and
 - Up to seven people appointed by the Lieutenant Governor in Council.
- A police board can have a maximum of 9 appointees. Initially, the Surrey Police Board will have seven members which includes five members appointed by the Province, one member selected by the municipality and the mayor of the City of Surrey who will serve as chair of the board. The option to add two additional board members will be considered at a later date.
- Initial board appointments will range from one to three-year terms.
- The Director will communicate all expectations of the police board for the establishment of a new police department to the board once it is established.

Hiring of Police Chief and Law Enforcement Officers:

- Pursuant to the Police Act, a municipal police board is required to establish and govern a municipal police department.
- Once a police board is appointed, the board will be required to hire a chief constable.
- Once the chief constable is selected, efforts can be undertaken to hire additional exempt positions.
- Hiring of unionized positions can only be undertaken once a collective agreement has been negotiated.
- The proposed model for the Surrey Police Department recommends a progressive scale up of the new Department while maintaining a fully funded police service at least equivalent to the current state and increasing in future years.
- The Province does not have a role in the staffing of a municipal police department.

Other:

- All decisions and responsibilities regarding direct costs for the Surrey Police Department rest with the City of Surrey and the Surrey Police Board, once established.
- The operational structure of the Surrey Police Department will be determined by the police board and chief constable.
- The process for the transfer of investigative files from one police agency to another will be determined and coordinated by the RCMP, the police board and the chief constable to ensure a seamless transition that maintains the integrity of investigations and victims and other involved persons are not negatively impacted.
- The proposed model for the Surrey Police Department recommends maintaining participation in the Integrated Teams consistent with the levels that currently exist through the Surrey RCMP.
- There are provisions in the existing policing agreements that address the process for the transfer of assets such as computers, tactical gear, uniforms and vehicles. These processes will be initiated and outcomes determined by the RCMP and the police board.

Attached please find a Notice of Motion that was presented on January 27, 2020 to Surrey City Council. The Notice was accepted for the council agenda and will be discussed on February 10, 2020.

After conversation with the Semiahmoo FN, I was surprised to learn that neither the City of Surrey, nor the Province of British Columbia had included the FN in the process what so ever. The Semiahmoo FN have a tri-partied agreement with the Surrey RCMP. The Katzie FN are policed by Surrey RCMP, and Kwantlen FN land is also in this area. Unfortunately, there was no attempt to even seek their input. It is also important to know that Surrey has the largest urban indigenous population and therefore this is impactful to the public safety for many indigenous people.

There is no question that the residents of Surrey are concerned about this transition and have been vocal critical of the lack of transparency and accountability in the process. You will see from the attached RAW Data that there was no attempt by the City of Surrey to engage FN peoples in anyway. This is disappointing given that the direction from both the Truth and Reconciliation Commission and the United Nations Declaration on Indigenous People have clearly outlined when and how we must work on a government to government basis with FN on issues that impact them and their lands. Clearly this is a significant oversight of the process for the police transition.

As this issue will be on the February 10, Council agenda, it is important that I and others on council understand how the Province of British Columbia will rectify this issue so that we meet the requirements of the BC Declaration on the Rights of Indigenous Peoples Act recently passed in November 2019.

Whereas: The Semiamhoo and Katzie First Nations have a Tri-partied agreement with the RCMP for First Nations Policing on their Lands;

Whereas: Surrey has the largest Urban Indigenous population in British Columbia;

Whereas: Both through the Truth and Reconciliation Commission and the United Nations Declaration on the Rights of Indigenous Peoples ("UNDRIP"), Federal, Provincial, Territorial and Municipal Governments are required to adopt participatory approaches to indigenous issues, which requires effective consultation and the building of partnerships that promotes full and effective participation for Indigenous peoples in all matters that concern them;

Whereas: The first two values of the City of Surrey's own "All our Relations" Report are:

"Respect for the political autonomy of the Coast Salish First Nations in Surrey."; and

"Respectful engagement with the Coast Salish First Nations in Surrey.";

Whereas: Fifteen of the forty-six articles in UNDRIP speak to the importance of indigenous peoples' participation in all decisions that affecting their lives.

Whereas: Guideline #6 of British Columbia's *Draft Principles that Guide the Province of British Columbia's Relationship with Indigenous Peoples* provides that: "The Province of British Columbia recognizes that meaningful engagement with Indigenous peoples aims to secure their free, *prior and informed consent* when B.C. proposes to take actions which impact them and their rights, including their lands, territories and resources." *[emphasis added]*;

Whereas: The Semiahmoo and Katzie First Nations advise that there has been no consultation with them regarding any possible transition to a Surrey Police Force by the Government of Canada, the Province of British Columbia or the City of Surrey;

Be it resolved that: The existing process being followed to consider transition from the RCMP to a Surrey Police Force be immediately suspended until a sufficient, respectful and transparent consultation process that meets the federal, provincial and municipal obligations to consult with our First Nations peoples affected by the proposed changes has been adopted.
