As your Stikine MLA I've been working on the inside of the institution I was elected to on immediate and, at the same time, future looking solutions to the current situation faced by BC, Canada and the Wet'sutwet'en. In recent weeks as your local representative I've met in person or had direct conversations with Wet'suwet'en hereditary chiefs, the Office of Wet'suwet'en, the RMCP, the Premiers Office, the Premier, the Minister of Indigenous Relations and Reconciliation, federal MP Taylor Bachrach, the federal government, liaison Nathan Cullen and others. The immediate objective is to find a peaceful, safe resolution to the current situation. At the same time, the longer-term objective is about rights and title as outlined and committed to in the joint statement issued by Wet'suwet'en hereditary chiefs, the Premier and the Minister of Indigenous Relations and Reconciliation issued Feb. 7, 2019 that is included below. I will continue this important work as your local representative, as I did before becoming an MLA, and as I will as a member of the community long after my time as an MLA is done.
