I'm sending you this letter to request your kind assistance and advice regarding the following urgent issue. I have talked to Mayor Kennedy Stewart earlier today on the related issue as we met at Vancouver City's New Year Celebration. I am copying this letter to him and Minister Adrian Dix.

As you are very well aware, there's a novel coronavirus infected pneumonia outbreak in China, especially in the city of Wuhan, Hubei Province. The Chinese government and Chinese people are making all out efforts to contain and control the epidemic. Medical staffs from all over China are mobilized to Wuhan for the treatment of the patients and the front line medical staffs are in extremely urgent need of professional disposable (single use) protective equipment including, respirators of or above the level of N95 masks, isolation gowns, goggles and face shields.

My office is instructed to liaise purchase of the above equipment. I would really appreciate if you could kindly refer my office to the relative provincial authorities and contact information.
