We are writing in follow up to our letter of September 17, 2020 in which we gave advice that B.C. should adopt a program that addresses competitiveness by protecting eligible emissions intensive trade exposed (EITE) industries from the full carbon tax and considers alignment with Canadian and international programs. We committed to forming a Working Group to advise government on principles and process for an approach.

We agreed to a governance process and the following principles that guided our work. The principles are:

## • Enhance incentives to reduce emissions

Stimulate innovation and the development of viable emissions-reducing technologies that result in lower abatement costs for EITE industries and assists BC in meeting climate objectives.

## Minimize competitiveness and carbon leakage risks

Minimize carbon leakage by limiting impacts on competitiveness from carbon pricing for large industrial facilities in a way that brings congruity within Canada and in other competing jurisdictions and recognizes the incremental abatements costs in BC.

## Consistency across sectors

The broad framework for assessing and addressing EITE competitiveness issues should be consistent across sectors and firms.

- Transparency to promote fairness and encourage broad support
  - Ensure continuous improvement through a review of the system after some time period.
- Simple to implement, administer and comply with and also be easily communicated

We are pleased to report that we had productive discussions at the Working Group on further details for a trade protection program for EITE industries that we believe improves upon on the current CleanBC Industrial Incentive Program (CIIP) and is aligned with the mandate letters.

The Working Group led solutions-oriented discussions to improve the CIIP. These discussions subsequently informed conversations at the Climate Solutions Council and with members of the Business Council of B.C. These groups will each be providing advice to the Minister of Environment and Climate Change.

As a Working Group, while we discussed broad competitiveness issues faced by B.C. industries, notably sales tax, we are agreed that the development of an improved CIIP program for EITE industries is the most expedient approach at this time to address the competitiveness risks that B.C'.s low carbon content commodities face in a changed and increasingly more competitive global economy. We believe that the approach we are proposing can be viewed as a component of Clean BC's goal to build a low-carbon economy while protecting against carbon leakage.

We would be pleased to discuss further as required with government officials.
