APPENDIX G - Throne and Budget Speeches

CONTENT FROM THRONE SPEECH 2021

“...Too often, economic growth in our province has come at the expense of the environment. That must change. We can no longer rely on simple resource extraction to generate wealth with no regard to long-term consequences.

“Your government is determined to continue tackling the environmental challenges that were neglected for too long.

“This year, it will continue the work of reforming the Forest Act and the Forest and Range Practices Act to meet the challenges of the 21st century.

“Your government will continue to take action on the independent report on old growth, which recommended important new protection for remaining old growth stands not already protected. New measures will be proposed to increase access to fibre for communities, First Nations, and small businesses.

“Land management practices will be updated to improve forest stewardship and emphasize environmental protection.

“The forest sector will be supported to move from volume to value – using innovation to improve management, support communities and generate economic opportunity.

“At the same time, your government will move forward with other measures to protect B.C.'s environment, including improving waste management, particularly of plastics.

“These actions will build on the progress we have made recently – like removing over 120 tonnes of marine debris from B.C. coasts and shorelines, protecting wildlife and habitat, and planting a record 300 million trees last year.

“Our economic recovery must become an opportunity to accelerate environmental protection, not an excuse to relax our commitment to sustainability.”

CONTENT FROM BUDGET SPEECH 2021

“...We are also continuing to support other emerging opportunities, like mass timber technology. Mass timber is good for forestry communities — because it adds value to timber rather than relying on volume alone.

“It is good for the environment — because it is sourced from sustainably-managed forests that have a lower carbon footprint.

“In short, it is good for British Columbia. Forests are the lungs of our province, capturing and storing carbon — we can't take them for granted.

“Thousands of tree planters set out last year — despite the pandemic — to replant forests, including those affected by wildfires and pine beetle.

“The result was an astonishing 300 million seedlings planted, with another 300 million planned for this year.

“Our province has great natural wealth, and that goes far beyond our forests.

“As we tackle climate change and invest in our clean tech future, we know that our mining sector will play an important role.

“It provides the metals and minerals that will be used — here and around the world — to create green technologies, from electric vehicles to wind turbines.

“Our province's natural beauty is also a great source of wealth, one that we have all come to rely on as we turn to the great outdoors to recharge in a COVID-safe way.

“Budget 2021 enhances people's access to nature by expanding and improving campgrounds and trails.

“And starting next year, Mr. Speaker, we will be adding up to 100 new campsites throughout the province — every single year.

“Our plan views B.C.'s recovery as an opportunity to accelerate environmental protection and sustainability.

“The successes we are seeing through CleanBC show how protecting our environment is good for people and the economy.”

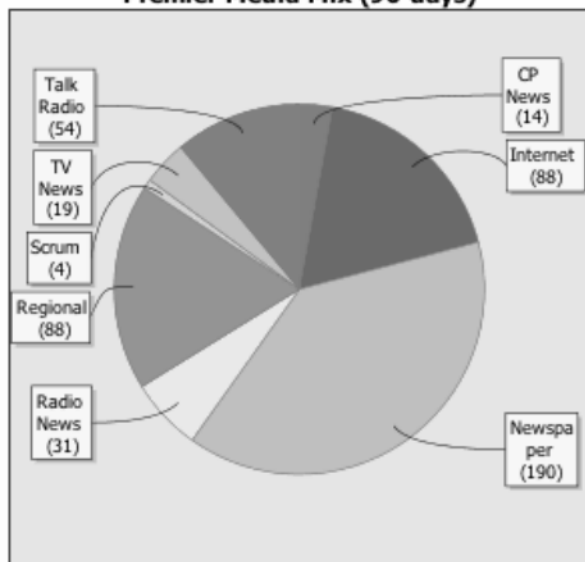

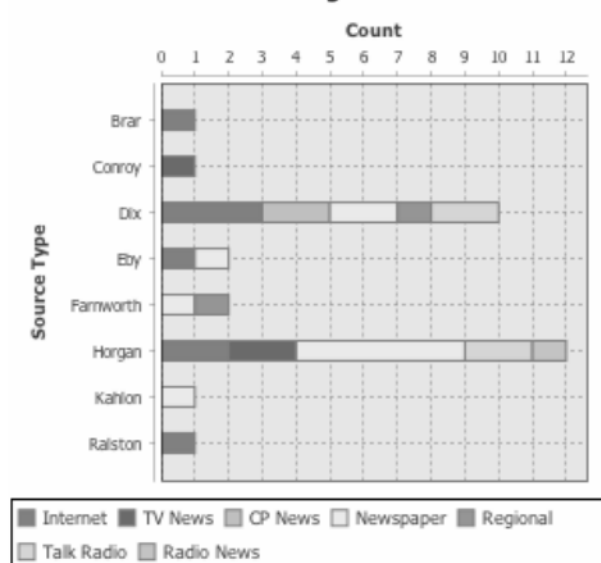

Premier Media Mix (90 days)



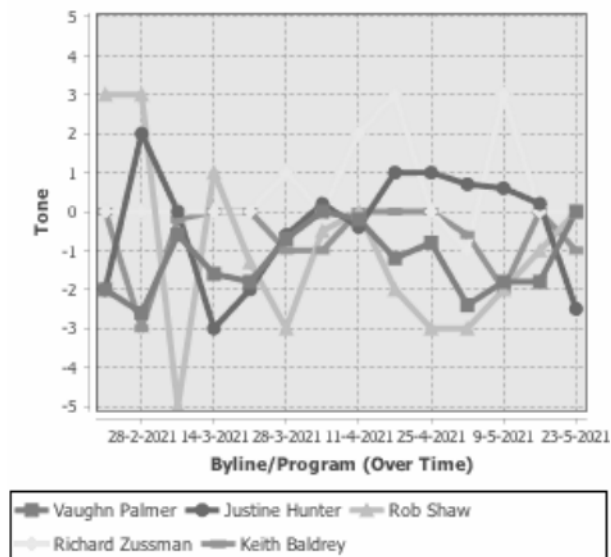

DATE: May 25, 2021

ISSUE: Canopy Planet request for progress in Great Bear Rainforest.

BACKGROUND:

- Fundamental to reaching the agreements that created the Great Bear Rainforest (GBR) was the stakeholder partnership known as the Joint Solutions Project (JSP). A partnership between environmental groups, the Rainforest Solutions Project (RSP) and industry representatives, Coast Forest Conservation Initiative (CFCI).
- Key to the Province's relationship with JSP was a set of 25 Provincial implementation commitments. These 2016 commitments to JSP provided further technical detail in support of the GBR Land Use Orders (GBRLUO), and some, including the approach to Landscape Reserve Designs (LRD), required CFCI and RSP members to reach agreement on completion or methodology.
- LRDs were to be a stakeholder led process, working with First Nations, toward targets for partial completion in January 2021. In early 2020, JSP members were unable to reach consensus on the LRD implementation approach and RSP withdrew from the JSP partnership.
- RSP made attempts to solicit support from Coastal First Nations (CFN) and Nanwakolas Council, the Province's G2G partners in GBR implementation, but were not well received by either organization. The two indigenous alliances hold that RSP and CFCI are often biased against indigenous forest values and sometimes work to destabilize alliances between First Nations.
- In addition to economic timber harvesting and managing for conservation targets, managing for Indigenous forest values is an essential element of implementing ecosystem based management (EBM) in the GBR.
- In mid-2020, and as required by the GBRLUO, the Province, CFN and Nawakolas in their G2G partnership, began the technical analysis that is the review of EBM implementation in the GBR (GBR 2021 Review). The G2G technical team has been reaching out to CFCI and RSP to engage them as stakeholders. Their information is being considered in an iterative process that will result in G2G consensus-based recommendations to government in early 2022.

DISCUSSION:

The timing of the break-up of JSP was unfortunate, and as a result, the G2G partnership has taken a more directive role in advancing GBR implementation, including leading the GBR 2021 Review, developing a path forward for the completion of LRDs, preparing a set of GBRLUO draft amendments, and advancing/finalizing several other essential GBR implementation commitments. The G2G technical team meets weekly, is highly functioning and has developed a strong level of trust that is supported by the executive leadership of each partner. CFN and Nawakolas have indicated that the G2G partnership for GBR implementation aligns with their expectations for the implementation of the *United Nations Declaration on the Rights of Indigenous Peoples*.

Evidence of this effective working relationship became apparent when a major LRD target date prescribed by the GBRLUO was missed in January 2021. The G2G partnership acknowledged this situation and developed a policy approach in consultation with stakeholders. The policy maintained harvesting activity while keeping conservation targets in check and respecting the need to consult with First Nations.

During the 5 year period that stakeholders were leading this process, no LRDs were prepared to the draft stage. In the last 5 months, in a process led by First Nations and supported by the Province, 20 LRDs are now in the draft stage. Before each LRD is put into operational use, stakeholders will have an opportunity to provide their comments to G2G for consideration.

Despite commitments from CFCI and RSP to contribute to the GBR 2021 Review discussions, and respect the review process by participating at the table before engaging in public campaigns, both organizations have looked to proxy groups to further their GBR interests and issues at the senior executive levels of the G2G partnership. For RSP, the Canopy group has been leveraged for this purpose.

Canopy's role became apparent in March 2021, after a roundtable forum for Canopy members, and attended by Minister Conroy with representatives from CFN, Nanwakolas, CFCI and RSP. At this forum, Minister Conroy, Chief Marilyn Slett (CFN) and Dallas Smith (Nawakolas) described the progress to date, acknowledged the challenges, and reiterated earlier G2G messaging to stakeholders asking them to bring their comments and contributions to the GBR 2021 Review table for consideration. The province's message also included an invitation to Canopy members to show their support for the GBR and its Indigenous communities by purchasing their carbon offsets from the CFN and Nawakolas led carbon sales programs in the GBR. To date, only the Province of BC has purchased GBR carbon offset tonnes.

Following the roundtable forum, Canopy has taken the media lead in representing the RSP views presented at the March roundtable, and recently approached separately the senior executive staff at each member of the GBR G2G partnership to press for an update on implementation progress. The preference of the G2G partnership governance team is to prepare a joint response to Canopy.

NEXT STEPS:

- Finalize a joint response to Canopy for signature by Minister Conroy, Chief Marilyn Slett, President, CFN, and Dallas Smith, President Nanwakolas Council.

Working Draft - CFN, Nanwakolas and BC, response to Canopy

Canopy,

Many thanks for your recent note that follows up on the Investor GBR Roundtable.

Please note that, as we conveyed in our Roundtable presentations and discussions, Coastal First Nations, Nanwakolas Council and the Provincial government are engaging with each other in relation to the Great Bear Rainforest (GBR) on a collaborative, government to government basis. In future we trust that you will send any questions you may have about our ongoing efforts to implement Ecosystem-Based Management (EBM) in the GBR to us in a way that respects that relationship.

Regarding our ongoing efforts to implement EBM in the GBR, as you know much progress has been made to act upon the amending decisions we made in 2016. Among other things these actions include:

- Establish new provincial GBR forest management legislation under which we significantly reduced timber supply in the GBR and designated 8 large new protected areas totaling over 264,000 hectares as Special Forest Management Areas. Over the past 2 years we have worked to advance new legislation and complementary co-governance agreements which we hope to apply to the final designation and management of these areas.
- Crafting and enacting amendments to the GBR Land Use Order which establish strategic plan area targets for old growth protection and managed forest and which provide enhanced protection and stewardship of indigenous forest values and aquatic habits and riparian forests.
- Eliminating the commercial hunting of Grizzly Bears and expanding the geographic scope of recognized Grizzly bear critical habitats
- Advancing a pilot project that represents a new G2G approach to timber supply and harvest access management in which timber supply and access issues are addressed at Provincial administrative unit and First Nation territory levels simultaneously.

As you likely also know, the one area that has proven challenging to implement is the recommendations brought forward by Joint Solutions Project in 2015 related to development of landscape reserve designs (LRDs). Those LRD recommendations have proven to be technically flawed and somewhat prejudicial to recognition of Indigenous rights and protection and stewardship of Indigenous forest values. Put simply, over a 4 year period from 2016 to 2020, neither the CFCI companies nor the RSP organizations, working

independently or together, were able to prepare and submit a single LRD for G2G consideration.

Our senior officials and technical staffs have been working very hard to unravel and address these and other issues by undertaking a 5 year review of EBM implementation in the GBR. That review is taking into consideration technical data, commissioned reports, recommendations from key stakeholders and input from G2G EBM Forum members. Senior representatives of CFCI and RSP have been invited to participate at a technical level in the review via creation of an interim GBR EBM Implementation Working Group.

Due to the complexity of the issues, progress has been slow but headway is being made. Key activities completed and work products produced to date include:

- Crafting of proposed amendments to the GBR Land Use Order which are intended to ensure commitments to strategic targets are maintained while simultaneously resolving technical issues and enhancing protection and stewardship of key Indigenous and ecological forest values.
- Development of a streamlined and more effective approach to LRDs which will allow First Nations to take more of a lead role in developing and delivering LRDs. Using this approach, over the past 5 months 20 LRDs have been developed to a final draft stage and 20 more are in active development.
- Development of an Indigenous Heritage Features (IHF) Handbook which will facilitate identification and enhanced protected and stewardship of IHFs in the GBR.
- Updating of GBR timber supply and carbon budget models to include new inventory data and management requirements. Contracts are now in place to ensure completion of the analyses that is required to support G2G decision making.
- Development of interim policy guidance that addresses issues associated with submission of applications for logging permits and LRDs during the period before the 2021 Review is completed.

As you know, part of the new sustainable forest economy in the GBR has to do with the sale of carbon offsets. While a new 5-year sale/purchase agreement was negotiated in 2020 between Nanwakolas Council and Coastal First Nation member First Nations and the BC government, sales to the private sector market place have been limited and challenging. Your assistance with efforts in marketing and communications would be welcome.

Meeting with Ditidaht, Pacheedaht, and Huu-ay-aht First Nations to discuss forestry and old growth management.

Who:

Representatives from Pacheedaht, Ditidaht and Huu-ay-aht First Nations

Executive Summary:

Ditidaht (DFN), Pacheedaht (PFN) and Huu-ay-aht (HFN) First Nations are all very active in the forest industry holding multiple forest tenures on Southern Vancouver Island in the area where old growth logging protests are occurring (see attachment for details). HFN is a Maa-nulth Treaty Nation, and DFN and PFN are in the final stages of the treaty process.

Tree Farm Licences (TFL) 44 and 46 are within PFN, DFN and HFN's territories. Recently, HFN purchased 35% interest in TFL 44. TFL 44 covers 24% of DFN territory) and 2% of PFN territory. TFL 46 owned by Teal Jones (Teal), covers 9% of DFN and 14% of PFN territory.

Background:

In September 2020 under Part 13 of the *Forest Act*, the Province designated the Central Walbran Valley as one of the 10 areas identified in the Old Growth Designated Area #1 to defer old growth harvesting; however, the Minister of FLNR exempted the Central Walbran from the Minister's Order that prohibits old growth harvesting as the PFN did not indicate support for the deferral. During engagement, PFN leadership communicated that the community was divided on old growth protection in its territory and they needed more time for community engagement. PFN holds multiple forest tenures that rely on old growth

harvesting and owns and operates an old growth cedar mill near its reserve that provides revenue and employment to its members.

With the increased old growth protests in PFN territory at Fairy Creek and other locations, PFN has asked protesters to leave and have reached an agreement with Teal to stand down on old growth harvesting in Fairy Creek until it can develop an Integrated Resource Management Plan through comprehensive community engagement. The Province has provided \$100,000 to PFN to help develop this plan.

DFN has expressed a desire to increase its forest holdings as it feels it lags behind HFN and PFN and would like to purchase TFL 44 Western Forest Products Inc. shares when they become available to First Nations (up to 24%).

HFN has spent over \$30 million in acquiring 35% interest in TFL 44 and needs to harvest old growth as part of the TFL profile to capitalize on its investment. They have expressed concerns about safety issues in TFL 44 related to protester activity.

On June 1, 2021, the Province released its Intentions Paper re-affirming its commitment to implement the 14 recommendations of the Old Growth Strategic Review, while balancing the needs of forest industry and workers who depend on old growth for their livelihoods including these three First Nations.

Key Messages:

As committed to in the Intentions Paper, I am coming to you, as Indigenous Leaders who are active in the forest industry where pressures are mounting for further old growth protection, to hear first hand your views on the Intentions Paper and recommendations on next steps regarding old growth management.

Old Growth Deferral Technical Advisory Panel

Terms of Reference (DRAFT for discussion)

May 27, 2021

Background

The Old Growth Strategic Review includes a recommendation to implement deferrals to protect areas of old growth at immediate risk of irreversible biodiversity loss. Deferrals are one key part of the 14 recommendations, intended to be an immediate but temporary measure. More permanent conservation measures are to be developed through the balance of the recommendations and in conjunction with other stewardship initiatives such as species at risk planning, land use planning etc.

The deferral recommendation included implementation advice on how government could identify potential deferral areas. The implementation advice included five criteria, some of which can be mapped using Ministry data. Some of the criteria cannot be easily mapped and may be open to different interpretations. Ministry staff have completed analysis on the five criteria, however further input is needed to ensure deferral areas are addressing the intent of the recommendation.

Purpose

The purpose of the Old Growth Deferral Technical Advisory Panel (the Panel) is to provide analysis and advice to Provincial and Indigenous Governments on where to locate temporary deferrals and how to prioritize implementation of deferral areas, consistent with recommendation 6 from the Old Growth Strategic Review.

The Panel will be supported by the Ministry of Forest Lands, Natural Resource Operations and Rural Development as well as the Ministry of Environment and Climate Change Strategy. David Muter (ADM Resource Stewardship Division) will serve as facilitator for the group and coordinate any additional technical resources needed by the Panel.

Identification of Deferral Areas

Recommendation 6 from the Old Growth Strategic Review and the associated implementation advice will be used as a starting point for the work of the Panel. Ministry staff have completed

analysis on recommendation 6 and will share this analysis and associated maps with the Panel. Ministry staff will also support the panel in developing additional maps and data as requested by the Panel to support the work.

The Panel will develop a series of recommended deferral areas and a prioritization for the implementation of the deferrals. Ministry staff will support the Panel to develop specific shape files for the recommended deferral areas. As some forest data sets are incomplete, the Panel may also provide advice and guidance on how to complete field verification of the proposed deferral areas before they are implemented.

Implementation of Deferrals

Once a prioritized list of deferral areas has been identified by the Panel, government will immediately begin discussions with Indigenous Nations to implement the deferral. Government will apply the following principles in implementing deferral areas.

- **Address Areas of High Risk.** Government will follow the prioritization recommended by the Panel. This will require consideration of harvest plans over the next 2 years. Areas that are identified by the Panel but do not face risk harvest over the next 2 years may not be deferred but will be part of discussion on setting broader old growth and biodiversity targets (consistent with recommendation 9 and 10 in the Old Growth Strategic Review).
- **Respect for Indigenous Rights and Title Holders.** The Panel is will be invited to support the technical briefing with Indigenous Nations on recommended deferral areas. Final decision on deferrals will be between the provincial and Indigenous governments.
- **Continuous Implementation.** As deferral areas are confirmed by Indigenous and provincial governments, they will be submitted for approval by Cabinet. It is expected that several packages of deferral areas will be developed and advanced when they are ready.
- **Engage Industry and Local Government.** Once deferral areas are identified with Indigenous Nations, Ministry staff will engage with tenure holders and local governments. This will be an opportunity to discuss the conservation objectives for the area and how to best minimize and mitigate socio-economic impacts. The Panel will be invited to support these discussions.

ISSUE: Implementation Update - Great Bear Rainforest commitments

BACKGROUND:

- The 2016 Great Bear Rainforest Land Use Order (GBRLUO) and the subsequent 2017 *Great Bear Rainforest (Forest Management) Act* are the products of almost 20 years of collaboration and negotiation that set the statutory framework for the Great Bear Rainforest (GBR).
- The GBR is a 6.4 million hectare forest management area in which 85% of the forested land-base is removed from commercial harvesting and establishes a Managed Forest (550,000 hectares) to support industry by providing for a AAC of 2.5 million m³.
- This balance underpins the the principles of Ecosystem Based Management (EBM), by providing objectives for conservation, timber harvesting and human well-being.
- The on-going implementation of the statutory framework is guided by agreements with Coastal First Nations (CFN) and Nanwakolas Council (Nanwakolas), bi-lateral agreements with 25 First Nations, and a suite of commitments to stakeholder partners.
- Continuous improvement and collaboration are key principles that informed the development of this framework of legislation, agreements and commitments. The GBRLUO (2006, 2009, 2016) was drafted with the lessons of implementation experience and through partnerships with First Nations, forest sector and environmental groups (ENGOS).
- As required by the GBRLUO, the GBR 2021 Review is underway, and is led by the Province, CFN and Nanwakolas, a partnership known as the GBR G2G Forum.
- All implementation decisions in the GBR require the consensus support of the GBR G2G Forum, and must acknowledge the interests of the Indigenous rights holders in the GBR.
- The forum considers input from our stakeholder partners: Coast Forest Conservation Initiative (Interfor, BCTS, Western Forest Products), Mosaic and Rainforest Solutions Project (SierraClub, Greenpeace and Stand.Earth).
- The 2021 Review will conclude later this year, with a government-to-government consensus package submitted for decision to the Minister of Forests, Lands, Natural Resource Operations and Rural Development, anticipated early 2022.

KEY MESSAGES

- GBR implementation is an on-going process, and its decisions require the consensus support of the GBR G2G Forum and the Indigenous rights holders in the GBR.
- GBR implementation includes a range of inter-related objectives, conservation targets, commitments, the development of operational definitions, and includes the drafting, review and implementation of Landscape Reserve Designs.
- The GBR G2G Forum considers comments, submissions and advice from Industry and Environmental stakeholder groups.
- The 2021 Review of the GBRLUO is underway, led by a G2G technical team from the Province, CFN and Nanwakolas, and guided by a Terms of Reference (TOR) that has the support of Industry and ENGO stakeholder partners.
- The G2G technical team has developed draft amendments to the GBRLUO, and consistent with our TOR, drafts have been shared with Industry and ENGO stakeholders for comment.
- Draft amendments will move to final G2G recommendation (expected in early 2022) following

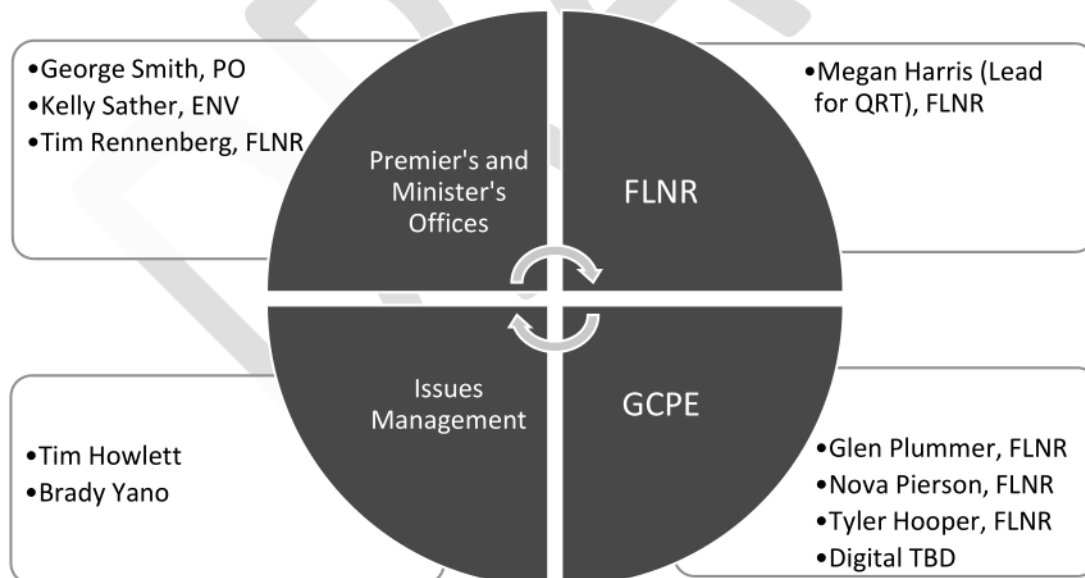

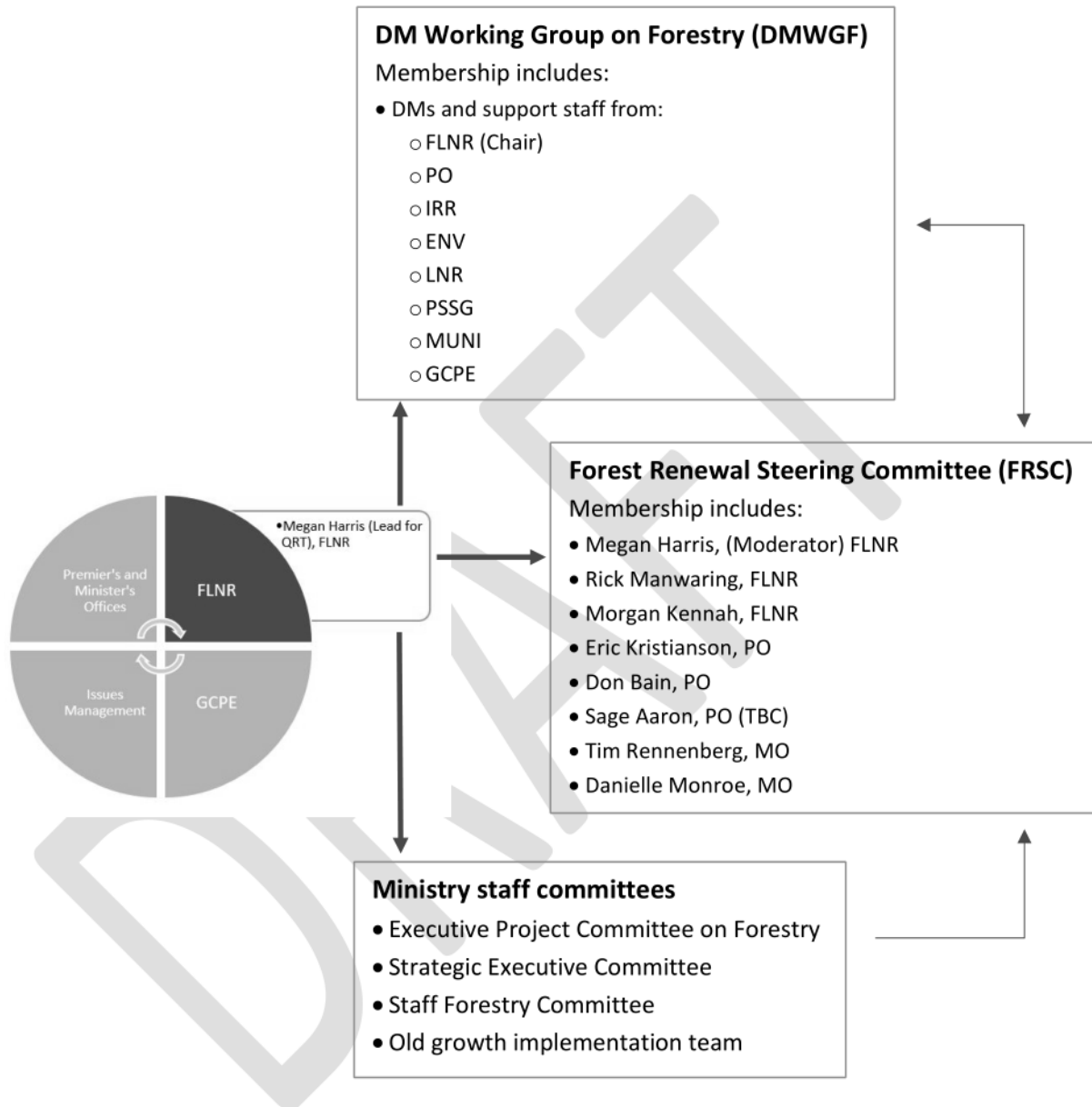

BACKGROUND:

Teal Jones Cedar Products (TJCP)/Fairy Creek Injunction Enforcement

- As of June 7th, 2021, approximately 200 protestors are present in the Injunction Zone. Police have made numerous additional arrests between May 25th and June 5th, 2021, primarily near the Hatton and Waterfall Camps, tallying a total of 172 arrests as of June 5th. Some individuals arrested are members of the Braided Warriors and the Indigenous Youth Movement. Despite these arrests, Chief Jones of Pacheedaht First Nation (PFN) has reaffirmed his support of Police action to date.

- Satellite protests sympathetic to the Fairy Creek Blockade, and some pro-logging counter protests, continue to emerge (e.g. protest at Premier's Constituency Office on May 28, 2021, protest in Castlegar on May 31, 2021, and planned protest in Nelson on June 5, 2021). s.15

- On June 4th, 2021 Ditidaht, Huu-ay-aht, and Pacheedaht First Nations signed the Hisuk Ma C'awak Declaration which formally gave notice to the Province of a request to defer old-growth logging for two years in the Fairy Creek and Central Walbran areas. The Nations asked that while work is underway everyone allow forestry operations in other parts of their Territories to continue without disruption.
- On June 7, 2021, the Premier released a statement acknowledging receipt of the Declaration. The Premier indicated that the Province is prepared to enter into discussions with the First Nations regarding the Declaration on an expedited basis.

- Ongoing communication between PSB, the Critical Incident Secretariat, the RCMP and other law enforcement agencies, and other communication channels is

necessary to monitor protest activities, support enforcement efforts, and protect the public's right to legitimate and peaceful protests.

Re: Old Growth Strategic Review Recommendations & Immediate Deferrals

Skwxwú7mesh Úxwumixw, the Squamish Nation, calls on the British Columbia Ministry of Forests, Lands Natural Resource Operations and Rural Development to act on our comments and concerns regarding the failure of the BC government to take steps to implement the urgent recommendations of the Old Growth Strategic Review panel. This call requires BC to take meaningful action toward honouring your commitments regarding old-growth forest management, including the implementation of immediate logging deferrals, and enabling the full participation of Indigenous Nations in these processes.

BACKGROUND

Indigenous Nations throughout BC have strong relationships with our forests stemming from thousands of years of Indigenous-led stewardship. Despite this relationship, and the deep knowledge it provides, our Nations have been left out of decision-making processes regarding our resources and have watched the destruction of our forests from commercial logging and other developments.

In September 2020, the BC government announced their new, holistic approach to protecting old-growth forests and committed to implementing all of the recommendations put forward by the April 2020 Old Growth Strategic Review report. These recommendations, particularly as they relate to collaboration with Indigenous Nations and protection of at-risk forests, presented BC with the opportunity to build lasting and meaningful relationships with Indigenous communities and to realize your commitment to reconciliation. However, as of now, no meaningful action has been taken to implement these

recommendations and our forests – and the many Aboriginal rights that rely on them – remain at risk.

THE SQUAMISH NATION'S CONCERNS

Our forests play an integral ecological role in the biodiversity and health of BC ecosystems and possess incalculable and irreplaceable cultural value and significance for our Nation.

In light of the ongoing risk of development to old-growth forests and the importance of these forests to our Nation's well-being – including our cultural, spiritual and economic needs – we demand that the BC government take immediate and sustained action to defer all harvest and development activities within areas of concern and to ensure that we as a Nation are included, consulted, and enabled to provide free, prior and informed consent respecting all commercial activity within our traditional territory.

In particular, we call on BC to enact the following:

- Immediately defer all harvest and harvest related activities (including road building) in all remaining old growth forests in our territory, , using any and all tools available to you (for example, by instructing BC Timber Sales to cease any development in the area and/or by declining new permits and licenses);
- Immediately defer harvest in all areas where the status of old forest is in doubt or there is insufficient data to conclude that the forest is not at risk (that is, enable the precautionary principle);
- Immediately defer harvest in forests with high ecological and cultural values, which are essential to long-term resilience and recovery in our territory, such as mature forests that are high volume or highly productive, at least until recovery and regenerative planning is complete;

- Support our Nation in developing a new planning process, based in both our Indigenous knowledge and science to ensure long-term ecological integrity and economic opportunities for our citizens; and
- Establish and support a Government-to-Government approach to decision-making that respects our sovereignty and ensures a well-resourced, transparent, and accountable approach to the paradigm shift for old growth management in BC.

CONCLUSION

We remind the province that in the Tsilhqot'in Nation case, the BC Supreme Court found that BC's entire forestry regime was ultra vires provincial powers. This determination resulted from the province's prioritization of maximizing economic return from forests over the protection and preservation of these spaces for Indigenous well-being and rights exercises. Further, the Court found that BC's forestry practices could not be justified without reference to a detailed record of species needs and a full and robust understanding of an Indigenous Nation's specific rights practices. These determinations on forestry rights highlight some of the problems that remain within the Province's current regime which have not been altered to implement court guidance.

In addition, BC has committed to upholding the minimum human rights standards in the United Nations Declaration on the Rights of Indigenous Peoples. These include standards regarding the right to be involved in decision-making, land stewardship, and the necessity to obtain free, prior, and informed consent. By adopting the Declaration on the Rights of Indigenous Peoples Act, the province must interpret laws of British Columbia through lens of the UN Declaration and ensure the human rights of Indigenous peoples are being upheld.

Our Nation is committed to ensuring that fundamental changes are made to the forest management approaches and priorities within BC and that the Crown recognizes our right to be involved in land-based decisions that are made on our territory. We believe that the Old Growth Recommendations are a good first step to seeing these changes come to fruition.

Given the high risk to ecological and cultural values associated with ongoing old-growth logging in our territory and in BC more broadly, we cannot stress enough the urgency of this call to action and the need for your rapid response. As such, we call on the Minister to make deferrals for the forests within our territory and to begin the process of engaging with our community in a way that is consistent with the BC Government's commitments under the Declaration on the Rights of Indigenous Peoples Act and the honour of the Crown.

ISSUE: Forestry Enforcement Update for the Deputy Minister Working Group on
Forestry

SUMMARY:

- Protest activities with respect to Teal-Jones Cedar Products (TJCP) continue to
ensue. As of June 16, 2021, Police have made 238 arrests.^{s.15}

- The RCMP report that protest activity is yet to cease following the announcement to
defer logging of old growth timber on Indigenous territories throughout Fairy Creek
and the Central Walbran Valley. It is anticipated that some level of protest activity
will continue in the area for the foreseeable future.

BACKGROUND:

- TJCP has harvesting rights for wood at the Fairy Creek Watershed on southwestern
Vancouver Island, which is an area that encompasses old growth timber and has
been the site of increased protest activity since August 2020. Protestor numbers in
the area have fluctuated between 80 and 200 individuals over the past year, with a
total of eight blockade sites established to date, including three occupied sites.

Protest Activity

- The blockades appear to be organized by a group called the “Rainforest Flying
Squad” and the collective protest is generally referred to as the “Fairy Creek
Blockade”. The protest groups involved are supported by a broad coalition of
environmental groups, including the Wilderness Committee.

- There have also been satellite protests sympathetic to the Fairy Creek Blockade that
have emerged, including a protest at the Legislative Assembly in Victoria
on June 11, 2021, which resulted in mischief.

Enforcement Action

- On April 1, 2021, the Supreme Court of BC (SCBC) made an order granting an Injunction that enables TJCP to continue forestry work in the Fairy Creek Watershed and allows for Police enforcement regarding obstruction or other related offences.
- Police enforcement of the Injunction began on May 17, 2021,^{s.15}

Old Growth Deferrals

- The Fairy Creek Watershed includes the traditional territories of the Pacheedaht, Huu-ay-aht, and Ditidaht First Nations, who have approved selective TJCP logging activities on these territories and issued related media releases.
- On June 4, 2021, these Nations signed the Hisuk Ma C'awak Declaration, which formally requested that the Province defer old-growth logging for two years in Fairy Creek and the Central Walbran Valley. The Nations have asked the public to allow forestry operations in other parts of their territories to continue without disruption. On June 9, 2021, the Premier publicly announced that the BC Government has accepted this request and will be deferring the harvesting of old growth trees in Fairy

Creek and the Central Walbran Valley for two years, which includes protecting about 2,000 hectares of forest from logging.

- The RCMP have connected with industry about alterations to ongoing forestry operations that may require changes to their enforcement strategy. TJCP has voluntarily committed to refrain from logging the old growth stands in Fairy Creek and the Central Walbran Valley. Currently, TJCP is working in the Eden, Edinburgh, Hatton, Braden, and Granite Creek areas, with private security teams holding road access and providing notification to those found in breach of the SCBC Injunction.
- The protestors have noted that the deferrals will not prevent substantial old growth logging to occur in other areas. The Rainforest Flying Squad has indicated they will continue protest activity until the entire Fairy Creek Rainforest is protected.
- Police remain in place to ensure that the lawful rights to work and peaceful protest continue in accordance with the SCBC Injunction,^{s.15}

Media Relations and Legal Observers

- Police have established provisions to accommodate media and legal observers (witnesses) at the protest sites in a controlled manner while enforcement is underway. However, an alternative media outlet has recently challenged efforts to ensure that media can effectively bear witness to active enforcement, arguing that the Police are too limiting on media access. The case is before the courts.

This week's FLNRO coverage analysis is attached.

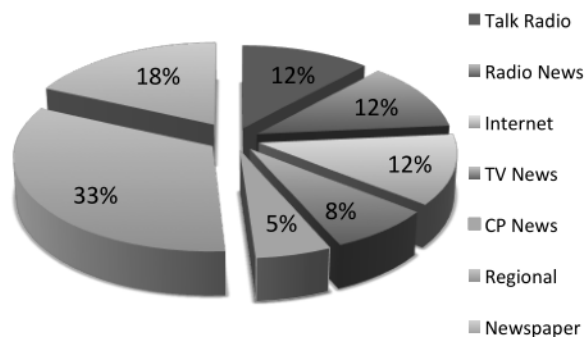

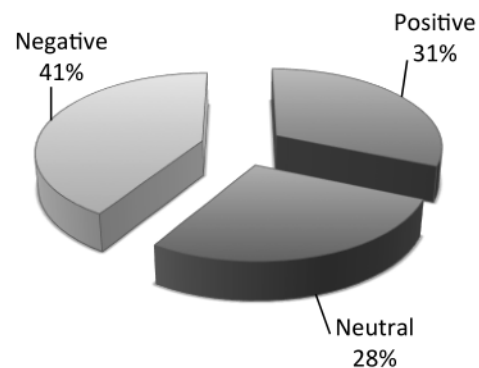

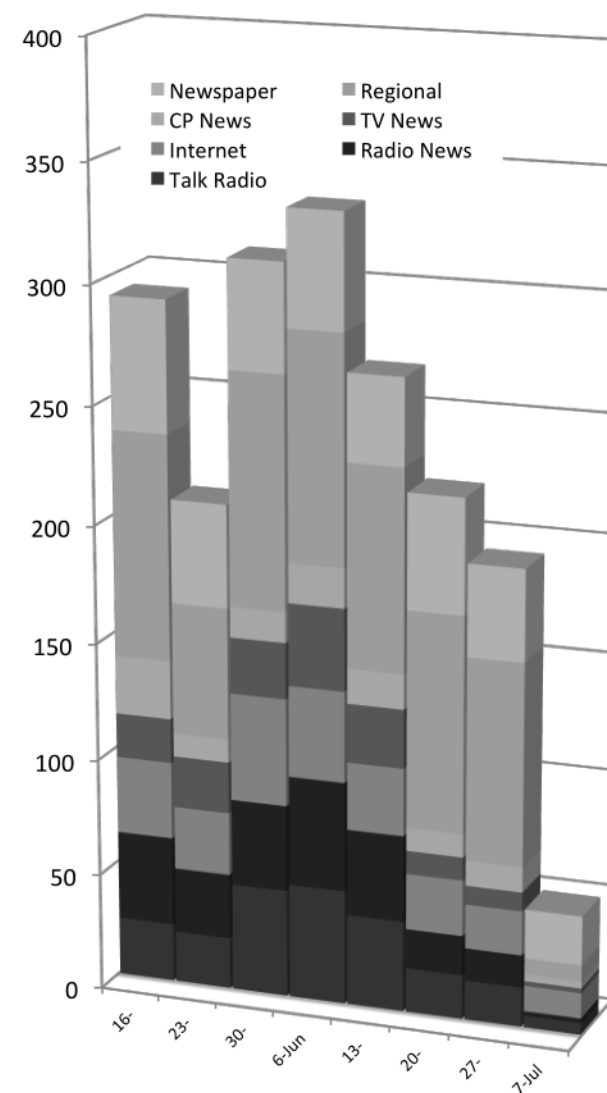

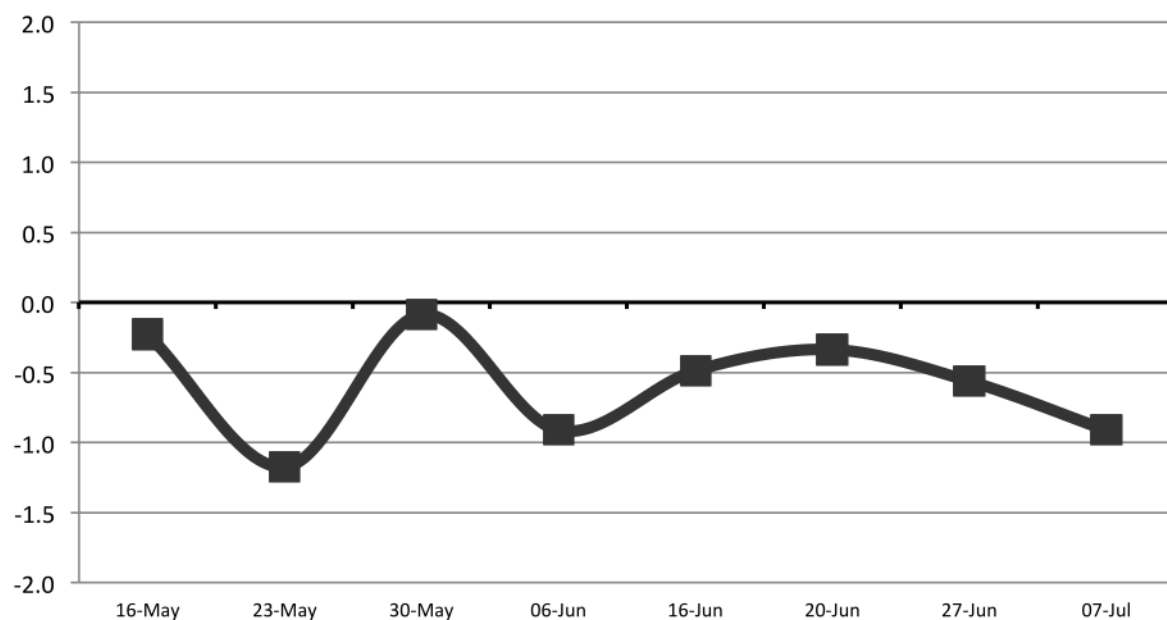

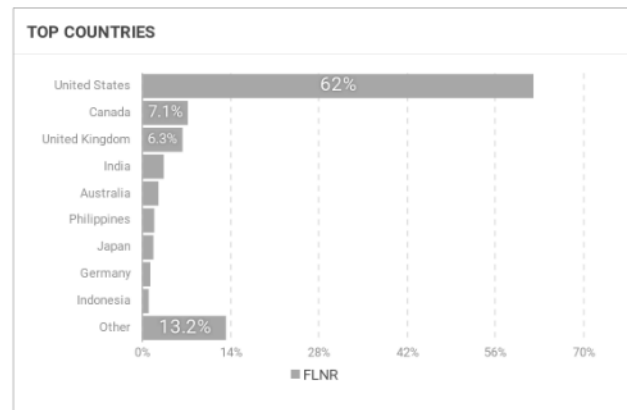
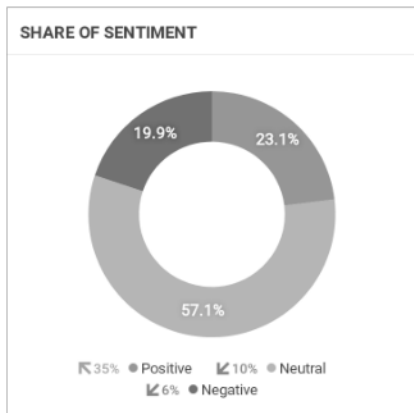
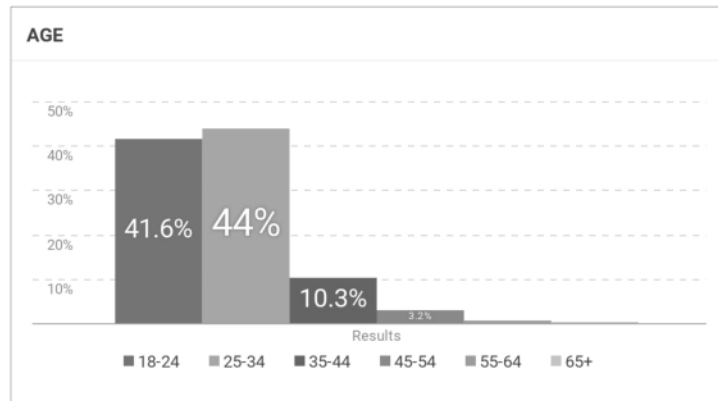
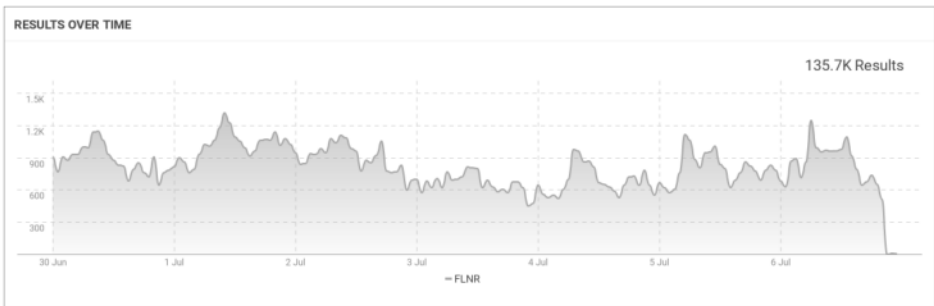
Number of Items by Date and Medium
