Extreme Heat Messaging June 30, 2021

Top Lines

- Over the past several days, B.C. has seen an unprecedented heat wave, with record-breaking temperatures across the province that have lasted into the night.
- I want to offer my sincere condolences to those who have lost loved ones over this past week.
- Our systems across the province are working hard.
- I want to thank the first responders who have been working tirelessly to respond to calls at this time.
- Please take a moment to check in with people in your life your parents and grandparents, and elderly or vulnerable neighbours to make sure they are ok and if they need support.

Provincial Supports

- As a province, we've provided support in a number of ways to help people and communities get through this unprecedented heat wave.
- We have worked with local communities and First Nations and made supports available to them.
 This includes reimbursements for:
 - Transportation to and from cooling centers in communities where no scheduled public or reasonable transportation exists.
 - o Staff wages and overtime to open a civic facility that would otherwise not be open.
 - Water for distribution within the facility.
- Emergency Management BC is also working with the First Nations Health Authority and Indigenous Services Canada throughout this event.
- BC's Health Authorities and BCCDC also provide resources to support local governments in developing Heat Alert and Response Plans and in declaring heat alerts and sharing information about how to stay safe.
- For those receiving support from BC's Home Health, nurses contacted clients and scheduled
 visits to make sure people with underlying health conditions were hydrated and staying as cool
 as possible.
- In long-term care networks, staff were redeployed to keep residents cool and hydrated.

Public Health Advice

- We are asking everyone to remember the advice distributed by Emergency Management BC last week:
 - O Never leave children or animals alone in a parked car
 - o Drink plenty of fluids
 - Keep cool in air-conditioned buildings, or take a cool bath or shower

- Plan activity before 10am or after 4pm
- Avoid tiring work or exercise in hot, humid environments
- Wear lightweight, light-coloured, loose-fitting clothing and a wide brimmed hat
- Many businesses and organizations that offer air conditioning and a cool centre, such as libraries, are extending hours to provide relief for those who do not have access to a cool place.

Ambulance Call Volumes and Supports

- We appreciate the incredible work paramedics and dispatchers are doing during this challenging time and we recognize they're doing everything they can to respond to emergencies quickly and effectively.
- I offer my gratitude to the paramedics throughout our province.
- Minister Dix has taken significant actions that have reduced wait-times for the most critical calls.
- But paramedics are facing two public health emergencies and record high call volumes. The stories we've heard over the past few weeks are heart wrenching.
- BCEHS is hiring 170 paramedics right now, in addition to the hundreds of paramedics we've hired since we formed government.
- Since 2016/17, B.C. has increased funding to BC Emergency Health Services by 25%. BCEHS also continues to strengthen paramedic mental health supports.

Moving Forward

- This kind of heatwave is not typical of British Columbia, but with the reality of climate change, we can't ignore the potential for this to become more common in the future.

QA – Lytton and Wildfires / Heat Wave July 1, 2021

What has the province done to improve wildfire prevention/response since the 2017 and 2018 seasons?

- Abbott Chapman Report: Have implemented more than 90% of the over 100 recommendations
- We have increased investments in direct fire which has helped the BC Wildfire Service improve its fire response capabilities by adding more crews, enhancing aircraft capacity and spending more on fire prevention activities.
- The B.C. government also committed \$60 million to the Community Resiliency Investment program to help local governments and First Nations mitigate wildfire threats around their communities.
- We've brought in digital tools for evacuation registration previously it was all done on paper which was time consuming and challenging for people.
- Since Abbott-Chapman, we have worked hard to improve the way we work with First Nations on wildfire issues. This has included better information sharing and training of First Nations firefighting crews.
- The new BC Wildfire Services mobile app additional avenue for direct communication with the public - consistent accurate and timely wildfire information.

What is the Community Resiliency Investment Program?

- Community Resiliency Investment Program established in September 2018 provides financial support to local governments thorugh UBCM to fund wildfire risk reduction and increase resiliency to wildfires.
 - o 366 grants allocated totalling 37 million as of beginning of May.
 - Starting in 2019/2020, as part of a more comprehensive wildfire risk reduction effort, the B.C. government committed up to \$50 million over three years for wildfire risk reduction on Crown land.
- In the 2020-21 Stronger BC economic recovery plan: Announced in September 2020, BC's Economic Recovery Plan issued \$19.5 million in additional funding to the CRI Program (\$10 million towards Fire Smart Community Supports and \$9.5 million towards Crown Land Wildfire Risk Reduction).

Will there be an adequate budget for fire response given projections for a bad season?

 We have increased the annual allocation for direct fire costs - but what is important is that responders have the statutory authority to spend what is needed on firefighting costs.

Can you tell us whether there are any confirmed fatalities?

- I'm not in a position to speak to that at this time.
- The site still poses significant safety challenges which limit the ability of police to review.

Was this caused by a train or derailment?

Staff are still investigating the cause of the fire.

You have urged people to be careful because most of the fires are human caused - are you shutting backcountry access?

- BC Wildfire Service is putting in place area closures in all of the area fires for first responder safety, community safety and our ability to manage these fires.
- This applies to both recreational activity and industrial activity.
- Firefighting staff collaborate with industry sharing resources and equipment for firefighting activities.

Is it a good idea to be re-opening the province to travellers from across Canada if the risk of human caused fires is so high?

- Our message to everyone in BC is that we are in a time of extreme fire risk and you must act accordingly.
- People need to use extreme caution to avoid human-caused fires.
- We have put in place area closures in all of the area fires.

Is other firefighting help coming?

- We have been in communication with the federal government and staff are working on the details of what sort of federal assistance would be most useful.
- We are also drawing on inter-provincial firefighting assets this is challenging as the heat dome moves over other provinces.
- And we are working on international assistance from overseas firefighting crews. This year is more complicated with COVID-19 but staff are working on it.

How has the heat impacted firefighting efforts?

- The heat and extreme dryness has obviously created very volatile conditions that contribute to rapid fire spread.
- At various points helicopters were not legally permitted to fly because air temperatures were above safe operating range.
- Firefighters and first responders working hard through incredible heat extra draining.

What are the impacts of COVID-19 on the fire fighting?

- BC Wildfire Service has done significant planning to adapt to COVID-19 protocols.
- It is fortunate that we have managed to bend the curve down but it is still a concern that needs to be managed.
- COVID-19 precautions are in place for firefighting crews as well as for evacuation assistance.

What supports are available to people who lost their homes?

- The situation in Lytton is currently being assessed for Disaster Financial Assistance.
- Supports are expected but the details will have to be confirmed as the assessments are completed.
- The immediate focus is on supporting people who had to evacuate very quickly.

Will the province help to rebuild the town?

- Disaster Financial Assistance assessment is in progress.
- Immediate focus is on supporting people who were forced to evacuate.
- The Province and Federal government will assist with municipal infrastructure.

- For those receiving support from BC's Home Health, nurses contacted clients and scheduled visits to make sure people with underlying health conditions were hydrated and staying as cool as possible.
- In long-term care networks, staff were redeployed to keep residents cool and hydrated.

Ambulance Call Volumes and Supports

- We appreciate the incredible work paramedics and dispatchers are doing during this challenging time and we recognize they're doing everything they can to respond to emergencies quickly and effectively.
- I offer my gratitude to the paramedics throughout our province.
- Minister Dix has taken significant actions that have reduced wait-times for the most critical calls.
- But paramedics are facing two public health emergencies and record high call volumes. The stories we've heard over the past few weeks are heart wrenching.
- BCEHS is hiring 170 paramedics right now, in addition to the hundreds of paramedics we've hired since we formed government.
- Since 2016/17, B.C. has increased funding to BC Emergency Health Services by 25%. BCEHS also continues to strengthen paramedic mental health supports.

Moving Forward

- This kind of heatwave is not typical of British Columbia, but with the reality of climate change, we can't ignore the potential for this to become more common in the future.
- And weather records have been broken and broken again. This week has seen the hottest temperatures ever recorded in Canada.
- Because we can't ignore the possibility of a next time, and it's clear that we can't rely on what we've done in the past.
- So after we're past this, we all need to take a hard look at what we need to change for the future.
- We're taking more than a dozen actions this year as part of the first phase of the Climate Preparedness and Adaptation Strategy to help set the stage for future work.
