# **BC Wildfire Daily Summary**

Since April 1, 2021, the BC Wildfire Service has responded to 1,101 wildfires, resulting in nearly 243,499 hectares of area burned. About 5 percent of the 305 wildfires that are currently burning are attributed to human activity, and 69 percent have been sparked by natural causes. The remaining 26 percent have yet to be determined. There are currently 305 active wildfires burning in B.C., 36 of which are Wildfires of Note.

There are multiple active Evacuation Alerts and Orders in place issued by regional districts, First Nations, and other local authorities.

#### **Weather Forecast**

Today: Rain in the northern half of the province will continue today but the area of continuous rain will move north toward Yukon. More lightning and local downpours will continue this morning, in the northern Kamloops Fire Centre, and Robson Valley Zone. Another weak upper trough will rotate north through the Cariboo later today bringing a 20-30% chance of lightning through the evening. Winds will ease slightly and temperature patterns will be similar to yesterday's moderate temperatures.

Tonight: The rain eases to isolated showers overnight and any lightning should end later in the evening.

Tomorrow: Another weak upper trough is expected to bring more showers and possible lightning to the central interior in the afternoon. Temperatures will begin to increase, reaching the mid-30s in the south initiating another warming and drying trend.

# How can people prepare for an evacuation alert and order?

- That means:
  - Stay tuned to your local authority's public information channels
  - Have an emergency kit and important documents ready to go, with clothing for several days, medications, comfort items for children and pets, things like photo albums and mementoes that can't be replaced.
  - o Check in with family, friends and neighbours who may need a helping hand.
  - o Make sure your vehicle's gas tank is at least halfway full.
- If you are issued an evacuation order, you will need to leave the area immediately.
- Staying in an area that's under an evacuation order puts yourself, your family, and first responders in danger.
- It's not worth the risk to stay behind.
- If you are evacuated, make sure you register with Emergency Support Services, whether or not you need support, so that your loved ones and communities know where you are and that you're safe.
- You can register online at ess.gov.bc.ca or by phone at 1-800-585-9559
- And if you need support, proceed to one of your local reception centres so they can help you.



#### Accommodation for Evacuees:

- People in wildfire-affected communities should plan their accommodations in the event of an evacuation order in advance to help ensure capacity for evacuees who need hotel rooms.
- If possible, the best option would be to arrange to stay with family or friends, so that commercial accommodations have capacity for those evacuees who have no other option.
- Your private home insurance should be accessed whenever possible to cover additional costs incurred while on mandatory evacuation. Make sure you confirm your coverage with your insurance provider and notify your insurance provider of the evacuation order. If other supports are unavailable to you, you can check with Emergency Support Services.
- If you're under evacuation order, you can self-register with Emergency Support Services (ESS) at www.ess.gov.bc.ca. If you can't self-register online, please go the Reception Centre designated by your local government or First Nation to register in-person. By registering, your community will know where you are, and loved ones can find out if you're safe.
- People who have self-evacuated to larger communities due to smoky conditions should also consider returning home
- Because smoky conditions shift and move, self-evacuating to another community does not guarantee a person's
  exposure will be reduced, and unnecessary relocation or travel will only add stress and anxiety that can also
  have negative health effects.
- In many communities, accommodations are reaching capacity. By returning home, people can help host-community Emergency Support Services create capacity for people who have been evacuated from their homes due to a direct wildfire threat.

Tomorrow: Extensive showers continue across the north of the province and as far south as the northern Cariboo. Isolated thundershowers pose risk to the northern half of the province, the Cariboo, eastern Kamloops and the Southeast Fire Centre.




#### Accommodation for Evacuees:


- People in wildfire-affected communities should plan their accommodations in the event of an evacuation order in advance to help ensure capacity for evacuees who need hotel rooms.
- If possible, the best option would be to arrange to stay with family or friends, so that commercial accommodations have capacity for those evacuees who have no other option.
- Your private home insurance should be accessed whenever possible to cover additional costs incurred while on mandatory evacuation. Make sure you confirm your coverage with your insurance provider and notify your insurance provider of the evacuation order. If other supports are unavailable to you, you can check with Emergency Support Services.
- If you're under evacuation order, you can self-register with Emergency Support Services (ESS) at
  www.ess.gov.bc.ca. If you can't self-register online, please go the Reception Centre designated by your local
  government or First Nation to register in-person. By registering, your community will know where you are, and
  loved ones can find out if you're safe.
- People who have self-evacuated to larger communities due to smoky conditions should also consider returning home.
- Because smoky conditions shift and move, self-evacuating to another community does not guarantee a person's
  exposure will be reduced, and unnecessary relocation or travel will only add stress and anxiety that can also
  have negative health effects.
- In many communities, accommodations are reaching capacity. By returning home, people can help hostcommunity Emergency Support Services create capacity for people who have been evacuated from their homes due to a direct wildfire threat.

# Incoming winds expected to increase wildfire activity

KAMLOOPS – The BC Wildfire Service is issuing a wind advisory for the Interior, southern Interior and southeast B.C. from Tuesday, July 20 to Thursday, July 22, 2021. This weather system is expected to exit the province late on Thursday, July 22.

Wind activity may significantly impact fire growth in these regions. The rate of fire spread will likely increase, and the direction of fire growth may change quickly on some wildfires.

The top priority for the BC Wildfire Service is human life and safety. We urge the public to maintain heightened awareness of the current wildfire situation.

People who remain in an area that's under an evacuation order may impede the ability of fire crews to fight a wildfire, because crews may be forced to stop fighting the fire to keep people out of harm's way. People who decide to "wait and see" if they need to evacuate an area may find their escape route blocked by fallen trees or abandoned vehicles, and familiar landmarks may be obscured by thick smoke.

- Wednesday, July 21: Winds will begin to increase from west to southwest Wednesday afternoon, with speeds up to 45 km/h and higher gusts near thunderstorms.
- Thursday, July 22: Forecasted winds could gust up to 40 km/h.

- Wednesday, July 21: Beginning in the evening, gusting winds of 50-70 km/h.
- Thursday, July 22: Gusting winds of 50-70 km/h.
