BACKGROUND:

Context – Dual Public Health Emergencies

- On April 14, 2016, the Provincial Health Officer (PHO) declared a public health emergency
 under the Public Health Act following an unprecedented increase in harm due to an unregulated
 drug supply that is unpredictable and highly toxic.
- Since 2016, over 7,000 British Columbians have died from illicit drug toxicity.
- The intersection of the public health emergencies of illicit drug toxicity and COVID-19 has exacerbated health inequities and the ongoing risk of illicit drug poisoning and other harms due to the toxic street drug supply.
- In 2020, there were 1,724 suspected illicit drug toxicity deaths. This is the most deaths in a single year to date and represents a 75% increase over the number of deaths seen in 2019 (985). Among Indigenous people, drug toxicity deaths rose nearly 120% from 2019.
- The November 2020 "In Plain Sight" report on Indigenous-specific racism in the B.C. health system found widespread systemic racism affecting Indigenous peoples, which results in a range of negative impacts, harms, and even death.

Pathway to Hope

- A Pathway to Hope sets the 10-year vision for a new system of mental health and substance
 use care in B.C., with an emphasis on prevention, promotion, early intervention, and integrated
 services, that builds on existing initiatives and implements new, innovative approaches.
- Actions to improve the wellness of children, youth, and young adults, support Indigenous-led solutions, and improve access and quality of care are well underway, in addition to ongoing work to address the overdose crisis and establish systems of treatment and recovery for substance use.
- Our government is taking action to give British Columbians what they so desperately need and deserve: a seamless network of mental health and addictions care where people get the help they need when and where they need it.
- With approved investments of over \$500M in Budget 2021, plus previous investments in Budget 2017 and 2019 and federal funding, a total of \$1.247 billion will be spent over the fiscal plan to advance the vision of a Pathway to Hope, allowing real progress on true systems of care that offer coordinated services for mental health care and for substance use care, as well as accelerating the response to the overdose emergency.
- Examples of innovative initiatives being implemented as part of A Pathway to Hope include the following:

Integrated Child and Youth (ICY) Teams

- ICY teams are community-based multidisciplinary teams which deliver wraparound mental
 health and substance use services and supports for children and youth aged 0-19 with soft
 edges up to 21 years old to ensure smooth and appropriate transitions, so families and
 caregivers have the support they need to connect with the right service at the right time.
- Services are outreach based, work closely with schools, early years services, primary care, and connect children and youth to specialized and higher intensity services when needed. ICY

teams are currently in implementation in 5 communities across B.C. and will be operational by the end of 2021/22.

Foundry

- Foundry is a network of centres and online supports that offer developmentally appropriate
 integrated health and wellness services and supports for young people ages 12-24. Each
 centre includes primary care, mental health and substance use services, peer and family
 support, and social services under one roof, making it easier for youth to get help when they
 need it.
- Currently there are 11 Foundry centres open across the province. B.C is committed to expanding Foundry from an existing 11 to a total of 23 centres province-wide by 2025/26.

Youth Substance Use Services

- In August 2020, government announced 123 new youth substance use beds across the
 province and enhance existing provincially accessible beds, doubling the number of beds
 available for youth in B.C., ensuring they get the care they need close to home.

- B.C. Budget 2021 provided an historic investment for youth substance use over three years to
 implement a full suite of evidence-based and culturally safe services and supports that focus on
 problematic substance use prevention for young people, and connecting them to integrated
 care early before small problems become large.

Expanding Virtual Mental Health Services

- In response to the COVID-19 public health crisis, government provided funding to launch virtual mental health and substance use services to people across the province, with emphasis on children, youth, and young adults. This includes:
 - Launch of Foundry Virtual, which provides primary care, mental health and substance use services, and peer support to youth aged 12-24 across B.C.
 - Expanded virtual counselling through grants to community counselling agencies.
 - Expanded virtual services for people experiencing eating disorders through the Looking Glass Foundation.

Overdose Response

- To date, the Province has committed a total of \$756.5 million through 2022/23 to support an
 escalated response to the illicit drug toxicity emergency.
- The Overdose Emergency Response Centre (OERC) was established within MMHA in December 2017 to act as a coordination centre in the province-wide illicit drug toxicity emergency response and provide support to health authorities, frontline workers, peers, agencies and organizations and local, regional and First Nations governments.
- The provincial illicit drug toxicity emergency response spearheaded by the OERC has focused on the implementation of a comprehensive package of essential health sector interventions and strategies to reduce illicit drug toxicity deaths and drug related harms.

Substance Use Treatment and Recovery

- 16 new and/or expanded integrated teams have been established to provide multidisciplinary care for adults experiencing substance use challenges and help people get connected and stay connected to care.
- In 2020/21, the Province announced additional funding to increase access to specialized treatment and recovery beds for those struggling with addiction, including 101 new beds for adults located across the province.
- Through Budget 2021, the B.C. Government is continuing to increase treatment and recovery services through new investments in withdrawal management, transition services, specialized treatment, and longer-term aftercare supports, including an additional 195 treatment and recovery beds.
- A Pathway to Hope also includes a commitment to develop a framework to build and guide
 improvement to the substance use system of care in B.C. The framework is currently under
 development and being informed by an Expert Advisory Panel, including peers and people with
 lived and living experience of substance use, clinicians and leaders from the health care
 system, researchers, Indigenous health leaders, and service providers from both the health and
 social sectors as well as targeted engagement with a diverse group of additional partners.

Decriminalization

- On April 14, 2021, the B.C. Government announced it will officially request a federal exemption from Health Canada to decriminalize personal possession of drugs in the province to remove the shame that often prevents people from reaching out for life-saving help.
- Officials with MMHA and Health Canada have been working on an agreement that outlines how
 the Province of B.C. will work with Health Canada to apply for a provincewide exemption to the
 Controlled Drugs and Substances Act, which governs simple drug possession.

Indigenous-led Solutions

- A key focus for the Province is supporting Indigenous peoples to take on a larger role in the
 design, planning and delivery of mental health and substance use services and addressing
 Indigenous-specific racism in the health care system consistent with the Declaration on the
 Rights of Indigenous Peoples Act (2019).
- The Province and B.C. First Nations work in partnership through a unique health governance structure that includes the only province wide First Nations health authority in Canada.
- The Province has made important investments to support First Nations-led approaches to
 mental health and wellness services, increase access to culturally safe treatment services
 through the construction of new First Nation-run treatment centres, and support a First Nationsled response to the overdose public health emergency.

Pharmaceutical Alternatives and Nurse Prescribing

- In September 2020, government announced that MMHA and the Ministry of Health will develop a policy to support prescribing of pharmaceutical alternatives to the toxic drug supply.
- This new policy will provide a broader range of medications to address the realities of high potency of illicit fentanyl and provide more specific guidance to support patient outcomes.

The public announcement of the new policy was accompanied by a public health order issued
by the Provincial Health Officer authorizing registered nurses and registered psychiatric nurses
to prescribe medications to support individuals with opioid use disorder. Nurse prescribing is
being phased in and has focused initially on opioid agonist treatment (OAT) medications.
