As your government maps out a plan for British Columbia's economic recovery while meeting your CleanBC commitments, I am writing to offer an update on recent and emerging developments at the Port of Prince Rupert that I believe can contribute meaningfully to your efforts on both fronts.

The Port of Prince Rupert remains well positioned to partner with your government on opportunities to expand and diversify BC's international trade and meet growing demand in a low carbon future. Prime Minister,

I write to urgently request your office's assistance with coordination across government departments regarding ongoing delays and missed deadlines relating to the regulatory process for the proposed Vopak Pacific Canada Project (the Project) at Environment and Climate Change Canada (ECCC). The issue, Prime Minister, is not the environmental review process itself, as we firmly support the highest environmental standards, but it is the fact that deadlines are promised by ECCC and then routinely missed.

Added together, federal regulatory delays have now put expected approval of the Project approximately nine months behind schedule, and trust in ECCC to meet the next target date is severely eroded. These consistent delays are undermining our global team's confidence in Canada as a place to invest and could impact future investment decisions.

Vopak is an international company, based in the Netherlands, that has supported global trade for over 400 years. We are ambitious and performance driven with a balanced roadmap focused on care for people, planet, and profits. Safety is our first priority.

We decided to build a new terminal, the Project, over four years ago. In making this decision, Canada won out over several other jurisdictions that were being considered by our global team. The Project is a new bulk liquids tank storage and marine export facility in Prince Rupert, BC. The Project, which is strongly supported by the Prince Rupert Port Authority and approved by the Government of British Columbia in April 2022, will store Liquefied Petroleum Gas, Clean Petroleum Products, and methanol on behalf of Vopak's customers. Vopak is determined to develop key infrastructure solutions to facilitate the transition of the world's changing energy systems and promote global energy security.

At full build out, the Project will bring online 578,000 cubic metres of storage space and export capacity for Canadian-produced energy transition fuels brought in from BC and Alberta's industrial heartland via the flattest rail grade through the Rocky Mountains to ensure low-emission transportation. The export of these lower-emission alternatives would immediately offset the use of coal in international markets (e.g., Asia Pacific and Latin America).

We are grateful for frequent engagement on this file with ECCC. Unfortunately, there have now been <u>nine months</u> of missed deadlines and delays stemming from the department initiating a Section 82 *Impact Assessment Act* process. The following is an abridged timeline of the Environmental Effects Evaluation (EEE) process, highlighting where delays have become especially challenging in 2022.

- An EEE under Section 67 of the Canadian Environmental Assessment Act (CEAA 2012), carried out by the Prince Rupert Port Authority (PRPA), Transport Canada (TC) and ECCC began for the Project in 2018.
- An assessment by the British Columbia Environmental Assessment Office (BC EAO) also began in 2018 (separate from federal process, but many parts of the review were coordinated). BC approved the project on April 20, 2022.
- In June 2021, ECCC notified Vopak that it intended to conduct its own EEE under Section 82 of the *Impact Assessment Act* and committed to meeting the Project's existing regulatory timelines to wrap up in **November 2021**. From 2018 to October 2021, the regulatory process was proceeding on the timeline expected by all parties until ECCC relayed it would not maintain the review timeline.
- After engagement with ECCC over six months (October 2021 April 2022), ECCC committed to a new proposed schedule on March 15, 2022, with a target release date for a Draft Determination Rationale (DDR) on May 16 and a final project decision in July 2022.
- ECCC missed the May 16 date and several new release dates that were proposed by ECCC were also missed, including the most recent targeted date of July 8. At this point, we have not received any official communication from ECCC on a new target date putting us over nine weeks past the original target of May 16.

To maintain our confidence in Canada as a place to invest, we are requesting a meeting with your office to discuss their involvement to ensure that the deadlines that are promised by your government are met.

We thank you for your urgent attention to this matter. If there is any additional information we can provide, please do not hesitate to contact me directly at any time.
