Paper Excellence

Issue: How probable is it that the Province and Paper Excellence (PE) can identify a pathway towards a successful economic recovery for the Company and the Communities that depend on those jobs?

Background: As the largest Pulp and Paper Employer in the Province, PE has operations in Crofton, Port Alberni, Howe Sound, Powell River, Skookumchuk, Chetwynd and MacKenzie. Powell River operations were curtailed in April 2020, MacKenzie in June 2020. Since April 2020, the Crofton Paper plant has been operating at 25% capacity and Port Alberni at 75% capacity. Howe Sound was scheduled to shut down indefinitely this October, however, Government action (see below) averted that closure. The other two operations (Skookumchuck and Crofton Pulp) are fully operational.
