- In 2001, Kent designated the Teacup Properties (comprised of four privately-owned parcels) as a Residential-Reserve Area. The lands became part of its Gateway Neighbourhood Plan.
- In 2005, the ALC formally declined to endorse the Gateway Neighbourhood Plan.
- In 2014, Kent identified the Teacup Properties as important to the community's future housing needs and subsequently included those lands in its 2014 Official Community Plan (OCP) as an area for mixed-use single and multi-family development. While no exclusion application was made, the ALC reviewed the OCP and reiterated its view that the proposed housing development was inconsistent with the ALCA.

- In 2017, Kent made a formal application to the ALC to “swap” two properties. It proposed excluding a single 14.1-hectare parcel of the Teacup Properties from the ALR in exchange for adding a 40.8-hectare portion of a 59.2-hectare parcel of agricultural land to the reserve.
- The exclusion application was denied by the ALC, while the inclusion application was given conditional approval. A request to reconsider the decision was rejected because the proponent was unable to offer any new evidence that had not been considered in the original application.
- In 2020 (following a 2019 site visit and discussions with the ALC), Kent made a new exclusion application to the ALC. It again proposed a land swap but proposed excluding 17.4-hectares (comprised of four parcels) from the ALR in exchange for including a 40.8-hectare portion of a 59.2-hectare parcel.
- In 2021, the ALC rejected the application in 2021 and subsequently declined a request for reconsideration because the District was unable to present any new evidence that had not been considered in the 2020 application.
- While the request to include 40.8 hectares in the ALR was given conditional approval, that parcel remains outside the ALR until such time that the landowner informs the ALC that they wish to proceed with a formal inclusion.

- While the request to include 40.8 hectares in the ALR was given conditional approval, that parcel remains outside the ALR until such time that the landowner informs the ALC that they wish to proceed with a formal inclusion.

Here's today's stakeholder report:

Mayor Blair Ireland (District of Lake Country), Mayor Tom Dyas (City of Kelowna), Chief Robert Louie (Westbank First Nation), Mayor Gord Milsom (City of West Kelowna), Mayor Patrick Van Minsel (District of Peachland), and Chair Loyal Wooldridge (Regional District of Central Okanagan) – a letter to PDE, MBM, MLP, MPA, MBB, MBR, and MAK regarding the Premier's Emergency Task Force. They identify 4 key concerns: Emergency Support Services reviews, decision-making matrix

for Provincial Orders, assessing the community impact of wildfires, and financial aid for businesses. They welcome advice as to how they can best participate to bring the voices of the Central Okanagan to the Task Force. We will coordinate a handling plan with the addressed ministries and acknowledge once confirmed.

Sidney Anglers Association – a letter to PDE regarding the importance of the Cowichan Lake and River to wild fish stocks and urging that the Province assume the water license and take responsibility for completion of the building of a new, higher weir. We have received many similar incomings recently and WLRS is responding to stakeholders. We will refer and acknowledge.

Mayor Sylvia Pranger (District of Kent) – a letter to PDE following-up on UBCM meeting. We will acknowledge.

Laryngectomy Association of British Columbia – a letter to PDE regarding the need for expanded coverage of voice prostheses, Heat and Moisture Exchangers and other devices for laryngectomees. They attach a submission to HLTH and request a meeting with PDE. We will sort to Scheduling.

Mosaic Forest Management – a letter to MBR requesting reconsideration of how Notice 102 is implemented on BC coast. They note that they have dropped their Federal Court application for Judicial Review in response to DM Richard Manwaring's suggestion that this would enable discussion. We will file.

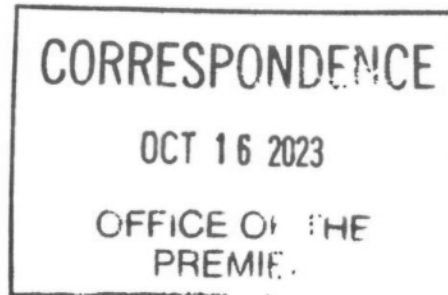
