INVESTIGATION INTO ALLEGATIONS OF BULLYING AND HARASSMENT

AGAINST RICHARD ROSENTHAL CHIEF CIVILIAN DIRECTOR BC INDEPENDENT INVESTIGATIONS OFFICE

Submitted to BC Public Service Agency by Investigator Christopher Sullivan I was appointed by the BC Public Service Agency to conduct an investigation into allegations of bullying and harassment against Richard Rosenthal, Chief Civilian Director (CCD) of the Independent Investigations Office (IIO).

The details of my appointment are contained in the following terms of reference:

Terms of Reference

Whereas allegations of bullying and harassment of employees in the Independent Investigations Office (IIO) against the Chief Civilian Director (the respondent) have come to the Deputy Attorney General of the Ministry of Justice's attention; and,

Whereas the Deputy Attorney General has requested that the Deputy Minister of the BC Public Service Agency formally determine whether, or to what extent, bullying or harassment may be occurring at the IIO;

The Deputy Minister of the BC PSA has engaged Chris Sullivan (the investigator), an independent third-party expert in employment and labour law, to conduct an investigation into the allegations.

In conducting the investigation, the investigator will comply with the following terms of reference:

- The investigation will focus on the alleged inappropriate conduct of the respondent. Any issues not specifically related to the personal conduct of the respondent, such as, but not limited to, the policies, procedures or mandate of the IIO, are outside the scope of the investigation;
- The investigation shall be conducted in a fair, objective, open-minded and independent manner;
- Subject to these terms of reference, the investigation process shall be determined by the investigator;
- The investigation will include interviews of any relevant complainant(s) and witnesses that the investigator determines necessary and a review of any documentation/evidence gathered by the investigator during the process;

- The respondent will also be interviewed and will be given the opportunity to respond to any allegation that may form the basis of a finding of the investigation;
- The investigation report will include conclusions based on findings of fact and determinations of credibility and will be submitted to the Deputy Minister of the BC PSA.


Upon the conclusion of the investigation, the Deputy Minister of the BC PSA will assist the Deputy Attorney General in determining the appropriate response to the above-referenced allegations based on the findings and conclusions made by the investigator.

Dear Mr. Rosenthal,

Allegations of bullying and harassment of employees in the Independent Investigations Office (IIO) have come to the attention of Richard Fyfe, Deputy Attorney General of the Ministry of Justice. As I have responsibility under the *Public Service Act* for personnel management and maintaining occupational health and safety programs in the public service, Mr. Fyfe has asked me to formally determine whether, or to what extent, bullying or harassment may be occurring and, if so, what steps may be necessary to ensure the IIO's compliance with the applicable *Workers Compensation Act* rules and regulations.

While there may have been a preliminary review(s) of this matter by the Ministry of Justice, it is my understanding that no determination has been made as to the merits of the allegations.

Mr. Fyfe has indicated to me that you were made aware that he was asking for my assistance and that you had requested to meet with me before the BC Public Service Agency engages in any formal process. I accept this request and will ask my office to get in touch with you to set up a meeting soon s.22

In the meantime, given the sensitivity of the allegations that have been made, I would ask for your cooperation in ensuring that the management of the IIO refrains from taking any disciplinary or related action against employees covered by the *Public Service Act* until we have the opportunity to meet. If a pressing employment-related issue develops prior to our meeting that you feel requires immediate attention, please contact John Davison, Assistant Deputy Minister, Employee Relations, at 250 356-3090 to discuss what action, if any, needs to be taken.
