s.22, and I wanted to let you know that we have a good first draft of the Rec 30 Report, and will need a few more days to review/finalize before sending it to you.

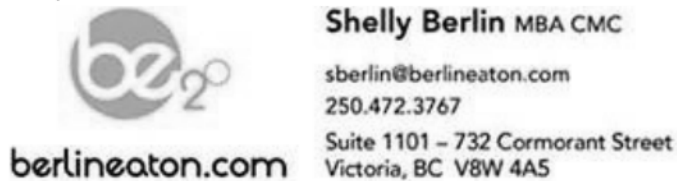
We were wondering if you're okay with the following next steps:
