Hi All,

It is with decidedly mixed emotions that I am writing you to tell you that Dave Nikolejsin is leaving the Public Service, effective June 5. Dave and I have been discussing this for the last little while, and it seemed like the right time for Dave to move on.

One almost doesn't know where to begin in writing an appreciation of Dave. He is this passionate ball of energy that is going 100 miles an hour, with ideas being spun out at rapid pace, almost always in a very colourful way. Everybody around the DMC table has their Dave Nik imitation, generally starting something like, "Well, that just b....."

But beneath the rough and ready exterior, lies a very big heart. He cares for his people. And he cares for the everyday people of British Columbia, indigenous and non-indigenous alike. He was the Provincial CIO, then went on to the Environmental Assessment Office and then various DM positions as EMPR got separated into two ministries and then recombined. I won't recount all of Dave's achievements over the years, but I would be remiss if I didn't mention one. I sincerely believe LNG Canada's positive FID in October 2018 – the single biggest private sector investment decision in Canadian history – would not have happened without Dave's tenacious work to bring things together.

I could go on, but I am sure you all have your own Dave Nik stories.

Please join me in extending our very best wishes for him in his next endeavours. I don't know what they will be, but I am pretty sure Dave is not a golf and puzzle guy.
