Dear Patti:

This letter confirms your appointment as Assistant Deputy Minister, Child Care, Ministry of Education and Child Care, pursuant to s. 12 of the *BC Public Service Act*, as specified in your appointing Order in Council, effective June 20, 2022.

Your salary will be \$185,000 per annum, consistent with an Assistant Deputy Minister 1 in the Executive Compensation Framework. The terms and conditions of employment for Assistant Deputy Ministers are those established for Category A Order in Council appointments.

As you know, we are expected to conduct ourselves in a manner that maintains and enhances the public's trust and confidence in the public service. I know you are familiar with our Standards of Conduct for Public Service Employees (attached) and I trust I can continue to count on your leadership in this respect.

As required by policy and practice, the BC Public Service Agency has been in contact with you to update your personal information for the purpose of the prescribed criminal records check. Also, as required, I have attached copies of the Employment Termination Standards and the Post Employment Restrictions.

On November 1, 2021 the BC Public Service announced the COVID-19 Vaccination Policy that defines the conditions and expectations for BC Public Service employees regarding vaccination against COVID-19. Among other possible measures, proof of vaccination is required. It is a term of acceptance of this offer that you agree to comply with all vaccination requirements that apply to the public service. 
