As such, I find that it would not have been possible for the Narrative to have been before the Commissioner for taking affidavits when the Report was sworn on November 26, 2015. As a result, I find that the Narrative was not properly incorporated into the officer's sworn Report. Therefore, in accordance with case law, I will not consider the Narrative in this review.
