**PURPOSE:** For INFORMATION for Lori Wanamaker, Deputy Minister and Deputy Solicitor General

ISSUE: Status update on response to the Missing Women Commission of Inquiry (MWCI) recommendations for meeting with First Nations Chiefs September 8-10, 2015

#### SUMMARY:

- On December 17, 2012, Forsaken The Report of the Missing Women Commission of Inquiry (MWCI Report) was released.
- On December 4, 2014, the Final Status Update Report was released, detailing progress made on the recommendations of the Missing Women Commission of Inquiry. This report built upon government's earlier status report on the Missing Women Commission of Inquiry's recommendations, which was released in November 2013.
- Work on the recommendations is still underway in certain areas, and will continue to be woven into larger government reform and change initiatives (see Appendix A for related initiatives underway).
- Targeted improvements to policing practices, standards, structure and accountability will continue to be prioritized through continued work on MWCl policing-related recommendations and implementation of the BC Policing and Community Safety Plan (BCPP).
- Future work to address issues of safety for vulnerable women and healing/rebuilding will be informed by, and captured under, priorities identified in the Vision for a Violence Free BC strategy.

#### BACKGROUND:

- The Final Status Update Report, released in December 2014, detailed progress made on the recommendations of the MWCI on the major themes: compensation and healing; improvements to policing; safety for vulnerable women; and, supports in missing person investigations. Efforts were focused on the recommendations that are action-oriented.
- Since the release of the report, the following actions have been taken on recommendations under the themes of Compensation and Healing and Safety for

Vulnerable Women (see BN, Cliff # 511827 for update on actions related to policing recommendations):

Identifying Approaches to Healing (3.1, 3.3., 3.4)

- In March 2015, CSCPB provided \$436,580.00 to fund 25 projects to support healing and rebuilding after violence against Aboriginal women.
- In June 2015, the Ministry of Aboriginal Relations and Reconciliation announced a family gathering for families of missing and murdered Aboriginal women to be held this Fall or Spring 2016 (in Prince George). The gathering is intended to provide a safe and supportive place for families to heal together by sharing their stories and their strength. CSCPB was successful in working with the federal DOJ to reassign project funding and is contributing \$50,000 towards the gathering.
- o Compensation Fund for the Children (Rec. 3.2)
  - Individuals (of the total 85 + 13 litigants) the Ministry has not been able to locate. 73 completed application packages have been received from the PGT and payments have been processed. The PGT is continuing to work with 4 individuals to complete their applications.
- o Enhancement of Services for Vulnerable Women (Urgent Measure #1)
  - In March 2015, a total of \$80,000 in CFO funding was distributed to key organizations that provide drop-in and outreach services to vulnerable women involved in the survival sex trade
    - \$40K was provided to Providing Alternatives Counselling & Education (PACE) Society. They received 30K for violence support and prevention support groups and one-on-one counselling and 10K for a sex work community education project.
    - \$40K was provided to Peers Victoria Resource Society. They
      received 20K for a small business training program for people
      in/from the sex industry and 20K to support their drop-in centre
      services.
  - Government is continuing to provide annual funding of \$750,000 to the WISH Drop-In Centre Society to improve services to vulnerable women who work in the sex trade in Vancouver and \$200,000 for the operation of the MAP van.
- Cultural Awareness Training for Justice System Personnel (Rec. 4.12)
  - Ministry staff are continuing to work on the development of justicespecific modules, in partnership with the Provincial Health Services Authority, in the Indigenous Cultural Competency (ICC) training course to support culturally responsive and sensitive services and target cultural competency learning needs for staff working in various areas

of the justice system, including police, courts, corrections, and Crown Counsel. Draft curriculum has been developed and is currently being vetted; pilot process to be completed in Fall 2015.

Expansion of "Living in Community" Model (Rec.5.3)

In March 2015, Living in Community received a \$30,000 CFO grant to work with key stakeholders to support better alignment and/or implementation of policies and practices necessary to reduce levels of violence and harm experienced by individuals engaged in sex work. This funding builds on and supports the \$100,000 grant that was provided to LIC in March 2014 to support interested municipalities in Northern BC and the Lower Mainland to adopt the LIC collaborative community engagement model.

## APPENDIX - Related Initiatives to Address Violence Against Women

• A key priority under VFBC, which aligns with Provincial Domestic Violence Plan commitments, is to work together with Aboriginal partners to address violence against aboriginal women. A key initiative currently underway in this area is the investment of \$1.5M over the next two years to provide direct services for Aboriginal women, men, and children who experience domestic violence. CSCPB is working with MARR and PODV on this initiative. The work will occur through a partnership table of government, non-government and Aboriginal representatives to develop the funding criteria.

- Government also recently provided \$200,000 in grant funding to the BC
   Association of Aboriginal Friendship Centres to enhance and evaluate culturally
   appropriate programs for perpetrators of domestic violence. This work reflects
   another commitment in the Provincial Domestic Violence Plan to provide direct
   services for perpetrators of domestic violence.
- VFBC also commits to working with the MOU signatories (via the Joint Partners Table) on the development of shared priorities and actions required to achieve outcomes in stopping violence against Aboriginal women and girls.
- The priority for the Joint Partner's Table this fiscal year is the family gathering and work to implement the identified actions that result from the gathering.
   CSCPB will work with the Joint Partner's Table to support this work and continue to explore with the Joint Partner's Table and Minister's Advisory Council on Aboriginal Women (MACAW) future priorities for action.
- In March 2015, government announced \$5 million in civil forfeiture grant funding
  to support community-led anti-violence and crime prevention projects, with a
  priority focus on violence against women. Over \$1M was provided to fund 58
  projects focused on supporting Aboriginal communities in their anti-violence and
  prevention initiatives, including:
  - \$30,000 to Carrier Sekani Family Services to create an action plan that addresses the issue of violence against young women and girls in the Burns Lake area.
  - \$30,000 for the Northern First Nations Child and Family Services Council Society to raise awareness around the issues of child abuse, family violence and the sexual exploitation of girls.
  - \$30,000 to help the Pacific Association of First Nations Women train front line service providers who work with Aboriginal women who are victims of violence, or at risk of experiencing violence.
  - More than \$27,000 for a 16-week program, run by the Haida Gwaii Society for Community Peace, for men who have used abuse in their intimate partner relationships.
