1.01 General

Model aircrafts and unmanned air vehicles (UAV), including remotely piloted aircraft systems or drones, jeopardizes the correctional centre by having the ability to deliver contraband, conduct unauthorized surveillance and create malicious damage.

1.02 Sightings

Any sightings of a model aircraft or unmanned air vehicle on correctional property are reported to SSP and the assistant deputy warden of operations immediately.

1.03 SSP responsibilities

SSP will attempt to locate the aircraft or air vehicle, and the operator via DVMS. Additional staff may be assigned to SSP to assist in the video surveillance.

SSP operator notifies the assistant deputy warden of the results of the searches. Sighting and searches are documented in the SSP log book.

1.04 Assistant deputy warden responsibilities

The assistant deputy warden notifies the warden and RCMP (if warranted) and collects any evidence.

Any privacy breaches are reported the Office of the Chief Information Officer (OCIO).

In the event of an emergent crisis, the command centre is initiated.

The assistant deputy warden of regulations completes a significant incident report and ensures any responding staff complete an incident report.

UNMANNED AERIAL VEHICLE (UAV) or "Drone"

1.01 OVERVIEW

An Unmanned Aerial Vehicle (UAV) or "Drone" is defined as "an aircraft without a human pilot aboard. Its flight is controlled either autonomously by onboard computers or by the remote control of a pilot on the ground or in another vehicle".

UAV or DRONE can also be referred to as a Remotely Piloted Aircraft (RPA)

1.02 PROCEDURE FOR STAFF PRESENT AT INCIDENT AREA

If, during the course of an officer's duties, the officer encounters a drone while transporting or monitoring an inmate or group of inmates, the officer should proceed as follows (if possible):

PROCEDURE FOR CONTROL STAFF

While working as a control officer during an incident involving a drone:

- When Code Yellow is called by staff follow normal procedures (locking up units, etc.). Have control runners respond to scene.
- When notified that a drone is present for the Code Yellow (not a fight, assault, etc.), contact RCMP to respond to the correctional center.
- Control staff located in control should try to follow the drone with cameras (if cameras can be moved) if at all possible. If not, try to record which cameras catch the drone at which times. Bookmarking can be facilitated by the CS Disciplinary Coordinator when an investigation is initiated.
- Fill out necessary Incident Report form(s).

PROCEDURE FOR CS OPERATIONS

While working as the CS operations during an incident involving a drone:

- When Code Yellow is called, staff will respond to the incident area.
- When arriving on scene determine the nature of the code (if a drone is involved or not).

DRONES

Definition of Drones

Drones are more formally known as unmanned aerial vehicles (UAV). Essentially, a drone is a flying robot. The aircraft may be remotely controlled or can fly autonomously through software-controlled flight plans in their embedded systems working in conjunction with GPS. UAVs have most often been associated with the military but they are also used for search and rescue, surveillance, traffic monitoring, weather monitoring, firefighting and used for dropping off contraband at Jails, among other things.

1.01 Reporting

In the event of a Drone being reported or witnessed on or near NFPC property, Central Control will be notified immediately. Central Control will contact the ADW of Regulations or designate immediately and provide them with the location and number of Drones.

1.02 Roles and Responsibilities

ADW - Regulations or Designate
