ISSUE

To advise senior management of an armed robbery of the Shell gas station on North Road in Burnaby that led to the arrest of Dean ZASTOWNY. The arrest is likely to draw significant media attention.

BACKGROUND

On Tuesday December 5, 2017 at about 2212 hrs the Shell gas station located at 4191 North Road in Burnaby was robbed at knife point. The suspect produced a knife that was described as having a three inch blade and went behind the sales counter demanding the money from the clerk. He took \$60 in cash from the register as well as a strawberry Danish and a coffee. He then fled on foot. There were no injuries.

Burnaby RCMP along with PDS attended and Coquitlam RCMP set up quadrants. A description was broadcast to surrounding police agencies. At about 2217 hrs GVTAPS Police located the suspect at the Lougheed Mall Skytrain Station and took him into custody without incident. The suspect was identified as Dean ZASTOWNY s.22 who is believed to be responsible for several LMD robberies and was recently accidentally released from Surrey Pre-Trial s.22

Dean ZASTOWNY is currently in Burnaby Detachment cells and will be facing one more count of robbery.

On December 2, 2017, at 1535 hours, Surrey Pre-Trial reported that Dean ZASTOWNY was inadvertently released from custody while remanded. s.15

ZASTOWNY was being held on charges of theft, PSP. ZASTOWNY is listed at **ARMED and DANGEROUS** and is charged with multiple counts of robbery. Charges are being sought against

ZASTOWNY for being unlawfully at large and obstruct justice.

ZASTOWNY is believed to be responsible for a bank robbery in Ridge Meadows today (photos above). Although ZASTOWNY stated he had a gun, one was not observed (*Ridge Meadows RCMP file 2017-27803 refers*).
