After attending the CA Seminar here in Victoria this week, Thursday afternoon the CAs will be coming by their respective Minister's offices to drop off their travel claim forms (see attached word document). I think Bev Bowen sent you the breakdown of how the seminar will be expensed but I wanted to attached it again for your information and you may need to help the CA with the form when they come to the office.

I will be giving them all blank printed forms at noon tomorrow and explaining how to fil them out, but they still may need your support.

If there is only one CA from your minster's constituency at the seminar – that person will be claiming the hotel for October 24 and 25, and an all day per diem (\$61.00) for October 25 on their "accompanying" claim form – copy attached. The rest of that CA's travel needs to be filled out on the 2017 Constituency Assistant Travel Claim form (also attached).

If there is a second CA from your minster's constituency at the seminar – that person will be claiming the <u>whole</u> thing: all travel/mileage, hotel for October 22/23/24/25 and meal per diems during travel time to Victoria and return, as well as full per diems (\$61/day) for October 23, 24 and 25. This is all to go on a 'accompanying' travel claim form as well.

Dear Legislator, Lawmaker and/or Policy Writer,

I am writing to urge the B.C. government to encourage and support currently illegal cannabis operations to shift to the legal landscape come July 1, 2018.

This would apply to all areas of the industry, including growers, processors and sellers.

Urging cannabis businesses to legalize their operations is crucial in reducing the existence and prominence of the black market during the legalization process, and to ensure taxes are being collected that can positively contribute to the province of British Columbia.

Regulation of cannabis is going to be the key to successful legalization. Encouraging and supporting illegal operations to become legal, and thus regulated, is the only way to achieve as close to 100 percent regulation in B.C. as possible.

We know from studying US markets that when the existing industry has been included, the legal regime has had better consumer buy in and acceptance, and has become a valuable part of the economy. When it has not been widely included as in Washington State, the black market is thriving and impacting the regulated system.

A transition of BC's existing cannabis industry is critical to economic stability for the province, and for success of the regulated market. If the black market remains, many current and future marijuana users will continue to turn to illegal operations, hindering the potential success of legal cannabis businesses and the resulting tax collection.
