

Chrystal,

This should actually be a reply from BC Wildfire Service instead of our minister. The Pressy Lake issues are part of the overall Elephant Hill fire event and BC Wildfire Service were in command of the response including the structure protection crews. The OFC acquired various resources (Structure Protection Units, crews and Structure Protection Specialists) but once on scene they fall under and report through the BCWS incident command system.

For background;

- The initial requests for information from residents came in while firefighting efforts were still in progress and crews still deployed in the field. Early responses to inquiries indicated that information around what structures had been actioned or not was not yet in our possession and that ultimately the notes etc would be held by BCWS, which is why we were not able to provide information.
- There have been some FOI requests made for information (being processed through the system).
- There have also been legal claims initiated and as such it is also a legal file which BCWS is managing which further complicates the issue.
- Stephen Gamble was brought onboard by BCWS to field calls and inquiries from residents. I am aware that he has responded to many such inquiries although unknown if this person is one of those.

I recommend this response be forwarded to BCWS for response.
