THIS FIRE IS THE RESULT OF AN ELECTRICAL SHORT CIRCUIT CAUSED BY A ROCK BECOMING CAUGHT IN BETWEEN A FRAME SECTION AND A POWER (BATTERY) CABLE. THE ROCK WORE THROUGH THE INSULATION ALLOWING THE BARE WIRES TO COME INTO CONTACT WITH THE TRUCK FRAME WHICH IN TURN CREATED A HEAT SOURCE FOR COMBUSTIBLE MATERIAL TO BE IGNITED.
