- <!--[if !supportLists]-->• <!--[endif]-->Important details like the traffic conditions at the time, the presence of pedestrians, whether drugs or alcohol were involved all of those will be provided by police and considered by the superintendent of motor vehicles, along with the driver's record over the past five years.

What kinds of things will RoadSafetyBC be considering in deciding how long to pull a dangerous driver's licence?

- <!--[if !supportLists]-->• <!--[endif]-->They'll be looking at why the driver was stopped and the risk factors at that time – everything from whether the roads were wet and traffic was heavy, to whether the driver was speeding, drinking, drug-affected or had passengers in the vehicle.
- <!--[if !supportLists]-->• <!--[endif]-->Those factors, as well as the driver's abstract for the past five years, will inform the length of the driving prohibition.

what's the process? Does their licence get suspended right away, or does RoadSafetyBC contact them at a later date.

<!--[if !supportLists]-->• <!--[endif]-->Under this new model, which comes into place Dec 1, police will complete a High-Risk Driving Incident Report to initiate a review by the Superintendent of Motor Vehicles, to determine whether the risk to public safety warrants immediate intervention. The Superintendent will consider the incident in its entirety -including incident details, the driver's behaviour and the entirety of the driver's five-year driving record. If the Superintendent is satisfied that the driver is an immediate risk to public safety, the Superintendent will issue a Notice of Prohibition in order to immediately intervene and ensure public safety by removing the driver from the road as swiftly as possible. Most prohibitions are generally between three and 36 months in length.

Also, what's the appeal process? If a driver requests a review of their penalty, does their licence remain suspended until a decision is made?
