Under the *Police Act* (BC), the Minister of Public Safety and Solicitor General must ensure that an adequate and effective level of policing and law enforcement is maintained throughout British Columbia. The Minister of Public Safety is responsible for setting the objectives, priorities and goals of the Provincial Police Service which is the Royal Canadian Mounted Police (RCMP). Day-to-day deployment of police services falls to the RCMP or the jurisdiction's municipal police force. Please note that individual investigations and enforcement decisions occur at arm's length from government and the Minister of Public Safety and Solicitor General cannot interfere with or direct police on such matters.

The Province has made significant investments in the Combined Forces Special Enforcement Unit of British Columbia (CFSEU-BC), which is the province's anti-gang police agency. The CFSEU-BC is the largest integrated joint force police unit in Canada. The CFSEU-BC's mandate is to target, investigate, prosecute, disrupt and dismantle the organized crime groups and individuals that pose the highest risk to public safety.

Dear Minister Farnworth,

The newly elected Mayor of Surrey, Doug McCallum, is attempting to dump the RCMP and set up a new City of Surrey police department. He has never given an acceptable reason for his decision to replace the RCMP.

Mr. McCallum was inaugurated in as the Mayor of Surrey on the evening of Monday, November 5th, 2018. Twenty minutes after assuming the position as mayor of Surrey he and Council members voted unanimously to get rid of the RCMP.

It concerns me that there was not the opportunity to debate the issue of removing the RCMP and establishing a new city police department (other than casting a ballot in the October 20th election).

I have phoned Surrey City Hall in an attempt to find out the costs involved to get rid of the RCMP and set up a new city police department. No one at City Hall has been able to tell me the costs involved or the estimated annual cost of operating a city police force compared to the current RCMP. I am concerned that a large waste of tax dollars will occur in getting rid of the RCMP and establishing a new city police department. Mayor McCallum won his mayor's position with only 41% of votes cast by Surrey voters. Council members won their council positions with a much lower percent of votes cast on Oct.20th.

Mayor McCallum and the Council clearly do not represent the majority Surrey residents. I understand this was an election promise but nobody in their right mind is giving the mayor a blank cheque. Before anything is approved by your office I would hope that all financial information be disclosed to you and the tax payers of Surrey.

Is there anything you, as Minister of Public Safety and Solicitor General of BC, can do to ensure that I and the citizens of Surrey, can have a voice in the decision to rid Surrey of the RCMP and to establish a new-city police department?

I am disheartened to learn that the over 400 traffic cameras the City of Surrey operates are generally useless for public safety. They are pixelated to the point that the police cannot even read a licence plate from them. There were over 6 cameras that could have tracked the individuals responsible for s.22 murder. As a victim of crime in Surrey and a taxpayer I find this unacceptable.

Private property uses HD CCTV, you are filmed at the airport, ferry terminal, borders, why then not at an intersection? ICBC operates red light cameras, I assume those are HD so that the licence plate can be read. Treo took your licence plate and car make and colour through photographs, these are public places. Is accountability only reserved for financial gain? Is a human life and public safety really that meaningless to society? If you are doing nothing wrong, why would it matter? The technology is there and is used in many urban settings around the world. The events of 9/11 demanded an increase in public safety and surveillance. Why then, would you deny the police the tools they need to track and catch criminals and keep our community safe? Why do the criminals always have more rights than we do as law abiding citizens? Why do my sons need to fear for their safety?

The City of Surrey has failed my family, and I cannot accept this. **s.2** should still be here. Please refer to the attached comments from the City of Richmond dated October 31,2017 regarding a Report to Committee on CCTV for Signalization Intersections in Richmond.

"Traffic Camera System versus the CCTV Camera System Discussions between the Detachment and Transportation also revealed significant differences between camera system requirements of one department over the other. As stated earlier the City's purpose for the existing traffic cameras is to detect vehicles, manage traffic flow and respond to real-time traffic incidents. The RCMP, on the other hand, requires high resolution cameras to reduce crime and assist in criminal investigations. The existing traffic camera system has limitations, which make them not suitable for the

Detachment's intended purposes. For example: • Some cameras do not have time and date stamps;

• Cameras do not display in high definition resolution; • To properly meet traffic camera needs the angle of these cameras face directly towards the traffic lanes. These cameras are designed for only one camera angle and are not mobile as required by the CCTV camera system; and • Current traffic cameras require fiber optic cable which makes installation expensive. CCTV Privacy Regulation and Data Collection The legal regulation of CCTV systems occurs primarily via privacy law. This oversight is provided by offices of the federal and provincial privacy commissioners."

I would like to know what the City of Surrey is going to do about this matter of Public Safety. If you don't give the RCMP the tools they require to solve crime and monitor criminal activity how is a City Police Department going to be any better? I look forward to your response to this matter. My family deserves answers.
