Thanks Mary for the quick response. This leads to a couple additional questions. (And I ask to help out ¹⁹ from LDB) So what I am hearing is that the province will accept applications prior to fully implication of Bill C-45 however no licences can or will be issued. Has there been any discussion on a potential date for the Province to start accepting applications, and if applications are accepted prior to Bill-45 being fully implemented is it safe to assume the province will start doing some of the fit and proper checks up to the Conditional Approval stage. Once Bill C-45 is in force the Province would then inform applicant of the conditional approval and then ask for the council resolution and confirm locations and other criteria they needed for final approval.

This time line is important as Kamloops has a couple of other policies and procedures to get into place to ensure they are ready for the application process.

Question for me: How is LDB approval to retail given? Does it go through the same process?

Hi Dave – I can answer your third question, and have cc'd two colleagues from Liquor Control and Licensing Branch who are better placed to answer the first two.

On question 3, no, Bill C-45 does not have to be fully implemented before the Province starts accepting licence applications. However, successful applicants cannot be authorized to sell cannabis until the date that Bill C-45 comes into force. The federal government has not yet communicated a date, but our best guess is that Bill C-45 will come into force 8-12 weeks after it completes the federal legislative process.
