Reporter says: "I would think someone of her standing would be able to escape quite easily, and therefore I am interested into what means are put into places to prevent this from happening."

### Holding Lines re Meng Release:

- Due to mandatory privacy legislation, we cannot speak to the specifics of a BC Corrections client's case management and supervision.
- We can confirm that probation officers supervise clients in the community by working closely with local police and community partners to ensure offenders comply with the terms of their court-ordered supervision.
- The degree of supervision provided by BC Corrections reflects the risk that the offender poses – essentially, the higher the risk, the higher the degree of supervision.
- If there is evidence that an offender has breached his/her conditions, police or BC Corrections can submit a report to Crown to independently assess whether charges should be approved and proceed to court.

### Surrey Policing:

#### Statement from Mike Farnworth, Minister of Public Safety and Solicitor General:

"People deserve to feel safe in their communities and their neighbourhoods and this violence is absolutely unacceptable.

As the Premier said, we are working with Surrey as they develop a plan for their own police force. Let's be clear. No one is putting up any roadblocks. We are prepared to work with the Mayor – he has to be willing to work too.

A new police force isn't created over the weekend but the Province is committed to working with the city as they move forward. We want to make sure there is a solid plan in place to ensure the people of Surrey have strong policing they can be confident in.

We have also made significant new investments in Surrey in anti-gang programs and enhanced policing and will continue to work to ensure people can feel safe."

### Status of Huawei Chief Financial Officer Meng Wanzhou:

- I can't comment on the matter before the courts.
- I understand that for privacy and security reasons, BC Corrections does not confirm if or where an individual is in its custody.
- But generally speaking, BC Corrections has a long-standing agreement with the federal government. It provides for temporarily housing individuals who have been detained by the Canada Border Services Agency. And these individuals are held in provincial correctional centres at the discretion of federal authorities.

### Cannabis, Driving and the Holidays:

- This is the first holiday season with legal cannabis. Many people may be trying or using it over the holidays, and that's fine – as long as they don't drive afterwards.

- Cannabis DOES reduce your ability to drive safely. Research shows your crash risk increases with cannabis consumption and can be significantly greater if your Blood Drug Concentration is over the Criminal Code limit. Drinking alcohol compounds the impairing effect of even a small amount of cannabis.
- The police ARE ready. Drug-affected driving isn't new – police have the tools and skills necessary to detect drivers who are unsafe due to any kind of impairment, and take them off the road. If anything, the additional police training that has accompanied legalization has only increased their ability to stop drug-affected drivers.
- The police ARE out there. Counterattack is underway now, and next year, funding for enhanced police enforcement will rise dramatically.
- Mandatory alcohol screening IS legal in Canada beginning Dec. 18. If you're affected by alcohol, or any substance, and you're driving, you should expect greater scrutiny.
- The penalties ARE serious. Beyond recent changes to the Criminal Code, we're toughening provincial sanctions. On Oct. 17, 2018, we extended B.C.'s zero-tolerance restriction for the presence of alcohol to cover the presence of specific drugs, such as THC and cocaine, for new drivers in the Graduated Licensing Program (GLP). And in spring 2019, we'll be providing police with more tools to remove drug-affected drivers from the road for 90 days – a much more serious sanction than the existing, 24-hour driving prohibition.
- You CAN take it with you – but there are rules about transporting cannabis in a vehicle. You're probably aware that nobody is allowed to have open alcohol or consume it in a motor vehicle. The same goes for medical and non-medical cannabis. Cannabis in its original, sealed packaging can be stored anywhere in a vehicle. But if it's unsealed, it has to be out of reach of the driver and passengers – for example, in the trunk.
- However you choose to celebrate this season, plan ahead for a safe ride home – with a friend, by cab, or via a program like Operation Red Nose, which has volunteers in 19 B.C. communities ready to drive you home if you feel unfit to do so for any reason.
- Please, help us ensure safe and happy holidays for everyone.
