Specifically, reporter was hoping to speak about any projects that are in the North. There is only one project on the North Coast as part of Intake 4 - Gitga'at First Nation

#### Gitga'at First Nation – Hartley Bay Tsunami and Flood Risk Assessment

Total Project Value: \$149,000  
Federal: \$74,500; Provincial: \$70,500; Gitga'at First Nation: \$4,000  
Project Start Date: May 1, 2018 (1 year project)  
This project conducts a flood/coastal inundation risk assessment for Hartley Bay, British Columbia.

This project consists of conducting a flood or coastal inundation risk assessment for Hartley Bay, BC. Hartley Bay, the home of the Gitga'at people, is a remote community that lies about 90 miles southeast of Prince Rupert. About 160 Gitga'at people live in Hartley Bay; there are about 60 homes and several community buildings. Because of its remoteness, emergency planning and response is vital – help could be many hours away.

Hartley Bay is at risk from coastal flooding associated with tsunamis generated by terrestrial or sub marine landslides. A 2012 DFO study described a historic sub marine landslide that would have generated a tsunami with a maximum amplitude of 15 metres and conditions exist for similar tsunamis in the future. A tsunami of this size has the potential to destroy the village of Hartley Bay. There is also flooding risk from a landslide into the lake above the village.

#### Key Messages:

- A 7.0 magnitude earthquake occurred near Anchorage Alaska at around 9:30am this morning. A 4.9 magnitude aftershock near the same location was recorded around 11:30am
- At this time, there is no risk of a tsunami in B.C. A Tsunami warning for coastal areas of Cook Inlet and Southern Kenai Peninsula has been rescinded.
- We will continue to share what we know via our online channels at Emergency Info BC.

**This event is an important reminder of the risk of both Tsunamis and Earthquakes in B.C.**

**In the event of a tsunami warning in BC:**

- If you live in a coastal area, it is important to get to high ground as soon as you feel an earthquake with strong, sustained shaking. The earthquake *is* a tsunami warning. And always follow instructions from local emergency officials.
- B.C. receives notification of a potential distant tsunami from the U.S. National Tsunami Warning Center. All information is then assessed by federal and provincial emergency officials and technical staff to determine if there is a threat to coastal BC.
- If a tsunami threat is identified, Emergency Management BC will activate the Provincial Emergency Notification System (PENS), which notifies local communities and agencies with information on alert levels for the province's five tsunami zones. Each zone includes all islands and inlets within it. What zone are you in? Emergency response plans are implemented at the local level as required.
- Throughout the event, official tsunami emergency warnings and information will be broadcast by radio, television, telephone, text message, door-to-door contact, social media, weather radios and/or outdoor sirens.

**In an earthquake:**

- If you feel shaking, remember to avoid panic. If you think ahead and have a plan and emergency kit in place, you will have gone a long way toward helping yourself and your family in case of a major quake. Here are some tips on preparing for an earthquake and what to do during one.

If you feel an earthquake, remember to immediately DROP, COVER and HOLD ON. Do this every

- **DROP** down onto your hands and knees. This position protects you from falling but allows you to still move if necessary. If you are in a wheel chair, move to an inner wall if it's safe to do so, lock the brakes and cover your head.
- **COVER** your head and neck under a sturdy table or desk. If there is no shelter nearby, only then should you get down near an interior wall (or next to low-lying furniture that won't fall on you), and cover your head and neck with your

arms and hands.

- **HOLD ON** to your shelter (or to your head and neck) until the shaking stops. Be prepared to move with your shelter if the shaking shifts it around. Look around you for hazards like falling debris and shattered glass and shield yourself.
- Wait for the shaking to stop and then **COUNT TO 60** to allow objects that may have shifted during the shaking to settle, cautiously come out of your safe DROP, COVER, HOLD ON location.
- If you are inside a building when the shaking starts, you will not be able to move more than a few steps before dropping, covering and holding-on. Stay indoors until the shaking stops and then assess what to do next. New hazards, such as broken glass, gas leaks or downed power lines may be present. It may be safest to stay where you are.
- If you are outdoors when the shaking starts, you should find a clear spot away from buildings, trees, streetlights and power lines, then drop, cover and hold on.
- If you are driving, pull over to a clear location, stop and stay there with your seatbelt fastened until the shaking stops. Once the shaking stops, proceed with caution and avoid bridges or ramps that might have been damaged.
