I apologize for being unavailable as of late, but I have had numerous issues to deal with both in and out of office. I will address your concerns below.

- 1) I am addressing the issue of providing false information utilizing my name or any RCMP member at this detachment. I will contact \$.22 when I require further information.
- 2) Our detachment does not actively select or call a specific tow provider unless a client requests a ceratin provider. We advise our dispatcher that a tow is required at a collision or seizure scene. They in turn contact an independent call centre who has a list of ICBC registered tow providers. This call centre calls the available tow company for the service. The selected company must be approved by ICBC or the company will not be reimbursed for their services. If ICBC does not approve a tow company, the company will not be used. If \$.22 loses his ICBC approval, he will no longer be used by the RCMP. I am currently reviewing all service providers with the appropriate agencies to ensure that all meet the required standards.

All traffic or insurance infractions resulting in a fine or impoundment is reported to ICBC. Our detachment members are well aware of all driving complaints, and will take appropriate action if a driving infraction is observed or reported.

I have received numerous calls regarding wildfires in the Okanagan particularly the Good Creek wildfire on Okanagan Mountain where the disastrous fire of 2003 occurred. The email below is one of many that sums up the general comments surrounding the fires.

I drove to Penticton yesterday AM at 9:30 and saw 11 fires. They were all just wisps of smoke at that time so I feel that one drop on each might have done the job. The bombers did not fly for the first time until 9:30 and I don't know where they went because by then I was in Penticton. I do have forest fire experience as does one of my daughters and I think that if initial drops had been done on each small fire, they might have gotten them. I think the forest service may have made errors in judgement and a debriefing should be done and the way they prioritize air cover be put under scrutiny.

I am asking for you to look into the current procedures for the expediential combating of wildfires in our region.
