Nimmi, attached is the second SOLE in place in the Province. It has been in place since December 3rd or 4th (see the Global news article at the link below) as the result of a boulder that fell in November.

You can easily see how many SOLEs are in place in BC by looking at the EMBC Update that is sent out every morning. The SOLEs are tallied in the table under the heading, Provincial Totals (excerpt from this morning's below). In that table, BCR stands for Band Council Resolution, which serves as a similar tool in indigenous communities. The BCR below has been in place since May or June and requires no action from Government. SOLEs result in evacuation orders; evacuation alerts are in place to caution residents of a hazard not deemed to pose an imminent or likely imminent threat to life safety— residents are not required to evacuate under an alert.

SOUTHEAST REGION (SEA)

Central Kootenay Regional District – Evacuation Alert remains in place for eight homes in Castlegar due to a landslide that occurred in Bloomer Creek in May.

CENTRAL REGION (CTL)

Columbia Shuswap Regional District – Landslide. A SOLE (extension expires Jan 19th) and an Evacuation Order remain in place to prohibit entry to homes destroyed by landslide in early April.

Columbia Shuswap Regional District – Evacuation Alert remains in place for 4 addresses in the Vicker's Trail and Robinson Creek areas due to flooding concerns.

Thompson Nicola Regional District – Evacuation Alert remains in place for Spences Bridge area pending confirmation that flood remediation work is complete.

Nooaitch Indian Band – BCR remains in place to support an evacuation Order for homes rendered uninhabitable during spring freshet flooding.

SOUTHWEST REGION (SWE)

District of Kent – Rockslide. A SOLE (extension expires Jan 18th) and an Evacuation Order remains in place for six properties that lie below steep terrain in the area of concern. The District is coordinating a thorough geotechnical assessment. Three couples (6 people) are receiving ESS. The SOLE and ESS will continue until pending further assessment.

No significant incidents of note.

Dear Minister Farnworth,

Thank you for your reply. I appreciate that you took the time to read my submission.

If I could make one request, it would be that you look into the the process for having health professions added to the restricted substances prescribers list.

I have had the opportunity to chat with many patients, physicians and people in the industry and I firmly believe that the legitimate medical cannabis user is going to be left unserved, with many medical professionals directing patients to use the legal access for recreational cannabis as an easy answer. I do not believe that these patients will be well

served and many patients, which could potentially be helped, will not get the guidance they need. This is exactly what I am seeing in supplement and health food stores where patients will be given medical advice by individuals that, while well intentioned, have absolutely no medical training. I see this scenario developing with cannabis.

The provincial government can facilitate this process by making a request to the Federal Minister of Health that a profession be added and submitting the relevant legislation.

Naturopathic Physicians in BC do have the scope of practice that would support this request. The College of Naturopathic Physicians worked closely with the College of Nurse Practitioners with regards to prescribing authority and our legislation and scope of practice mirrors theirs very closely. They have been added to the restricted substances prescribers list along with midwives and podiatrists.

Thank you for your email dated October 30, 2017, in which you express your thoughts and views regarding how the regulation and distribution of medical cannabis may be affected by the upcoming legalization of non-medical cannabis in July 2018.

Although the proposed legislation set out in the *Cannabis Act* provides for provinces and territories to regulate certain components of the legal non-medical cannabis regime, it does not provide provinces and territories with authority to regulate medical cannabis as this falls under the existing *Access to Cannabis for Medical Purposes Regulations* (ACMPR), which is administered by Health Canada. Under the ACMPR, an individual may purchase medical cannabis only through Health Canada licensed producers or produce a limited amount for their own medical purposes.

As part of the development of our provincial regulatory framework, the Province conducted a public and stakeholder engagement from September 25 to November 1, 2017. The results from the engagement have been compiled and can be found in the 'What We Heard' report. The feedback provided is being used to inform the development of a provincial regulatory framework. The report is available on the engagement site at: <https://engage.gov.bc.ca/BCcannabisregulation/>.

As you may already know, the Province has announced the minimum age to possess, purchase and consume non-medical cannabis will be set at 19, and the wholesale distribution model will be government-run by the Liquor Distribution Branch. The Province also anticipates establishing a retail model that includes both public and private retail opportunities and will announce further details in late January early February. You may also be interested to know that Health Canada has launched a public consultation on the proposed federal regulatory approach for Bill C-45 (the *Cannabis Act*). The public consultation seeks input on a range of topics, including licensing, security requirements for producers and their facilities, product standards, labelling and packaging, access to cannabis for medical purposes, and health products containing cannabis. All Canadians are invited to share their views on the proposed regulatory approach until January 20, 2018. Health Canada is accepting written submissions or input provided online. The River Forecast Centre is issuing the current advisories and warnings as of 9:30AM, Monday January 29th:

- **Flood Warning (UPGRADED) - Southern Vancouver Island** including the Chemainus River, Cowichan River, Koksilah River and surrounding areas
- **Flood Watch - Eastern Vancouver Island** including the Englishman and Bowser, Parksville, Qualicum, Nanaimo and surrounding areas
- **High Streamflow Advisory (DOWNGRADED) - Eastern Vancouver Island** including Tsolum River, Oyster River and tributaries around Campbell River, Courtenay, and Comox

- **High Streamflow Advisory - Central Vancouver Island** including Sproat River, Somass River and tributaries and areas around Port Alberni
- **High Streamflow Advisory - Western Vancouver Island** including areas around Tofino and tributaries around Sutton Pass and surrounding areas

Heavy rain has impacted rivers on Vancouver Island over the past day. Heaviest rainfall amounts have been on Western Vancouver Island, Eastern Vancouver Island (around Parksville, Qualicum and north to Courtenay) and Southern Vancouver Island (around Lake Cowichan, Duncan and north to Nanaimo).

Rivers have been rising rapidly in response to this rainfall. A summary of conditions as of 9:00AM include:

- Englishman River near Parksville (Water Survey of Canada gauge 08HB002) peaked earlier this morning at approximately 490 m³/s (approaching a 10-year return period flow). Rainfall this morning may slow the rate of decline through Monday
- Tsolum River near Courtenay (08HB011) peaked earlier this morning at approximately 120 m³/s (below a 2-year flow). Flows are expected to remain elevated on Monday, but significant additional rises are not expected
- Sproat River near Port Alberni (08HB008) is flowing at 150 m³/s and slowly rising. The estimated flows on the Somass River are 460 m³/s, and rising at approximately 10 m³/s per hour. Flows are expected to continue to rise through Monday, with a forecasted peak later in the day of approximately 500-600 m³/s, or slightly higher if significant additional rainfall occurs this morning
- Koksilah River at Cowichan Station (08HA003) is flowing at approximately 200 m³/s (2-year flow) and slowly rising. Additional rises are expected through mid-day Monday
- Cowichan River near Duncan (08HA011) is flowing at approximately 440 m³/s (10-20 year flow). This is approaching 2009 flood levels. Continued rises are expected through Monday.

Additional rainfall is forecast through Monday, however rainfall rates and amounts are generally forecast to be much less than was observed on Sunday.

The River Forecast Centre will continue to monitor conditions and update this advisory as conditions warrant.

A **High Streamflow Advisory** means that river levels are rising or expected to rise rapidly, but that no major flooding is expected. Minor flooding in low-lying areas is possible.

A **Flood Watch** means that river levels are rising and will approach or may exceed bankfull. Flooding of areas adjacent to affected rivers may occur.

A **Flood Warning** means that river levels have exceeded bankfull or will exceed bankfull imminently, and that flooding of areas adjacent to the rivers affected will result.

Request:

I'm working on a story on WAVAW Rape Crisis Centre in Vancouver. The centre offers a number of services to victims of rape and sexual assault, including free one-on-one counselling. They used to receive core funding but 12 years ago the government cut that core funding and now they are funded on a program basis, which means their funding from year to year can be uncertain. Also since that core funding was cut, the waiting list for the one-on-one counselling has grown. Currently a victim of rape or sexual assault has to wait 18 months to get counselling through WAVAW, which is the only centre of its kind in the city. It was 24 months not that long ago but a big fundraising push helped bring it down to 18.

Q1: They said they get their funding through the Ministry of Justice, would that be through the Attorney General's office or the Minister of Public Safety/Solicitor General?

A1:

- The Community Safety and Crime Prevention Branch of the Ministry of Public Safety and Solicitor General currently provides approximately \$30M in annual, core funding to support over 400 victim service and violence against women programs across BC. This includes 160 Police and Community-based Victim Service Programs and 240 Violence Against Women Counselling and Outreach Services.
- The victim service programs provide support and practical assistance to victims of crime including safety planning and information about and support through the criminal justice system. Community-based victim service programs specifically assist victims of family and sexual violence.
- The violence against women counselling and outreach services include the following programs:

- **Stopping the Violence (STV) Counselling programs** provide individual and group counselling for women who have experienced childhood abuse, sexual assault and violence in their relationships. There are 94 STV Counselling programs.
- **Children Who Witness Abuse (CWWA) programs** provide group and individual counselling for children ages three to 18 who have witnessed abuse, threats or violence in the home. There are 86 CWWA programs.
- **Outreach Services** help women identify and access the services they need by providing information and referrals, and accompaniment and transportation to other necessary services. There are 55 outreach service programs.
- **Multicultural Outreach Services** provide services to 10 communities in up to 24 languages to ensure immigrant and visible minority women receive assistance by workers who speak their own language and are familiar with their culture.
- The Community Safety and Crime Prevention Branch currently contracts with WAVAW for over \$360,000 annually to provide a Community-based Victim Service Program and a Stopping the Violence Counselling Program. WAVAW has been one of the Ministry's service providers for these services for a number of years.
- WAVAW has also received \$235,000 in civil forfeiture funding since 2011 for various projects addressing issues related to violence against women.

Q2: I am wondering if the new(ish) NDP government has given any thought to reinstating core funding for public service organizations, like WAVAW? Especially in the face of the recent #metoo campaign, which has resulted in an increase in the number of women coming forward to report, and seek help after, sexual assault.

A2:

- Service providers for victims of domestic violence, sexual violence and other violent crimes currently receive annual core funding through the Community Safety and Crime Prevention Branch of the Ministry of Public Safety and Solicitor General.
- This government is committed to ensuring vulnerable women and children get the quality services they need in a timelier manner. However, we also recognize that service providers for victims of domestic violence, sexual violence and other violent crimes have experienced challenges meeting service demands in communities throughout B.C.
- That is why in November 2017 we provided \$5 million in one-time funding to enhance front-line services and address waitlists. The grants are an immediate investment in front-line services for women and children experiencing violence in BC. All current service providers, including WAVAW, received a grant from the Ministry equal to 12.8% of their current contract value or a minimum \$5,000 whichever is greater.
- In addition, the ministry is currently exploring options for strategic investments that will build on work underway to strengthen the services and supports currently provided and address service demands.

Staying Warm

Avoid hypothermia by remembering the acronym COLD:

- Cover: Wear a scarf, hat or toque, mittens or gloves and even a balaclava if necessary.
- Overexertion: Avoid activities that will make you sweat a lot. The combination of wet clothing and cold weather can cause you to lose body heat more quickly.
- Layers: Wear loose-fitting, layered, lightweight clothing. Wool or silk are great choices. Outer clothing made of tightly woven, water-repellent material is best for wind protection.
- Dry: Get out of wet clothing as soon as possible. Be especially careful to keep your hands and feet dry, as it's easy for snow to get into mittens and boots.

Staying Warm

Avoid hypothermia by remembering the acronym COLD:

- Cover: Wear a scarf, hat or toque, mittens or gloves and even a balaclava if necessary.
- Overexertion: Avoid activities that will make you sweat a lot. The combination of wet clothing and cold weather can cause you to lose body heat more quickly.
- Layers: Wear loose-fitting, layered, lightweight clothing. Wool or silk are great choices. Outer clothing made of tightly woven, water-repellent material is best for wind protection.
- Dry: Get out of wet clothing as soon as possible. Be especially careful to keep your hands and feet dry, as it's easy for snow to get into mittens and boots.

You should also know the signs of hypothermia. They include constant shivering, confusion, poor decision making (such as trying to remove warm clothes),

Advice and Recommended Response:

- **The safety of all British Columbians is a priority for government.**
- **Emergency Management BC (EMBC) provides emergency response and recovery support to on-reserve First Nations in British Columbia.**
- **As part of a 10-year agreement with Indigenous Services Canada signed in 2017, EMBC also provides planning, training and public education to on-reserve First Nations communities. These initiatives help improve preparedness and strengthen capacity for disaster prevention, mitigation, response and recovery.**
- **EMBC continues to explore ways to improve the delivery of emergency management services to all residents of B.C., inclusive of First Nations communities.**
- **Responsibility for regular fire suppression, education and prevention is shared between the Federal Government and the local Band Council. This is beyond the scope of the Province's mandate.**

- Although on-reserve fire investigations are not a provincial responsibility, upon the RCMP's request, B.C.'s Office of the Fire Commissioner will assist with fire investigations for fires resulting in serious injuries or fatality.
- Work is underway to establish a federal Indigenous Fire Marshal (IFM) office, and B.C.'s Office of the Fire Commissioner is involved in this process. It is expected that fire prevention and education will be a key element of the IFM mandate.

Background Regarding the Issue:

The BC Coroners Service received a media inquiry for statistics related to Aboriginal victims of residential fire deaths for a story about on- and off-reserve housing. The line of questioning could turn towards the Province's role in closing gaps in fire service, education and prevention between First Nations and non-First Nations lands.

We have several requests about distracted driving, following the release of a law firm report claiming authorities have exaggerated the role of electronic devices in fatal car crashes (included in link below). PDF of Coroners data release included for background.

Draft Statement for MO Approval

Minister of Public Safety and Solicitor General Mike Farnworth:

“Distracted driving is preventable behaviour that has caused too many people and their families to suffer. I understand that fatality statistics vary depending on how agencies measure types of distraction, but frankly, nobody should be dying because of distraction or inattention at the wheel. And focusing only on deaths ignores the pain endured by the thousands of people who are injured every year.

“Research* tells us that you’re 23 times more likely to crash if you’re texting at the wheel and three or four times more likely to crash if you’re on the phone. And police-reported Traffic Accident System data tell us that, over the last several years, distraction and inattention have injured 175 people – a dozen of them seriously – on average each week in B.C.

“At the same time, we know the penalties currently in place haven’t put a significant dent in the amount of distracted driving that police are seeing. Between June 2016 and June 2017, police issued 44,000 distracted driving tickets, which is down just 13% from the same period in 2015/16.

“For these reasons, we’re taking action to make some of the toughest distracted driving penalties in Canada even tougher. The changes we announced last fall mean distracted drivers with multiple distracted driving offences will now face added and higher penalties, over and above their regular insurance premium.”

- Emergency Management BC (EMBC) is the only provincial agency with the authority to use Alert Ready (formally the National Public Alerting System).
- Alert Ready and the BC Provincial Emergency Notification System (PENS) are currently used to alert local governments, emergency response officials and the media of tsunami threats.
- It should be noted that several local governments in B.C. have their own public alerting systems in place, but these local governments do not use Alert Ready or PENS.

I am a rental housing provider (landlord) in British Columbia and I have huge concerns about the impending legalization of cannabis specifically as it pertains to the consumption and cultivation (personal grow-ops) of cannabis in rental housing. I am especially concerned about personal grow-ops in rental housing and the risk they represent.

I am concerned about the negative impact the consumption and growing of recreational cannabis will have on my rental property and how both activities will infringe upon my ability to provide safe housing to my tenants. It is my view that:

- Smoking cannabis should be banned anywhere that smoking tobacco is banned. In addition, landlords should be able to ban the smoking of tobacco or the smoking of cannabis.
- Growing cannabis in multi-unit or rented dwellings is more problematic than cannabis smoking. Concerns include:
 - Safety hazards due to electrical overloading, and excess humidity
 - Interference with other tenants through strong odours
 - Potential liability for the landlord and risk to the tenants and mortgage holder

- Potential cancellation of building insurance or the calling of a mortgage with financially disastrous results for an innocent building owner.

This is a critical issue and I strongly urge you ban cannabis consumption and cultivation in rental housing so that we can continue to provide safe housing to British Columbia families while respecting our rights as property owners too.

A quick note to give you an update on some of the issues we're working on:

- An article was published indicating that the Cariboo Regional District board is "requesting NCLGA and UBCM lobby the provincial government to make legislative or policy changes ensuring local emergency organizations that assist during declared States of Emergency, such as local fire departments and search and rescue teams, receive timely compensation." We're working on an Issues Note to clarify which ministries are involved in the reimbursements for various stakeholders, the policies that drive the reimbursement process, and whether or not there are any ongoing payment issues.
- We received a radio clip from CHNL Kamloops (related to our Information Bulletin from earlier this week on backcountry/avalanche safety) during which the host suggests that fines should be used as a deterrent. We're refreshing an old Issues Note that relates to avalanche support/funding, and we'll include key messaging on the Province's position on financial penalties related to SAR activities.
- An article was published related to remediation work underway in Castlegar related to a previous landslide at Bloomer Creek. The article notes that the city applied to EMBC for funding, but this was not approved. We're working on an Issues Note for this as well.

Further to my previous note, we have received a media inquiry with regards to wildfire recovery support and are working co-operatively with the FLNRORD Communications team on a response.

For your review and approval, please find below the suggested response to clarify EMBC's role with regards to emergency management for on-reserve First Nations and EMBC's role in financial support for wildfire recovery. This will be sent to FLNRORD to be combined with their own messaging on wildfire recovery. This messaging has been approved by Ralph Mohrmann, Johanna Morrow, Monica Cox, Patricia Leidl, and Bob Turner (as Acting DM).

Indigenous Services Canada

- As part of its agreement with Indigenous Services Canada, Emergency Management BC provides emergency management support to on-reserve First Nations in British Columbia.
- However, the *responsibility* and *authority* for emergency management for on-reserve First Nations in British Columbia is with Indigenous Services Canada.
- Emergency Management BC provides financial support for recovery through the Disaster Financial Assistance program.

Disaster Financial Assistance

- As fire losses are insurable for all homes, farms and businesses in B.C., Disaster Financial Assistance is not available for individuals, small businesses or farms. Fire insurance for homes, farms and businesses is reasonably and readily available across the province.
- Nevertheless, local governments and First Nations are eligible to receive financial assistance from the Province and from the Government of Canada to help rebuild any essential public infrastructure damaged by wildfires. Emergency Management BC has received applications from seven First Nations related to the 2017 wildfire season and is working closely with these applicants to complete their recovery plans. No claims have been received or paid to date.

General

- The Province has provided \$100 million in funding to the Canadian Red Cross for wildfire relief. These funds assist individuals and families that were affected by wildfires, as well as community groups. They also support First Nations cultural livelihoods that support communities.
