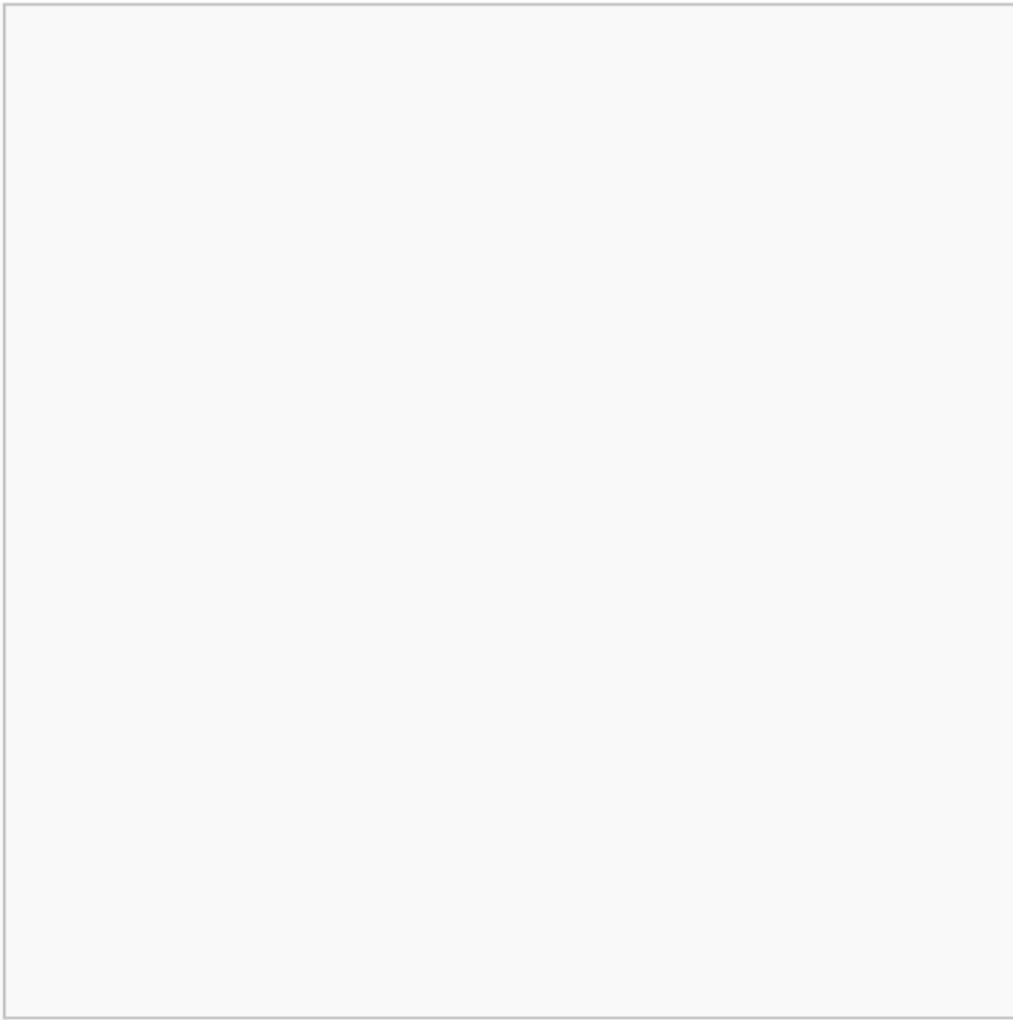

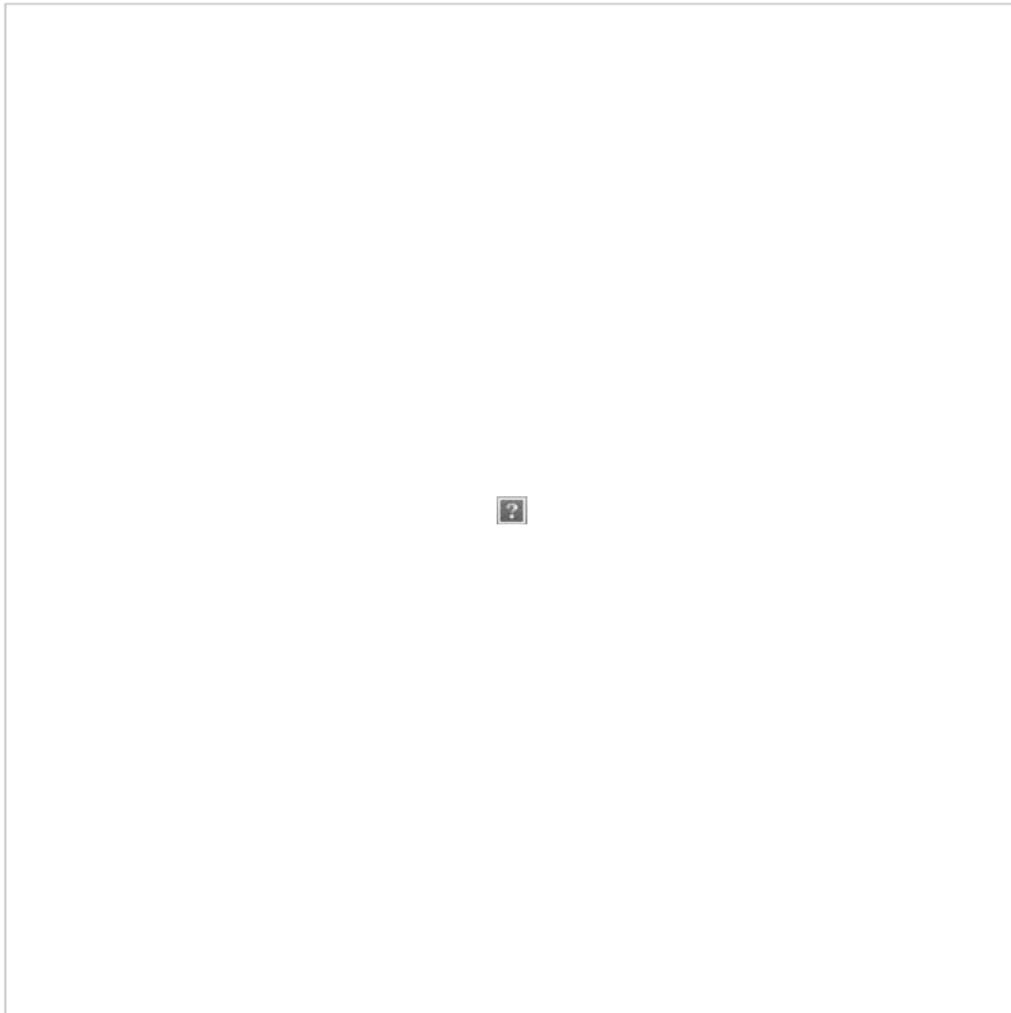

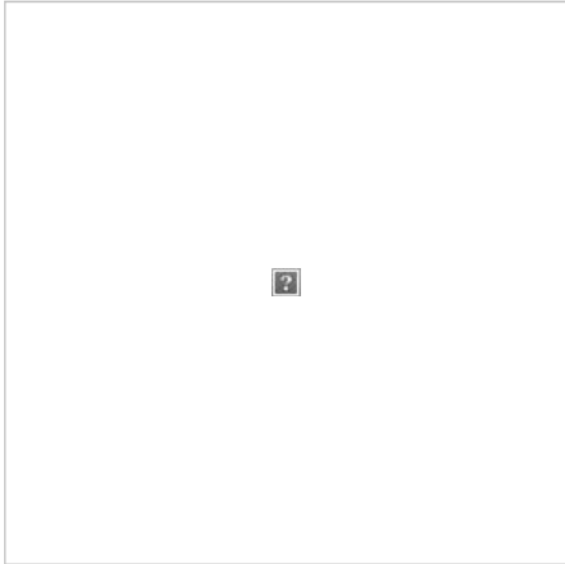

PreparedBC survey

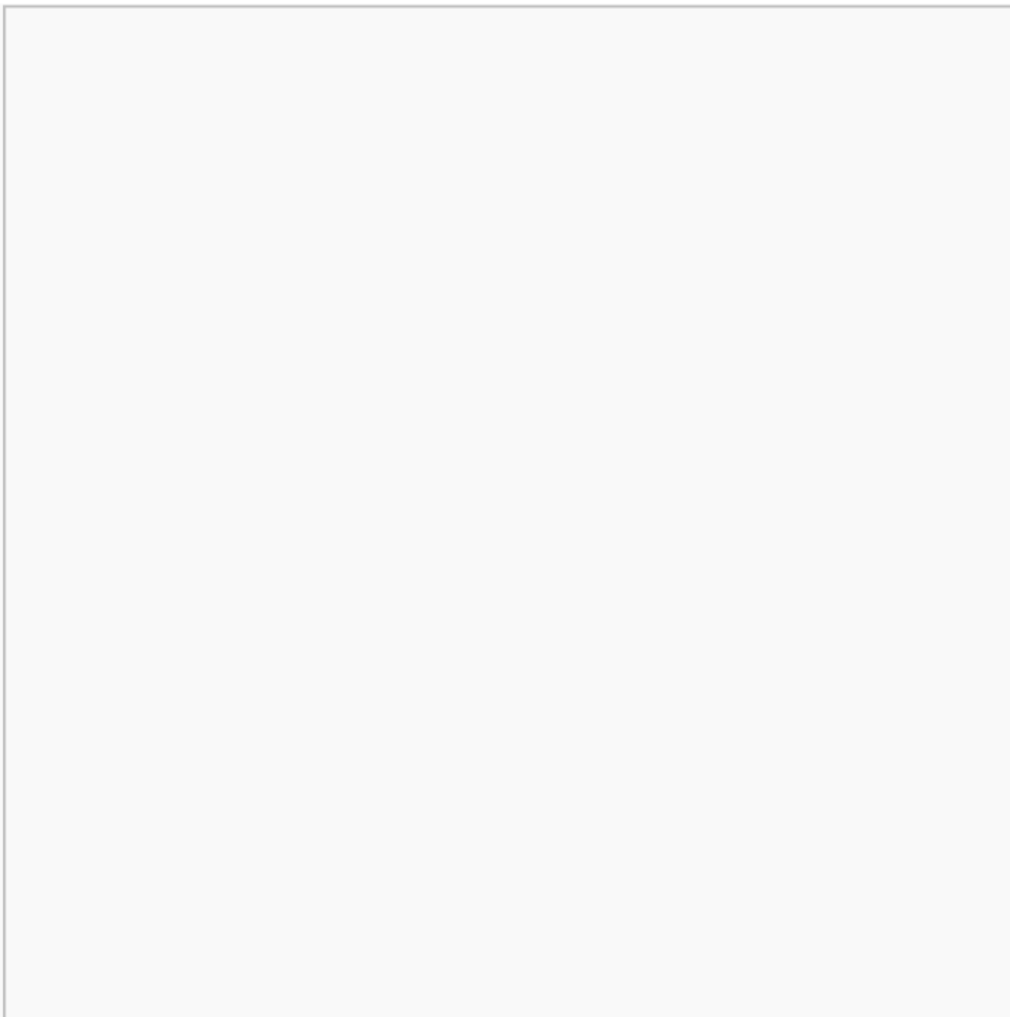
