Draft email for today:

Further to the Speaker's memorandum sent on **October \*\***, I wish to provide you with an outline of how the Great B.C. Shakeout is scheduled to unfold this Thursday, October 18.

The House will convene as usual at 10 a.m. After prayers, the Speaker will inform Members that the House will be recessed in order to participate in the earthquake drill. The proceedings will be suspended and Members will be asked to return to their offices.

At 10:19 a.m., the sounds of an earthquake will be projected over the public announcement system, and building occupants will be instructed to duck, cover and hold on. After one minute, the fire alarms will be activated. When this happens all Members and all staff will be required to evacuate the building to their assembly station on the parliamentary precinct. Fire wardens will ensure that building occupants are exiting through the nearest exit. Legislative Assembly Protective Services will be conducting sweeps to ensure that no one stays behind. Please note that elevator use will be suspended during the building evacuation. If you are in a different part of the building when the exercise starts, follow the directions of the fire warden in that area. If you need assistance exiting the Parliament Buildings please ask your Fire Warden or a member of the Legislative Assembly Protective Services.

Once outside, I invite you to have a look at the sea containers beside the Armouries and a static display that will be set up at the rear lawns. This display will give you an idea of the tools and resources that we have at our disposal in the event of a real disaster occurring within the parliamentary precinct. These resources are a vital part of the Legislative Assembly's disaster response strategy.

Legislative Assembly Protective Services will signal when it is safe to re-enter the building. It is hoped that the House will reconvene by 11 a.m., at which time business will proceed as if the House started at 10:00 am. The House would adjourn by noon.

This exercise is being treated as a serious earthquake, and we appreciate everyone's cooperation in enhancing our preparedness for such a situation. Please treat this as a real situation, and don't forget to take your wallet and keys with you as you exit the building; you would not be able to retrieve these items in a real major disaster.

To summarize, the events will unfold as follows:

- House sits at 10:00 am
- Prayers
- House recesses at 10:05 am
- Clerk, Sergeant-at-Arms and the Parliamentary Secretary for Emergency Preparedness make very brief comments in the Chamber
- At 10:10 am Members return to their offices (those wishing to stay in the Chamber can do so)
- At 10:19 am the "earthquake" begins (duck, cover and hold)
- At 10:21 am the fire alarm rings (exit the building by following the instructions of your fire warden)
- Go to your assembly point outside; wait for further instructions
- At 10:55 am the Division Bells will ring
- At 11:00 am the House will reconvene with introductions, introduction of bills, statements by Members, Oral Questions by Members
- House adjourns at approximately 11:55 am

After the exercise on Thursday morning, the Speaker, Sergeant-at-Arms and I would be very interested in hearing from you regarding your suggestions to improve communication, exiting and re-entry procedures, displays, instructions and any other matter that would bolster your well-being in the event of a real catastrophic incident. Shakeout on Thursday.


