Good Afternoon to All,

I hope that 2019 has been treating you all well. As you know, Kitsumkalum has been working very hard at developing a Spill Response Plan for the Lower Skeena River because we are extremely concerned with the tremendous increase, and planned hydrocarbon transport by rail along this river. As some of you may know we have completed two comprehensive studies from Terrace to Prince Rupert. The first study was to map the rail line with high definition photos and identify ecological and cultural sites of concern. This years study (not yet complete) has taken the most critical sites identified in the previous study and gone into classifying the site greater detail (fish trapping, fish id, access barriers, fish traps due to low waters, etc. This year we are going to conduct die studies from some of the most prominent tributaries in order to get a better idea of how a potential hydrocarbon spill might behave. We will be mapping the dispersal patters of the die, and we will try to establish what the potential impact of a spill will have in the tributaries that are under tidal influence (Ecstall, Khyex, Scotia, etc.).

As I have mentioned several times at the meetings that we have all attended, Kitsumkalum is very interested in being one of the Pilot Geographic Response Plan areas. However, I would like to invite all of you to become active participants in this process. The protection of the Skeena River, its tributaries and its proximal estuary (Flora Bank) has to be one of the most complex and important areas in the Province.

I am soliciting your input and advice as to how we move forward with this initiative this 2019-20 fiscal year as the first step in developing a long term response plan. We will be carrying out the die study regardless and we will add the results of the study to the volume of information that we have been amassing: however, in order to accomplish a truly elegant and effective plan I will need your committed input.

You may recall that you will be on the agenda for the Southern Interior Local Government Association (SILGA) convention on May 3, 2019. The event organizers have asked for a short session summary. If you have any edits to the below, please just let me know.

Draft SILGA Session Summary

In 2017, Jennifer Rice was re-elected as MLA for the North Coast of British Columbia, and subsequently appointed as Parliamentary Secretary for Emergency Preparedness. Following the devastating flood and wildfire seasons of 2017, the Government of B.C. commissioned co-chairs Chief Maureen Chapman and George Abbott to review and assess the government's response to these flood and wildfire events. The ensuing report, *Addressing the New Normal: 21st Century Disaster Management in British Columbia* (also known as the Abbott/Chapman report), was released May 10, 2018, and contains 108 recommendations, primarily for the provincial government. Numerous other relevant reports capturing recommendations from the 2017 and 2018 flood and wildfire seasons have also been released.

In response to these reports, the Province established the Emergency Management Review Office in September, 2018 to lead the cross-ministry coordination on the recommendations and the gathering of additional recommendations from emergency management partners across British Columbia. This work has led to an Action Plan on the Abbott/Chapman report, released by the provincial government on October 31, 2018. The Action Plan

reinforced the Province's partnership approach to emergency management enhancement and a commitment to focussed work on improving the Province's resiliency in the face of flood and wildfire threats.

Parliamentary Secretary Rice will speak to the actions that have been taken by the provincial government and its partners in advance of the 2019 flooding and wildfire seasons, as well as additional work underway which is poised to influence future seasons. Delegates will have an opportunity to ask questions and provide additional input with respect to necessary emergency management enhancements.

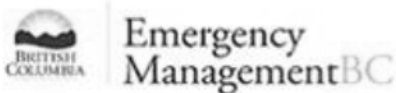

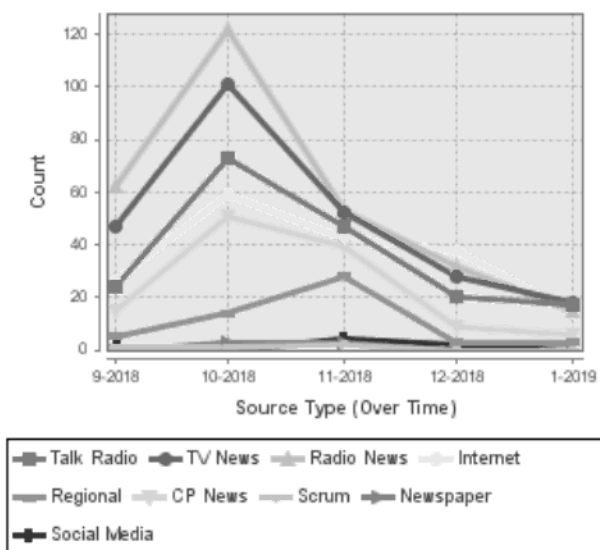

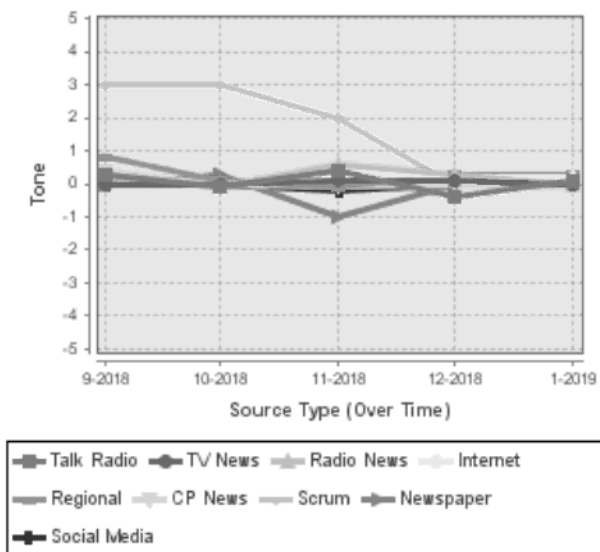

Media Mix (90 days) (2018-09-12 to 2019-01-08)



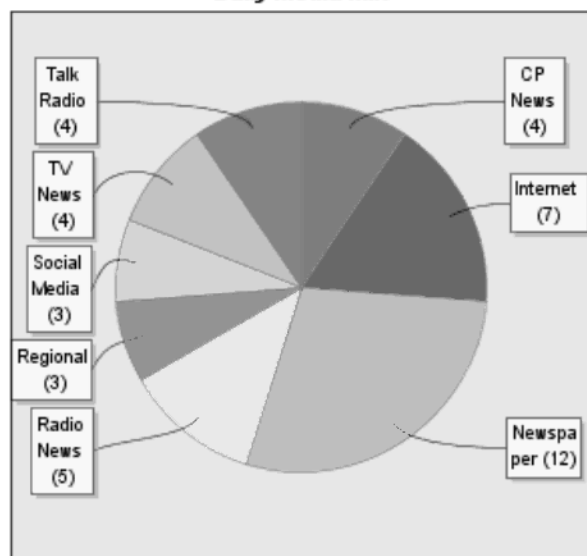

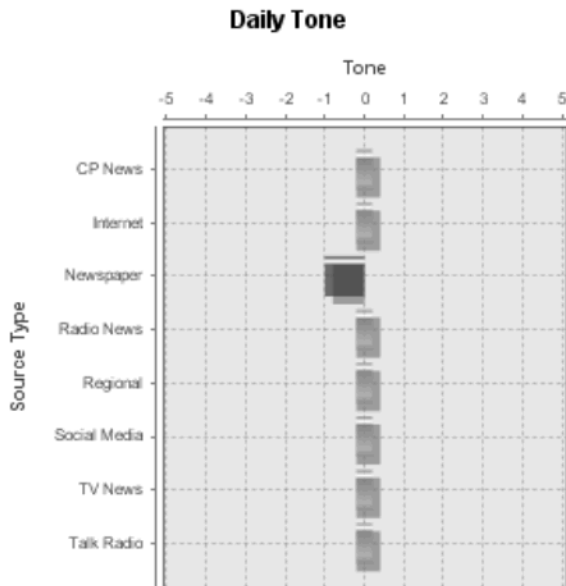
