# MINISTRY OF PUBLIC SAFETY AND SOLICITOR GENERAL POLICING AND SECURITY BRANCH BRIEFING NOTE

PURPOSE: For INFORMATION for the Honourable Mike Morris,

Minister of Public Safety and Solicitor General

ISSUE: Meeting with representatives of the Great Canadian Gaming Corporation regarding

the initial progress of the Joint Illegal Gaming Investigation Team (JIGIT)

#### SUMMARY:

 JIGIT is a collaboration between the Combined Forces Special Enforcement Unit of British Columbia (CFSEU-BC) and the Ministry of Finance. The objective of JIGIT is to provide a dedicated, integrated, and coordinated multi-jurisdictional investigative and enforcement response to illegal gambling houses and unlawful activities within BC gaming facilities, with an emphasis on top-tier organized crime and gangs.

### **BACKGROUND:**

- The Great Canadian Gaming Corporation is a BC based company that operates 20 gaming, entertainment and hospitality facilities across Canada and the United States, with nine located within BC. In 2015, the company reported gross gaming revenues of almost \$900M and total assets of almost \$1B.
- At the provincial-level, the Ministry of Finance's Gaming Policy and Enforcement Branch (GPEB) and the British Columbia Lottery Corporation (BCLC) oversee the BC gaming industry, and the companies within it. GPEB regulates all gaming in BC, ensures the integrity of gambling industry companies, people and equipment, and investigates allegations of wrongdoing. This includes regulatory oversight of BCLC. Meanwhile, BCLC manages and operates the province's gambling industry and seeks to maintain its integrity and security. BCLC owns the games and equipment used in casinos and oversees the private sector service providers who maintain the facilities and manage day-to-day operations.
- In April 2016, JIGIT was formed to disrupt organized crime and gang involvement in illegal gaming, prevent criminals from using BC gaming facilities to legalize the proceeds of crime, and conduct criminal investigations of illegal gambling houses and activities.
- JIGIT is located within CFSEU-BC and, when fully operational in 2017/18, it will be comprised of 22 law enforcement positions and five GPEB personnel appointed as investigators under the *Gaming Control Act* and Special Provincial Constables under the *Police Act*.

 The law enforcement positions will be responsible for conducting criminal investigations while GPEB's investigators will provide subject-matter expertise to the team, though the scope of their role is limited by what is legally permissible.

- BCLC also supports JIGIT through gathering and reporting information to GPEB on occurrences where the conduct, activity or incidents in, around or related to provincial gaming involves the commission of an offence under the *Criminal Code* or the *Gaming Control Act*.
- Since forming in mid-2016, members of JIGIT have engaged in specialized training and they are now operational. On February 6, 2017, CFSEU-BC made the first public announcement regarding JIGIT after two individuals were charged as a result of an investigation conducted by the team at Lake City Casino in Kelowna (which is owned by Gateway Casinos and Entertainment Limited).
- There are several mechanisms in place to monitor and assess the success of JIGIT.
   For instance, CFSEU-BC has committed to providing a range of qualitative and quantitative measures that relate to mission success, impact on society and demonstrated dollar for value in several regular reports. Additionally, GPEB will provide BCLC with bi-annual performance information based on reporting received from CFSEU-BC. The report will outline the efforts of JIGIT and include gambling specific metrics.
- It is important to note that any reports generated or produced in connection to JIGIT, including performance reports and financial reports, will remain confidential unless otherwise agreed to by PSSG and GPEB or where required by law or regulatory disclosure requirements. In addition, all public-facing communications of JIGIT activities, such as media releases and press conferences are within CFSEU-BC's jurisdiction.

Hi Tom,

I am not sure precisely what you need so I will lay out what I think is important to know and then feel free to ask me anything additional that you need.

Great Canadian Casino Corporation (GCGC) is a public traded entity. The only two substantially large shareholders are investment firms, Burgundy Asset Management with 19.16% and BloombergSen Inc. which has 10.95%.

The Chairman of the board is Peter Meredith. CEO is Rod Baker. CFO (very new to the position) Andreas Thompson. COO Terrance Doyle. Mr. Baker has been there for several years and Mr. Doyle goes back many years having worked his way up to the position.

As mentioned in the briefing note that Len sent you, GCGC is the largest gaming company by revenue in BC although Gateway Casinos is not far behind after recent acquisitions. GCGC's River Rock casino in Richmond is by far the largest money maker in the province and dominates high roller play.

GCGC Operates Casinos and Horse Racing tracks in four Canadian provinces but they are based out of BC and the majority of their business is here. Their sites break down as follows:

#### British Columbia

- 4 casinos
- 1 casino with racetrack
- 1 racetrack with slot machines
- 3 Community gaming Centres (bingo halls with slot machines)
- 20 horseracing teletheatres which GCGC partially owns

#### Ontario

2 Racetracks with slot machines

2 casinos

New Brunswick

2 casinos
