Thanks for your help with seeking funds to help sustain the CVTS programs that are supported by Too Good To Be Threw.

I know you asked for some hard numbers and I have some preliminary numbers for the programs CVTS is contracted with the Provincial Government to provide.

The emergency funding request is based on one quarter of the budgeted deficits in each of the contracted programs. The annual deficits in the contracted programs are covered by the thrift store net revenue.

Here is the breakdown my contract/ministry

BC Housing – Lilli House Transition House - \$3,000

BC Housing – Homelessness Prevention Program - \$7500.00

Island Health/Ministry of Health – Amethyst House - \$37,250

MPSSG – Stop the Violence Counselling - \$2,000

MPSSG – PEACE Programs (Children Who Witness Abuse) - \$3675

Total is \$53,425 for provincially funded programs. The annual figure is \$213,700.

In addition to the contracted programs we also fund a number of unfunded programs through the Thrift Store. I need to do a bit of work to figure out exactly what that shortfall will be and will let you know what that figure is very shortly. One of these programs is the tenant support worker for the housing we have developed over the past few years. And this is fully funded by the Thrift Store and will be a great lose to the women in our supported/transitional housing and those trying to find housing. The annual cost of for this employee that works 28 hours per week is \$40,000.

So far the required total to get us to March 31 is \$63,425

And again I will figure out the other smaller gaps we will have in the other unfunded programs and send it to you shortly.

As we discussed, I have attached FINTRAC's "Questions and Answers" (Q&A) document that was prepared in response to the Financial Action Task Force's (FATF) 2016 Mutual Evaluation Report (in two PDFs, since I'm unable to scan double sided documents). The Q&A document is a public relations exercise that seeks to minimize the seriousness of FATF's findings, in 2016, that FINTRAC's use of financial intelligence to combat money laundering were only "moderately effective."

Your staff may be able to request a copy of the actual 2016 Mutual Evaluation Report through federal access to information channels.

I have also attached a copy of my CV for your reference. As I mentioned on Friday, I am interested in doing contract consulting work on behalf of the BC NDP or serving as a director on the boards of government agencies and commissions.

Hi there,

My name is s.22
s.22

Right now, we have two major problems we are facing, the first one is our water situation- we get our water from a creek, which comes out of the mountain beside our property, but because all of the trees burnt, the creek is drying up. We need water for our home, for our business^{s.22}, and to fight any future fires. We got a quote to get a well drilled, and the cost will be close to \$20,000 when all said and done.

Our second major problem, is the land cleanup. As I type this email, it is still burning underground on our property in spots. There is hardly any snow to speak of, so come spring time, there will be a re-burn. We have a TD15 Dozer, and there is only so much cleanup we can do with that, so we are needing to purchase an excavator, which will be in the \$60,000 range.

We lost a lot of smaller items(our haying equipment, snowmobile, Argo, truck canopy, etc), but obviously those items we will replace over time, as they are not that important in order to function right now.

WE haven't received any help, other than a small amount from Red Cross, for alternative heating(because we use Wood Heat), and a small amount from Horse Council BC, because we have horses(they had to get evacuated), and their fencing was destroyed when the fire came through, and fireguards were put in.

We live off the reserve, we have not seen any donation money. We have not received any help whatsoever, we have been on our own, and we are frustrated. The Tahltan Band has received much financial assistance/donations(and they are still receiving, according to the news), and we have not received anything other than what Red Cross, and Horse Council BC has given us, which is not very much at all, it is almost a joke.

Everyone in town was given firewood for the winter that was donated(18 logging truck loads were donated by Red Chris, to the Band). No one has to worry about their water drying up in town and no one has to worry about a re-burn in town, because everything got cleaned up and hauled away, and property's were landscaped.

We have contacted as many organizations and programs that we know about, with only (2) being able to help us- the others have told us we don't qualify.

It is very frustrating when we keep getting told that we can't be helped, and we are feeling very defeated these days. Just being outside, or looking out the window at this mess, is overwhelming some days.

Are you able to help us in any way?

Hi Talea – we haven't been asked for a formal letter response but wanted to get some information to you that staff provided in response to the **s.22** enquiry:

- An Unmet Needs Committee has been formed. It is chaired by Derek Ingram, the Community Recovery Manager and will support both Tahltan and the Regional District of Kitimat Stikine (RDKS) residents.
- The Canadian Red Cross has been contacted and they will follow up directly with the **s.22** regarding any additional support they may be able to offer.
- The Community Recovery Manager will speak to residents and work with the Regional Recovery Manager (Deb Borsos) to identify specific needs and, based on the needs assessment, look at available supports.
- Rural Economic Operations (FLNRORD) will do a community reach out when they visit Telegraph Creek to discuss regional economic development initiatives and tourism opportunities. Tentative schedule for the community visit is within the next several weeks.
- BC Wildfire Service has confirmed receipt of a claim from the **s.22**. Assessment of suppression activities on private land will be completed in conjunction with Crown land assessments. FLNRORD staff have been in contact with the **s.22** and as it gets closer to the time when individuals will be out looking at suppression activities, they will be notified.
- There is not enough information at this time to determine if the water issues are a direct result of the wildfire and/or BCWS response efforts. Further analysis would involve Water Stewardship for information on the water conditions in the area, etc. According to the BC drought mapping, the drought code for the Telegraph Creek area is "Dry" (described as the first indications of a potential water supply problem).

Right now, we have two major problems we are facing, the first one is our water situation- we get our water from a creek, which comes out of the mountain beside our property, but because all of the trees burnt, the creek is drying up. We need water for our home, for our businesss.22, and to fight any future fires. We got a quote to get a well drilled, and the cost will be close to \$20,000 when all said and done.

Our second major problem, is the land cleanup. As I type this email, it is still burning underground on our property in spots. There is hardly any snow to speak of, so come spring time, there will be a re-burn. We have a TD15 Dozer, and there is only so much cleanup we can do with that, so we are needing to purchase an excavator, which will be in the \$60,000 range.

We lost a lot of smaller items(our haying equipment, snowmobile, Argo, truck canopy, etc), but obviously those items we will replace over time, as they are not that important in order to function right now.

WE haven't received any help, other than a small amount from Red Cross, for alternative heating(because we use Wood Heat), and a small amount from Horse Council BC, because we have horses(they had to get evacuated), and their fencing was destroyed when the fire came through, and fireguards were put in.

We live off the reserve, we have not seen any donation money. We have not received any help whatsoever, we have been on our own, and we are frusterated. The Tahltan Band has received much financial assistance/donations(and they are still receiving, according to the news), and we have not received anything other than what Red Cross, and Horse Council BC has given us, which is not very much at all, it is almost a joke.

Everyone in town was given firewood for the winter that was donated(18 logging truck loads were donated by Red Chris, to the Band). No one has to worry about their water drying up in town and no one has to worry about a re-burn in town, because everything got cleaned up and hauled away, and property's were landscaped.

We have contacted as many organizations and programs that we know about, with only (2) being able to help us- the others have told us we don't qualify.

It is very frustrating when we keep getting told that we can't be helped, and we are feeling very defeated these days. Just being outside, or looking out the window at this mess, is overwhelming some days.

What is considered legal marijuana (can he share what he grows, or would that mean marijuana purchased from a provincial store)?

Initially it sounded like he wanted to know if it was legal for people to drink tea and consume marijuana he provides on his front lawn but he also talked about eventually making this a business where he sells food and drink.

Any information you can provide on this question would be greatly appreciated? If there are issues outside of the province's jurisdiction, just note that for me and I will direct the constituent on where they can go to get that information.

A constituent of MLA Brar's in Surrey-Fleetwood requests a justification for Section 25 (4) & (5) of the Motor Vehicle Act:

(4)If the applicant for a driver's licence has at any time before making the application held a driver's licence issued under this Act or in another jurisdiction, the applicant must, at the time that he or she is issued a driver's licence under this Act, surrender the last driver's licence or duplicate of it held by him or her, unless the Insurance Corporation of British Columbia on cause shown to the corporation's satisfaction dispenses with its production.

(5)At the same time that he or she has a driver's licence issued under this Act, a person must not have a driver's licence issued by another jurisdiction or have another driver's licence previously issued under this Act.

The scenario is as follows: The constituent's spouse spends several months a year with family in the Philippines, during which time she depends heavily on motor vehicle transportation. On February 4th, the spouse's Philippine driver's license was scheduled to be surrendered. The couple's concern is that the spouse will be unable to hold a license in the Philippines and would thus be unable to drive in the Philippines during the period of her stays.

Our office and the constituents request a backgrounder on, or explanation/reasoning for, this

section of the Act.

If you could so provide me with this information, I would be most grateful.

Further analysis would involve Water Stewardship for information on the water conditions in the area, etc. According to the BC drought mapping, the drought code for the Telegraph Creek area is "Dry" (described as the first indications of a potential water supply problem).

Right now, we have two major problems we are facing, the first one is our water situation- we get our water from a creek, which comes out of the mountain beside our property, but because all of the trees burnt, the creek is drying up. We need water for our home, for our businesss.22 and to fight any future fires. We got a quote to get a well drilled, and the cost will be close to \$20,000 when all said and done.

Our second major problem, is the land cleanup. As I type this email, it is still burning underground on our property in spots. There is hardly any snow to speak of, so come spring time, there will be a re-burn. We have a TD15 Dozer, and there is only so much cleanup we can do with that, so we are needing to purchase an excavator, which will be in the \$60,000 range.

We lost a lot of smaller items(our haying equipment, snowmobile, Argo, truck canopy, etc), but obviously those items we will replace over time, as they are not that important in order to function right now.

WE haven't received any help, other than a small amount from Red Cross, for alternative heating(because we use Wood Heat), and a small amount from Horse Council BC, because we have horses(they had to get evacuated), and their fencing was destroyed when the fire came through, and fireguards were put in.

We live off the reserve, we have not seen any donation money. We have not received any help whatsoever, we have been on our own, and we are frustrated. The Tahltan Band has received much financial assistance/donations(and they are still receiving, according to the news), and we have not received anything other than what Red Cross, and Horse Council BC has given us, which is not very much at all, it is almost a joke.

Everyone in town was given firewood for the winter that was donated(18 logging truck loads were donated by Red Chris, to the Band). No one has to worry about their water drying up in town and no one has to worry about a re-burn in town, because everything got cleaned up and hauled away, and property's were landscaped.

We have contacted as many organizations and programs that we know about, with only (2) being able to help us- the others have told us we don't qualify.

It is very frustrating when we keep getting told that we can't be helped, and we are feeling very defeated these days. Just being outside, or looking out the window at this mess, is overwhelming some days.

Are you able to help us in any way?

He would like to know if this means he can set up a picnic table in his front yard, sell ice tea, and share marijuana for people to smoke. Is there any restriction on how often he shares 30 grams with adults or how he distributes that 30 grams? Can people consume marijuana in a front yard? What is considered legal marijuana (can he share what he grows, or would that mean marijuana purchased from a provincial store)?

Initially it sounded like he wanted to know if it was legal for people to drink tea and consume

marijuana he provides on his front lawn but he also talked about eventually making this a business where he sells food and drink.

Any information you can provide on this question would be greatly appreciated? If there are issues outside of the province's jurisdiction, just note that for me and I will direct the constituent on where they can go to get that information.

A constituent of MLA Brar's in Surrey-Fleetwood requests a justification for Section 25 (4) & (5) of the Motor Vehicle Act:

(4)If the applicant for a driver's licence has at any time before making the application held a driver's licence issued under this Act or in another jurisdiction, the applicant must, at the time that he or she is issued a driver's licence under this Act, surrender the last driver's licence or duplicate of it held by him or her, unless the Insurance Corporation of British Columbia on cause shown to the corporation's satisfaction dispenses with its production.

(5)At the same time that he or she has a driver's licence issued under this Act, a person must not have a driver's licence issued by another jurisdiction or have another driver's licence previously issued under this Act.

The scenario is as follows: The constituent's spouse spends several months a year with family in the Philippines, during which time she depends heavily on motor vehicle transportation. On February 4th, the spouse's Philippine driver's license was scheduled to be surrendered. The couple's concern is that the spouse will be unable to hold a license in the Philippines and would thus be unable to drive in the Philippines during the period of her stays.

Our office and the constituents request a backgrounder on, or explanation/reasoning for, this section of the Act.

If you could so provide me with this information, I would be most grateful.

Question: If someone would like to go through a public safety test but can't afford the \$200 cost is there any financial assistance for that?

- In order to be certified as a guide dog or service dog, a dog must either:
 - Have been trained by a school accredited by an organization named in the Guide Dog and Service Dog Regulation, or
 - Pass a test administered by the Justice Institute of BC
- The fee to pass a test by the Justice Institute of BC is \$200.00
- A supplement is available to cover the fee to recipients of income assistance, hardship assistance, or disability assistance.
- For dogs that are to undergo a test administered by the Justice Institute of BC, the supplement may be issued up to two months before the date of the test.
- Clients will be eligible for the supplement when the client provides the Ministry of Social Development and Poverty Reduction with a letter from the Justice Institute of BC that confirms that they have a test booked.

Is it mandatory for Volunteer Fire Departments to meet the standards set out in the Playbook?

1. Any organization delivering fire services in BC is required to meet the standard (Playbook), with the exception of the BC Wildfire Service (First Nations on reserve are not covered by legislation or requirement).

What are the consequences if a Volunteer Fire Departments does not meet the standards set out in the Playbook?

- Potential liability in the event of death/injury.
- Any lawsuit over a fire response would look at what standards exist and any failure to comply as potential contributing factors.

Does the province have any programs or supports to assist a Volunteer Fire Department to meet the standards set out in the Playbook?

- Through the Office of the Fire Commissioner (OFC), all necessary training curriculum materials for Exterior Fire Departments have been developed and are available for free.
- A series of “Train the Trainer” courses were funded and run across the province to allow departments to develop an internal instructor capability.
- Team Leader courses were also funded to support departments.
- OFC with Local Government Management Association (LGMA) runs regional workshops on Effective Fire Service Administration (Chief Administrative Officer (CAOs) and Fire Chiefs). The next one is in Cranbrook in early March.

Who is responsible for enforcement?

- It is the responsibility of the authority having jurisdiction over the specific fire service to ensure compliance with the Playbook.

Is there anything that the province can do to assist Spences Bridge with the issue of a nonconforming Volunteer Fire Department?

- OFC staff are available to answer questions, provide advice and point them towards resources.

A constituent from Spences Bridge has reached out to MLA Tegart for some assistance. He is very concerned that Spences Bridge's Volunteer Fire Department does not meet the minimum standards set out in the Structure Firefighters Competency and Training Playbook. Because of this, adequate fire protection is not being provided to residents in Spences Bridge, which puts their residents at risk; as well as residents are paying premiums for property insurance, and in some cases not able to get insurance for their properties.

Could you please provide responses to the following:

- Is it mandatory for Volunteer Fire Departments to meet the standards set out in the Playbook?
- What are the consequences if a Volunteer Fire Departments does not meet the standards set out in the Playbook?
- Does the province have any programs or supports to assist a Volunteer Fire Department to meet the standards set out in the Playbook?
- Who is responsible for enforcement?
- Is there anything that the province can do to assist Spences Bridge with the issue of a nonconforming Volunteer Fire Department?

I received this information this morning from the Ministry, responding to your constituent's inquiry:

Is it mandatory for Volunteer Fire Departments to meet the standards set out in the Playbook?

1. Any organization delivering fire services in BC is required to meet the standard (Playbook), with the exception of the BC Wildfire Service (First Nations on reserve are not covered by legislation or requirement).

What are the consequences if a Volunteer Fire Departments does not meet the standards set out in the Playbook?

- Potential liability in the event of death/injury.
- Any lawsuit over a fire response would look at what standards exist and any failure to comply as potential contributing factors.

Does the province have any programs or supports to assist a Volunteer Fire Department to meet the standards set out in the Playbook?

- Through the Office of the Fire Commissioner (OFC), all necessary training curriculum materials for Exterior Fire Departments have been developed and are available for free.
- A series of "Train the Trainer" courses were funded and run across the province to allow departments to develop an internal instructor capability.
- Team Leader courses were also funded to support departments.
- OFC with Local Government Management Association (LGMA) runs regional workshops on Effective Fire Service Administration (Chief Administrative Officer (CAOs) and Fire Chiefs). The next one is in Cranbrook in early March.

Who is responsible for enforcement?

- It is the responsibility of the authority having jurisdiction over the specific fire service to ensure compliance with the Playbook.

Is there anything that the province can do to assist Spences Bridge with the issue of a

nonconforming Volunteer Fire Department?

- OFC staff are available to answer questions, provide advice and point them towards resources.
