VICTORIA - British Columbians only need to recall the last two flood and wildfire seasons to be reminded of some of the hazards in the province and the importance of being prepared.

Planning ahead can help protect loved ones and reduce stress in the event of any kind of emergency, including a natural disaster. This Emergency Preparedness Week, May 5-11, 2019, all British Columbians are encouraged to make a plan, compile a kit and build resiliency in their homes and communities.

"The best way to keep safe in the event of an emergency is to ensure your household is ready in advance," said Mike Farnworth, Minister of Public Safety and Solicitor General. "PreparedBC has the resources British Columbians need to get started on making plans that will help them cope through the initial stages of any emergency."

PreparedBC is getting back to basics this year by focusing on three key steps:

1. know the hazards in your local area;
2. make a plan to help keep focused and safe during an emergency; and
3. build an emergency kit and assemble grab-and-go bags.

"It's fantastic to see communities around B.C. taking part in emergency preparedness activities," said Jennifer Rice, Parliamentary Secretary for Emergency Preparedness. "Tofino took a great step towards tsunami preparedness with its recent high-ground hike event and I applaud the many communities that are holding emergency preparedness events throughout the week."

One of the ways the Province is supporting Emergency Preparedness Week is by participating in national public safety emergency notification system testing. The Alert Ready system will be tested in B.C. on Wednesday, May 8 at 1:55 p.m. During the test, an alert will be broadcast on radio and television stations, as well as on compatible wireless devices. This testing is designed to assess the system's readiness for an actual emergency and identify any adjustments that need to be made.

March 7, 2019 PS Rice and Minister Beare, respective Deputy Ministers and support staff met in the Hemlock room with representatives from the 4 of the 5 Regional Destination Marketing Organizations (RDMOs) to discuss the needs of the Tourism Sector and emergency management specifically preparedness.

- At that meeting the RDMO's expressed an interest to continue to take on a greater leadership role in emergency management preparedness, even though resources and funding to support these activities is limited.
- In the short term, it was recognized that some funding support to the RDMO's to undertake emergency management communications and training would help ensure all regions are prepared to respond to potential floods and wildfires in 2019.
- The Cariboo Chilcotin Coast Tourism Association (CCCTA) has spent considerable time and resources on emergency preparedness last year over the last two years, the other regions are not as well prepared.
- Modest one time year end funding was provided \$200,000 to assist the RDMOs with preparing for the 2019 season. *This is the announcement PS Rice has the opportunity to support.*
- Of the \$200,000 CCCTA received \$75,000 on behalf of the RDMO's to lead the coordination of communication and training activities for all RDMO's this spring in advance of the 2019 wildfire season as well as an additional \$25,000 for their region-specific emergency preparedness needs.
- The remaining four RDMOs also received \$25,000 for their region-specific emergency preparedness needs.
- The Tourism Branch continues to work closely with the RDMO's to integrate their efforts within the provincial emergency management system.
