- 1) **Guidebook** with all of the changes to the Travel card program. Please note there are changes noted in this guidebook that apply to the BMO purchase card and BTA, please disregard.
- 2) **Corporate Travel Entertainment Program Insurance Certificate** – This is a new Certificate of Insurance for all Travel cardholders.

A: Cardholders will phone the Insurance provider – phone number on the back of the card. They will assist with processing the claim and if the claim is valid, they would apply the credit back to your card/account.

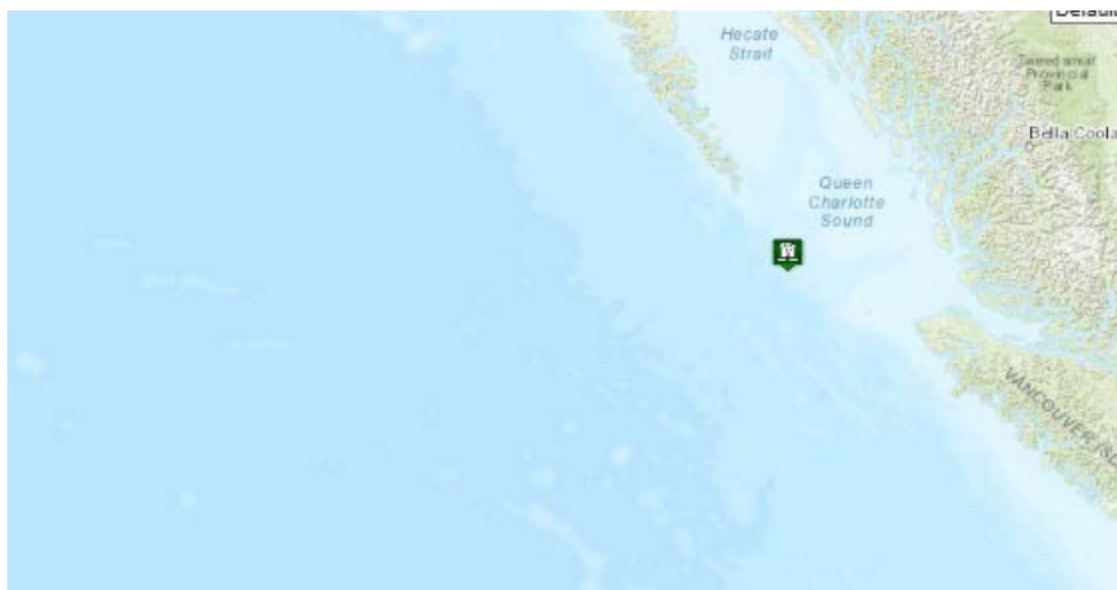
An earthquake incident has occurred near **Sandspit, BC** with the following **preliminary parameters**:

Dear Minister,

Lions Gate Risk Management [LGRM] has recently secured contracts with the RCMP 'E' Division to provide approximately 600 security personal for deployment in areas of British Columbia that will be impacted by forest fires; and in addition approximately 400 security personal to secure and protect RCMP crime scenes. This will give the RCMP an opportunity to free up RCM Police members to carry out their regular duties and responsibilities, and as well prevent the need to recruit members from [for example] lower mainland detachments for fire support duties. This becomes very expensive, and as well leaves many communities adversely affected by members being posted to the fires, subsequently reducing the detachments' ability to fulfill the policing needs.

During recent discussions with the RCMP and to assist in their concerns, LGRM has recruited several hundred personnel [applicants] to secure the 'forest fire' staffing needs that is usually carried out by the RCMP eg; road closers, looting, fire scene protection, etc., and as well, crime scene protection, eg; homicides, airplane crashes, suspected arson, etc.. The LGRM applicants are mostly former and retired law enforcement officers that would normally qualify for an exemption from acquiring the Basic Security Training [BST] in order to qualify for the Security Guard License; [Reference: Security Services Regulations Subsection 3(10)(b)(ii).

In consideration of the aforementioned would you be so kind to expedite LGRM applicants, as we are already into an early fire season and are currently experiencing serious forest fire outbreaks in the province. As well, it is predicted that the forest fires could be worse than we experienced in 2018. Furthermore, we have another hurdle to get through once our personal receive the security guard license; as per our agreement with the RCMP, those approved by your Ministry for a security guard work license are then required to engage in, and clear an 'enhanced level security' process by the RCMP before they can be deployed.

Most importantly, LGRM/RCMP contract for the above are procured through senior management of the RCMP. Furthermore, please be advised that the Assistant Commissioner, RCMP, 'E' Division, has kindly offered to speak to these matters with yourself, the Deputy Minister, or a delegate.

The *Freedom of Information and Protection of Privacy Act* (FOIPPA) contains both mandatory and discretionary exceptions to disclosure. Sections 13 to 20 are the discretionary exceptions. Where Information Access Operations (IAO) has advised the head



that a discretionary exception may apply, it is important that the head consider the possibility of releasing the information despite the fact that an exception may apply.

- when the policy advice exception is claimed, whether the decision to which the advice or recommendations relates has already been made.

We've had some media issues arise following our Grand Forks funding announcement on June 26. There is a chance this could come up given ongoing coverage on CBC and Global.

We have a comprehensive IN currently in approvals which should be ready by late afternoon. It is mostly the INs background that needs review, so here are approved holding lines in the meantime if you're on a shorter deadline:

- Our government recognizes the truly catastrophic impact the flood has had on the community of Grand Forks and the surrounding area.
- I saw firsthand the loss and immeasurable destruction. Our government remains committed to helping the residents of Grand Forks as they rebuild and recover from this devastating tragedy.
- The goal of the Disaster Mitigation and Adaptation Fund project announced on June 26 is to find ways to give the people affected by the floods the means and opportunity to rebuild homes and communities in Grand Forks.
- What's important is that this community is built back better. Risk mitigation is key. This is an opportunity to make sure that if an event of this magnitude were to occur again, it would not have the same outcomes for this region.
- To help provide the City of Grand Forks with the tools they need to build a more resilient community, to help provide those who have lost homes the opportunity to rebuild, and to help protect the downtown core, the Province is providing a total of \$31.5 million.
- Within these broad objectives, the City of Grand Forks and the Province know that every homeowner's situation is unique; the local government will be considering all of their available options to provide viable opportunities for homeowners to rebuild in the community.
- While this is a local government-led project, the Province has worked alongside Grand Forks and the Boundary Flood Recovery Team since the beginning of this event and will continue to work with them to rebuild.

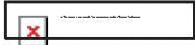

Dear Premier Horgan, Minister Trevena, Minister Farnworth, Attorney General Eby

Enforcement of traffic laws in BC appears to have declined to an unacceptable level while vehicle numbers, congestion and population all have grown. All of our lives are at risk, whether as a driver, cyclist or pedestrian, because of excessive vehicle speeds and dangerous, aggressive driving habits.

Personally, I favoured speed enforcement cameras and was dismayed to see them removed as part of a BC Liberal election ploy. Intersections however, are the most dangerous places and both speed cameras and good video records are needed to make them safer.

I would acknowledge that some of our posted speed limits are unrealistically low, but they are flouted routinely by practically all drivers, which seems to have led to a general disregard for speed limits or a notion that 10-20 km/h over the posted limit is generally ok.

Data-based decisions are usually best - what evidence is there that more enforcement leads to lower vehicle speeds and that lower speeds reduce harm and injuries? I expect there is ample evidence. It is this sort of evidence that led to welcome reversal of some BC Liberal government speed limit changes in the past couple of years, changes to drunk driving limits and the like - well done.. but keep going down this rational path using presumed copious accident/traffic data!

Other jurisdictions face similar problems, but driving seems safer in many of them. Even in France, which many years ago seemed much more risky than BC, speed limits in towns and villages are mostly well-observed, being enforced by radar cameras.

An often-heard argument against speed enforcement cameras is that government manipulates them as a form of "cash cow" for an extra source of revenue. One way to allay those fears and suspicions is to re-direct the net revenues to drivers who observe the rules (every month each driver who has not incurred an infraction for a period is entered into a lottery draw and the lucky winners share the net proceeds (Sweden once proposed this, but I don't know whether it was implemented). Another way might be to use the net proceeds to supplement another charity or similar such as the BC Parks Foundation or some other non-essential service - it would seem to become just a taxation replacement if it were directed to schools, roads, hospitals or similar essential services.

So far, my family have all managed to avoid serious road injuries (touch wood!). Even so, we've been collectively involved in many accidents, and vehicle write-offs due to poor driving by BC motorists. Many others, regrettably, have not been so lucky.

Let's get more of them. Those who break speeding laws can voluntarily pay for them by continuing to speed. They are used effectively in many advanced countries in the world. The USA is not an advanced country. Look at the effectiveness in France, as an example.

Violations of traffic laws kill injure more people and cause more public damage than Criminal Code violations. Speed is the number 1 traffic law violated, and it goes virtually unchecked. It is open house - it is the Wild West. Do not issue warning tickets - we all should know the law as we are licenced drivers,. Do not give grace-allowances. A posted limit of 50 km/h is the law, 51 is speeding. If one gives a grace of 10 km/h, then a posted sign of 50 km/h is not true, because the grace makes the limit 60 km/h. If 60 km/h is the real limit, then post at 60 km/h and 61 then becomes the new speeding.



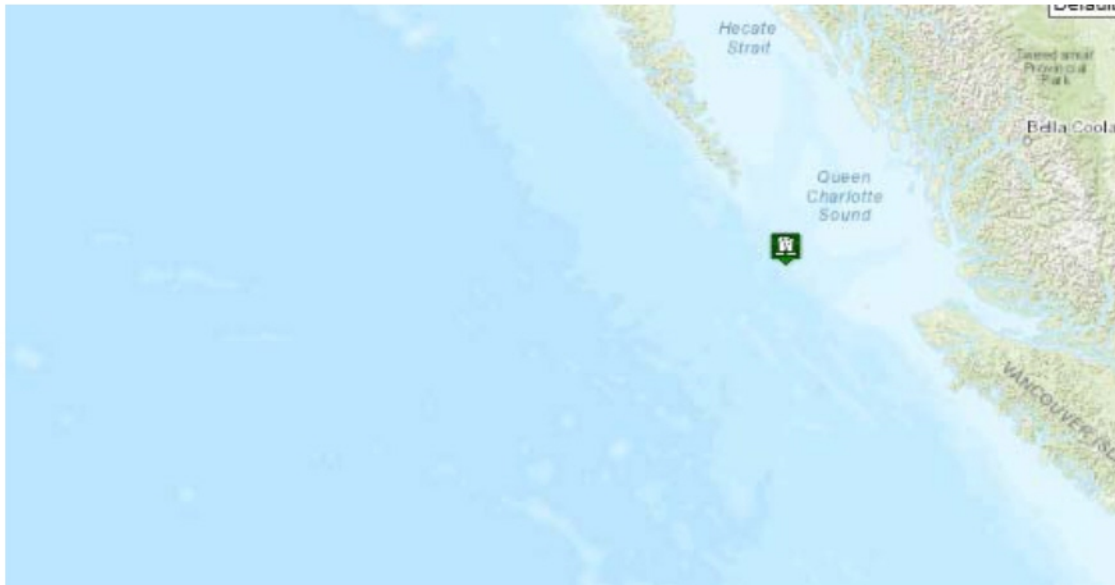
