Dear colleagues,

In response to a government-wide directive from Treasury Board, our ministries are taking actions to reduce discretionary spending through the immediate implementation of spending restrictions. As you may know, government has been under spending restrictions for several years and the additional actions that we are taking today are to ensure that funding is invested in the priorities that matter for people and maintain strong fiscal management, debt affordability, and balanced budgets.

#### What does this mean?

Effective immediately, all hiring must have Deputy Minister approval. This includes hiring for positions that are currently in the recruitment process. For competitions underway, unless a written offer has been given, Deputy Minister approval must be reconfirmed and no offers given until Deputy Minister approval is received. All positions which previously received blanket approval on their bulk hiring will now be reviewed by the appropriate Deputy Minister. The exception to this will be essential operations staff such as sheriffs, correctional officers, probation officers and prosecutors.

Only essential travel should be considered and any travel whether in province or out of province, which is not litigation-related or essential for a statutory obligation or fully reimbursed, will require preapproval by the Deputy Minister.

Discretionary spending, including new contracts, is now on hold. Only essential expenditures should be considered and these should be pre-approved by your Deputy Minister. Essential expenditures approved by branches and divisions will be monitored by the Corporate Management Services Branch on behalf of the joint executive team.

The approval process for other discretionary expenditures is also being reviewed and targets will be developed through our corporate governance committees. More information on this to come.

The hiring approval process will be communicated through executive next week. In the meantime, please speak with your ADM if you have any questions.

Good morning. Just a few points to note as you approach this exercise in conjunction with the rest of Executive. It will be useful to keep in touch with the same exercise with EMBC and MAG, too, so each DM knows the full picture of what is being submitted and identified initiatives aren't at cross purposes. Try to touch base with Lori and Richard early on.

David could also begin to reach out to individual branches so they can prepare their EDs and ADMs. I'd then convene a meeting with Executive along with David  $^{\rm s.13}$ 

Generally, its useful

to give people time to go back to their branches and do some work and have a follow up meeting. There is a DMC next Friday – There is likely to be discussion there about the exercise as its playing out and may be further instructions after there has been some dm discussion.

There may also be some discussion amongst the social/justice dm's – we've already had discussion amongst us that much of what is allocated to us as discretionary or in contingency is base line operational. You may benefit from touching base with David Galbraith and Allison Bond, in particular.

I've had a brief touch base with Nimmi already. I suggest you give her a call on Monday just to let her know that you're working up an initial approach with Executive. Let her know you'll touch base with her later in the week in terms of progress. You'll have lots of time with the Minister during UBCM so you can begin to outline what it looks like during that time. I'd look to give him something in hardcopy end of the UBCM week or beginning of the week of Sept 30<sup>th</sup>. make sure he has a few days consider and leave yourself time to adjust and work with Exec if he requests changes. He may not do so but it's good to have that built into your timeframe. Prior to finalizing, I'd look to have one last touch base with Richard and Lori.

That's really all the advice I can think of in conjunction with this type of task. Give me a call if you have a question or want to discuss next week. My experience is there really is only so many places to look and levers to pull. Whatever you and the team put together will be the plan.

Good evening to all BMC.....

I'm writing to provide a heads up that tomorrow we can expect to receive some corporate direction across the sector relating to some fiscal controls that are being put into place, effective immediately and likely for the balance of the fiscal year. At this time these controls relate specifically to what would be referred to as discretionary spending which includes things like hiring, travel and contracts.

We can expect to be advised that all hiring will require DM approval. This is something that has been in place for many years now, however it had loosened up in recent years. We can expect that all positions and all types of hiring (permanent, TA, aux) will now require this approval. We will also be directed to cancel all competitions that are in progress unless an offer letter has already been provided. Another area of impact for the branch will be on travel with only essential travel to be approved. I expect we will see more on what constitutes essential travel in the communication that comes tomorrow.

I wanted to provide you with the heads up of what's to come and wish I had more details to provide than I do. In addition to the immediate spending controls that will be communicated tomorrow, we have been asked to complete a budget exercise to identify other areas of potential savings across the branch for this fiscal year. This information is required to be submitted by the ministry to the Secretary of Treasury Board by October 4, 2019.

I would appreciate that you keep this information confidential until there is broader communication to all staff. I recognize the uncertainty this creates and I don't want to create any unnecessary alarm for staff – especially since there are more questions than answers at this stage. I may look to schedule a short BMC call before the end of the week so we can have an opportunity to talk as a group. In the meantime, please let me or any of the executive directors know if you have any questions or concerns. It would also be appreciated if you could advise of any concerns staff are raising as I expect word from other ministries will start to trickle out.

As with all things, we will get through this. And as always, we are stronger together and I'm grateful for such a strong team. ☺


Currently, as you know, managers may not refuse TA opportunities for their staff. The PSA has confirmed that there are no plans for the Agency to amend the TA policy at this time.

#### Dear colleagues,

In response to a government-wide directive from Treasury Board, our ministries are taking actions to reduce discretionary spending through the immediate implementation of spending restrictions. As you may know, government has been under spending restrictions for several years and the additional actions that we are taking today are to ensure that funding is invested in the priorities that matter for people and maintain strong fiscal management, debt affordability, and balanced budgets.

#### What does this mean?

Effective immediately, all hiring must have Deputy Minister approval. This includes hiring for positions that are currently in the recruitment process. For competitions underway, unless a written offer has been given, Deputy Minister approval must be reconfirmed and no offers given until Deputy Minister approval is received. All positions which previously received blanket approval on their bulk hiring will now be reviewed by the appropriate Deputy Minister. The exception to this will be essential operations staff such as sheriffs, correctional officers, probation officers and prosecutors.

Only essential travel should be considered and any travel whether in province or out of province, which is not litigation-related or essential for a statutory obligation or fully reimbursed, will require pre-approval by the Deputy Minister.

Discretionary spending, including new contracts, is now on hold. Only essential expenditures should be considered and these should be pre-approved by your Deputy Minister. Essential expenditures approved by branches and divisions will be monitored by the Corporate Management Services Branch on behalf of the joint executive team.

The approval process for other discretionary expenditures is also being reviewed and targets will be developed through our corporate governance committees. More information on this to come.

The hiring approval process will be communicated through executive next week. In the meantime, please speak with your ADM if you have any questions.

The AG and PSSG joint executive team recognizes the challenges that can come with these constraints. We want to thank you for your commitment and ongoing dedication to serving the citizens of B.C.

## **Facilities Governance Committee (FGC) Colleagues:**

To recap our discussion at this morning's FGC meeting (September 24), all ministries received an Expenditure Management Target Letter from the Chair of Treasury Board, requiring that all Ministries develop an in-year savings plan focussed on reducing discretionary spending. MAG and PSSG also received savings targets which have already been shared with the Executive Committee and branch finance representatives.

Subsequently, Salman Azam has asked that every CMSB division develop a potential savings plan for their area of responsibility. To that end, Facilities Services Division has developed a draft template (see attached) to identify 3 tiers of potential facilities savings and we are seeking your input to help populate this information.

**Tier 1** – Minor Impact/Low risk (low lying fruit): These projects can be potentially deferred to fy 20/21 or beyond, and are non-critical and/or not started yet.

**Tier 2** – Moderate Impact/Moderate risk: These projects may be deferred to future years, but *in addition to the projects identified in Tier 1*, this tier will also include potentially critical projects (either from current budget or contingencies) that have not yet been initiated or are already in progress.

**Tier 3** - Major Impact/High risk: These projects may be deferred to future years, but *in addition to the projects identified in Tier 1 and Tier 2*, this tier will also include critical projects (either from current budget or contingencies) that have not yet been initiated or are already in progress.

The attached template shows an example for a special purpose property (courthouse or correctional centre) which are complicated facilities with many distinct project categories (i.e.

Mandatory Operating Equipment [MOE] expense, Tenant improvement [TI] expensed, TI amortization, etc.). However, other branches with office inventory may not be as complicated so do not feel compelled to populate all project categories shown.

Your S/FPM will be contacting you with a template customized for your branch and prepopulated with current information regarding your existing facilities costs. They will also be available to assist you in completing this task. We will be depending upon you and your staff's invaluable input to identify risks and impacts as a result of delaying or cancelling projects/facilities requests.

Please note that David Hoadley has already contacted branch financial contacts and ADMs to assist with identifying potential savings in all areas (not just facilities). Please ensure you touch base with your finance area to avoid duplication of information.
