- · A detailed breakdown of all fees, charges and taxes
- · Seat or standing area location

 $\cdot$  Any terms and conditions on the ticket

Ticket sellers that violate these requirements will be subject to significant enforcement actions. These include compliance orders, property freezing orders, administrative penalties as high as \$50,000 for corporations, and fines up to \$100,00 for corporations. There is also a right to take action in civil court for losses suffered as a result of someone's violation of the legislation.

#### Recommendation

Bill 27, the Ticket Sales Act is not yet in force and regulations are being developed prior to the new legislation being implemented. Consumer Protection BC will administer and enforce the legislation.

#### **Exercise of Discretion:**

The Freedom of Information and Protection of Privacy Act (FOIPPA) contains both mandatory and discretionary exceptions to disclosure. Sections 13 to 20 are the discretionary exceptions. Where Information Access Operations (IAO) has advised the head

that a discretionary exception may apply, it is important that the head consider the possibility of releasing the information despite the fact that an exception may apply.

### Factors relevant to the exercise of discretion include:

- the general purposes of the legislation: public bodies should make information available to the public; individuals should have access to personal information about themselves;
- the wording of the discretionary exception and the interests which the section attempts to balance;
- whether the individual's request could be satisfied by severing the record and by providing the applicant
- with as much information as is reasonably practicable;
- the historical practice of the public body with respect to the release of similar types of documents;
- the nature of the record and the extent to which the document is significant and/or sensitive to the public body;
- whether the disclosure of the information will increase public confidence in the operation of the public body;
- the age of the record;
- whether there is a sympathetic or compelling need to release materials;
- whether previous orders of the Commissioner have ruled that similar types of records or information should or should not be subject to disclosure; and
- when the policy advice exception is claimed, whether the decision to which the advice or recommendations relates has already been made.

### **Background**

VANCOUVER - A former jail guard has won his discrimination complaint against the British Columbia government for being forced to work in what the human rights tribunal concluded was a "poisoned work environment."

Levan Francis, who is black, filed a complaint to the B.C. Human Rights Tribunal in 2012, alleging colleagues and supervisors at the North Fraser Pre-trial Centre in Port Coquitlam used racial slurs and stereotyped him.

During a 12-day hearing the government claimed that Francis used accusations of racism as a shield when his performance was criticized and fabricated allegations for his human rights complaint. But adjudicator Diana Juricevic ruled Francis was subjected to racism that only got worse after he made the rights complaint when he was called a "rat" who had a "target on his back."

No settlement or award was issued, but the chair said she would retain jurisdiction of the dispute to complete that process.

Francis left his job nine months after making the human rights complaint, and Juricevic says in her ruling there seemed to be no other option for him but to leave.

### Recommendation

Statement from BC Corrections Spokesperson Cindy Rose:

"The Human Rights Tribunal's findings are deeply troubling, and BC Corrections' legal counsel is currently reviewing them. Because this matter remains before the tribunal pending the remedy phase, it would be inappropriate to comment further on the decision at this time.

"What I can confirm is that, when these allegations came to light years ago, BC Corrections contracted outside experts to provide mandatory antibullying and harassment training to all staff at North Fraser Pretrial Centre.

"BC Corrections staff are expected to model high standards of behaviour, including civility, courtesy and professionalism in their interactions."

"Maple Ridge Coun. Gordy Robson brought a motion to the community's June 18 council meeting to try and start the discussion again on establishing a provincial police force to replace the RCMP. The municipality will be bringing it forward as a resolution to the next UBCM convention.

I'd like to ask, what does the province think of this idea? How often is it brought up with the ministry? Is this something the province would entertain, in light of Surrey's initiative to establish its own municipal police force? Is the province doing any work to evaluate the viability of having its own provincial police? Those kinds of questions."

#### Recommendation

- It is the responsibility of the Minister of Public Safety and Solicitor General, under the Police Act, to ensure adequate and effective policing for all of British Columbia.
- The current integrated policing structure we have in B.C. is a key part of our strategy to meet current and future policing challenges and B.C.'s high level of integration helps communities stretch their policing budgets by giving their police access to sophisticated equipment and expertise.
- The Police Act provides three options for policing; establishing a municipal police department; enter into an agreement with the Province for RCMP municipal services; or, with provincial support, enter into an agreement with another municipal police department to provide policing.

- While the RCMP Municipal Police Unit Agreement (MPUA) has a 20-year term, it also has a two-year opt out clause, and five-year reviews are conducted.
- The RCMP is a national force, and internal management is under the control of the Commissioner but the Minister sets the objectives, priorities and goals for the RCMP provincially and the Mayor, on behalf of Council, sets the priorities for their local RCMP that are consistent with provincial priorities.
- The province will continue the work we've been doing with municipalities to ensure sustainable policing that meets the needs of British Columbians.

The cost of policing the Trans Mountain pipeline protests is now about \$1.8 million. Burnaby hasn't paid the bill for the extra policing since 2014. On Wednesday, MP Peter Julian and Coun. Sav Dhaliwal held a news conference to say Ottawa is responsible for 100 per cent of the costs as per the Municipal Police Unit Agreement sections 8.3 and 8.4 which cover an Emergency and a Major Event.

Reporter also says "MP Dhaliwal who said, no, these are the normal costs of policing in Burnaby so he believes Ottawa is 100 per cent responsible for the costs. But he liked the idea that the issue is now "on their radar.""

#### Recommendation

- The Police Act is clear that municipalities over 15,000 in population must pay the cost of policing within their municipalities—this includes the cost of policing matters related to civil disobedience.
- In addition, Burnaby is a signatory to a Municipal Police Unit Agreement (MPUA) which provides both a dispute mechanism and an article regarding default under the agreement.
- The dispute is under the Municipal Provincial Unit Agreement (MPUA) between Burnaby and the Province, however the federal government is aware and is working with Ministry and the City of Burnaby to resolve the matter.
- In recognition of the mutual benefit of contract policing, Burnaby, as an RCMP jurisdiction, receives a 10 per cent federal contribution to their policing costs. In addition, the Province contributes over \$71 million to fight organized crime and gangs of which Burnaby, like other Lower Mainland Municipalities, is a beneficiary. Burnaby also benefits in numerous ways from provincial policing infrastructure.
- The obligations of municipalities are clear, and we encourage them to work with their local police to minimize the impact on municipal budgets while ensuring the safety of the public.
- The province is aware of Burnaby's views on paying for these policing matters, and we confirm there is an outstanding non-payment with respect to 2014 and more recent 2017/18 invoices.
- That said, we understand the significance of these events and will continue to work closely and collaboratively with the city of Burnaby to ensure public safety.
- It's important to note that regardless of any disagreement over funding, policing services will continue uninterrupted and will be unaffected by any funding disagreement.
