## **CONSUMER PROTECTION – Ticket Resales**

## SUGGESTED RESPONSE:

- British Columbians have told us it's extremely frustrating when people can't get tickets to live entertainment events without resorting to tickets sold on the secondary market at highly inflated prices.
- We want to ensure everyone has a fair chance of getting a ticket at a fair price, so we are establishing a regulatory framework for the sale and resale of tickets in B.C.
- The new Ticket Sales Act will help create a level playing field by prohibiting bots and improving transparency for consumers trying to buy tickets.

#### When will regulations be in-force:

- Government wanted to make sure it had done its due diligence in all aspects of this file: consulting with fans and stakeholders and looking at all policy options. This takes time and is not undertaken lightly. We wanted to get it right.
- My ministry staff are currently working towards completion of regulations for the Ticket Sales Act.

## **KEY Stats from questionnaire:**

- 13,744 visits to the Ticket Buying engagement site
- > 6,507 completed online questionnaires were received

## **BACKGROUND:**

In October 2017 media suggested that "ticket promotors in B.C. might give political donations, and because of this government may be hesitant to move on ticket sale legislation. Legislation that current government was keen to implement when in opposition."

Public complaints are largely based on not being able to get tickets to popular events, where demand for the tickets greatly exceeds the supply available. For high-profile events the sale of tickets amounts to a lottery where those who can type or phone in the quickest get the limited supply. Ticket-buying software ("ticket bots") allows to users of bots by-pass online security features and jump to the front of the queue.

On July 1, 2018, Ontario brought into force legislation to strengthen consumer protection in their province through a number of measures, including changes to ticket selling in Ontario.

Under Ontario's new government, elected 2018, the legislated price cap on resold tickets was not brought into force. From the news release:

"The previous government attempted to institute a cap on ticket re-sales with no way to enforce that cap, resulting in less consumer protection. We have paused the implementation of this section until we can review this provision in full to make sure it is in the best interest of Ontarians."

On August 1 2018, Alberta brought into effect new consumer protection laws to ban ticket bots and ensure refund protections from resellers, from the news release.

"Put fans first by helping prevent ticket fraud and gouging through measures including: banning ticket bots that allow scalpers to buy tickets in bulk, requiring that ticket sellers carry out due diligence to identify any ticket purchased by bots, and requiring re-sellers to offer full refunds for tickets that are cancelled, counterfeit or purchased by bots."

The B.C. government cannot guarantee that people will be able to purchase tickets to events where demand exceeds supply. It can, however, strive to create a level playing field for everyone trying to obtain those tickets.

In March of 2018, the Ministry launched a public questionnaire to find out what the public's thoughts on the state of ticket buying and selling in B.C. were. The questionnaire was available for three weeks and over 6500 completed responses were received which will help to inform the legislation on the subject. The report on these results was released to the public through engage.gov.bc.ca on August 13<sup>th</sup>, 2018. The report was directly emailed to journalists who have been following the ticket buying file closely, as well as several ticket industry stakeholders previously engaged by ministry staff.

On January 31, 2019 the Competition Bureau of Canada found that Ticketmaster's use of scalper bots, to facilitate helping the resale of tickets for people using its Tradedesk online sales operations, did not violate the *Competition Act* of Canada. In their press release they noted "Generally, consumer protection and unfair business practices, including as they relate to ticket sales, are addressed at the provincial level."

During the Spring 2019 session Minister Farnworth introduce the Ticket Sales Act, which laid out the province's regulatory framework for making legislated changes to the ticket sale industry.

## Requirements include:

- clear and prominent disclosure of prices;
- refund guarantees by secondary sellers and secondary ticketing platform operators;
- disclosure of key terms and conditions by primary and secondary sellers;
- · ticket resellers to disclose they are secondary sellers;
- prohibition of the sale of speculative tickets that the seller does not possess or control;
- the ability for civil action to be taken by consumers or ticket selling businesses if they feel they have suffered losses as the result of a contravention of the legislation.

#### SUMMARY:

- Doug Enns is requesting an opportunity to introduce Rod Dewar to the Minister as the incoming Chair of CPBC. Doug Enns will complete his term as Chair for the CPBC Board of Directors in December 2019.
- Mr. Enns is expected to express his support to work with ministry staff and the Crown Agencies and Board Resourcing Office to recommend candidates for the Minister's appointee on the Board, in preparation for the current government member's term end in February 2021. Anar Popatia is the current government member and she is not eligible for re-appointment after serving her maximum term.
- CPBC will provide updates on current issues and will not be making any requests of government. The ministry has been working closely with CPBC on these issues.

#### **BACKGROUND:**

#### CPBC Overview

- Since 2004, CPBC has been delegated responsibility for the administration of the Business Practices and Consumer Protection Act and the Cremation, Interment and Funeral Services Act. In 2007, CPBC assumed additional responsibility for administering the Motion Picture Act.
- CPBC is self-funded through licensing fees. The Authority licenses roughly 8,800 businesses annually, across eight industries: debt repayment, debt collection, payday lending, telemarketing, home inspection, travel agents, motion picture retailers, and funeral services.

#### **CPBC Current Issues**

Recent Agreements to Classify Motion Pictures for Ontario
 On October 4, 2019, CPBC and Ontario entered into an agreement to have BC's film classifications used for commercial general release films and trailers shown in

Ontario. CPBC classifies films shown in BC and has separate agreements to classify films for Saskatchewan and Manitoba. Ontario's agreement with CPBC is an interim solution following Ontario's wind down of its film authority and review of its motion picture legislation.

## Ticket Selling and Re-selling

CPBC will be the administrator for the new *Ticket Sales Act*, which establishes a regulatory framework for the sale and re-sale of tickets to live recreational, sporting or cultural events in British Columbia. The ministry is working closely with CPBC on the development of regulations and a delegation agreement to bring the Act into force.

#### High Cost Credit Lending

This past spring's amendments to the *Business Practices and Consumer Protection Act* will establish a new regulatory and licensing regime for alternative high-cost credit providers and products in BC (e.g., instalment loans; credit building loans and high-cost lines of credit). The regime is similar to current payday lending laws and builds on existing provisions related to open and fixed credit. When the amendments are brought into force, high-cost lenders will be licensed by CPBC.

Money Services Businesses (MSBs)
 CPBC is supportive of recommendations by Peter German and the Expert Panel on Real Estate for BC to regulate and license money services businesses, as part of the government's response to address money laundering. CPBC is willing and prepared to be the licensing body based on its experience and successful record in regulating various business sectors. Ministry staff and the Ministry of Finance are

Your May 24, 2019 email, addressed to Premier John Horgan and the Honourable Katrina Chen, MLA for Burnaby-Lougheed, has been referred to me as consumer protection matters is the responsibility of the Ministry of Public Safety and Solicitor General.

You are not alone in your frustration regarding the ticket-buying process. In 2018, over 6,500 British Columbians responded to an online government survey regarding ticket sales. They told us they were frustrated with the process of buying live event tickets and in particular expressed concerns about their experiences buying tickets on the re-sale market. Many survey respondents said they would like to see changes to the law including increased transparency requirements and refund guarantees from ticket re-sellers, and a prohibition on ticket bots.

In the spring of 2019, I introduced Bill 27, the *Ticket Sales Act* (The Act), to address these concerns. The Act was passed by the Legislative Assembly of British Columbia in May 2019 and can be viewed here:

https://www.leg.bc.ca/parliamentary-business/legislation-debates-proceedings/41st-parliament/4th-session/bills/progress-of-bills

As noted in your email, it is becoming increasingly common for average ticket buyers to be shut out of the ticket-buying process. The Act aims to resolve this and level the playing field for people purchasing tickets to recreational, sporting and cultural events in British Columbia. It bans mass ticket-buying software ("bots") that is used to jump the line and quickly buy up tickets before average consumers are able to purchase them. Under the new rules, the sale of tickets purchased using bots is prohibited and ticket sellers must take measures to detect bots and cancel any tickets purchased using them. In addition, the new rules prohibit businesses that sell tickets on the primary market from diverting those tickets directly to related ticket re-sale businesses. This unfair practice pushes consumers to buy tickets on the re-sale market for prices that are substantially higher than face value.

Other key features of The Act include:

- Ticket seller transparency requirements regarding ticket price, currency, seat location and terms and conditions
- Refund guarantees for tickets purchased on the re-sale market
- Prohibition on the sale of speculative tickets that the seller does not possess or control
- Requirement for ticket re-sellers to disclose their identity as such, as well as their contact information
- Right of civil action for those who have suffered losses as a result of a violation of the Ticket Sales Act

The government is currently working on regulations to support implementation of the Act, and anticipates the legislation will come into effect in 2020.

Since publication, the main update is with Viagogo, who are heading to court for contempt via the CMA action. That becomes a criminal case, with potentially tough sanctions for the directors.

As Adam T mentioned, there are no silver bullets. But two hugely important aspects for improving this market are (i) transparency, which unfortunately has to be enforced; and (ii) for industry to offer the consumer a capped authorised alternative for resale.

The speculative practices of VividSeats and others are, to these eyes, simply ridiculous. See below. It positively encourages bad practice, and allows a relatively small number of ticket touts to cause havoc.

This listing describes tickets that the seller does not have in hand, but will obtain for you. After you place your order and your order is confirmed, we guarantee that your tickets will be within the zone or section listed or one comparable and that you will receive these tickets in time for the event or your money back. Orders exceeding four tickets may be split up into different rows within the requested zone or section.

Today the Government of B.C. introduced Bill 27 – the Ticket Sales Act. The Bill will establish a regulatory framework for the sale and resale of tickets to live recreational, sporting or cultural events in British Columbia. Highlights of the Bill include:

- Prohibition on bots/mass ticket-buying software
- Transparency requirements for all ticket sellers, including face value, total price, seat location and terms and conditions
- Protections for ticket purchases on the secondary market
- Ban on speculative tickets
- Ban on the sale of tickets that sellers do not have in their possession or control
