Minister,

Mary provided the below information in regard to your call with Chief Sellers at 9:45. This nicely summarises the major highlights of agreement. One other element to remember is they will be NUMBER ONE. First in BC, first in Canada.

- Ability to operate both retail stores and a production facility (the CCLA generally prohibits businesses from operating in both retail and production)
- On reserve retail stores will be "authorized" rather than "licensed" by the province, and there are minor variations to the rules for these "authorized" on reserve stores
- Commitment to pursue opportunities for training or employment of WFLN members in compliance and enforcement of Provincial Cannabis Laws
- Time limited exemption from any moratorium on new retail licences, until October 2025 (approximately 5 years)
- Commitment for LDB to make an initial purchase for cannabis from the WFLN-owned production facility, subject to certain conditions (price/quality)
- Commitment to allow the WFLN producer to do farm-gate sales (**note that farm-gate/direct delivery announcement is planned for Sunday or Monday; it may be worth foreshadowing this to forestall any suggestion of bad faith bargaining; could also say that we expect WFLN will have access to farm-gate in advance of broader program launch**)
- Ability for the farm gate store to sell arts and crafts produced by members of Indigenous nations in the region

Also, while this is outside the section 119 agreement

- The \$500,000 grant from FLNR to support development of their licensed production facility

Urgent and Primary Care Centre coming to Tri-Cities

TRI-CITIES – People living in the Tri-Cities will soon have better access to same-day health-care services when and where they need it with a new urgent and primary care centre (UPCC).

The temporary location will open February 2021 and a Request for Proposals for a permanent location is underway.

“The new UPCC will allow people in the Tri-Cities including Coquitlam, Port Coquitlam, and Port Moody to access the everyday health-care services they need closer to home, while also taking the demand off the emergency department” said Adrian Dix, Minister of Health. “We are working in partnership with local communities and health-care providers to deliver on our primary care strategy throughout the province.” **NOT APPROVED.**

The UPCC will be operated by Fraser Health, with the support of the Fraser Northwest Division of Family Practice, Indigenous Partners and the Tri-Cities on the ancestral, traditional and unceded territories of the Kʷikʷəłəm (Kwikwetlem), Qiqéyt (Key-Kayt) and Coast Salish Nations.

A team of health-care workers will join the centre, including family physicians, nurse practitioners and registered nurses, as well as allied health providers (pharmacist, social worker and clinical counsellor) and support staff.

“I am very happy for the communities in the Tri-Cities that will benefit from this new urgent and primary care centre to help meet their daily health-care needs closer to home,” said Rick Glumac, MLA for Port Moody-Coquitlam. “Urgent and primary care centres are an excellent solution for people that may not have a regular family doctor, and they can also help patients secure a primary care provider.”

The centre will focus on providing ongoing, long-term primary care, as well as urgent care to people with non-life-threatening conditions who need to see a health-care provider within 12 to 24 hours, but do not require an emergency department. The centre will offer services to people with minor cuts or burns, headaches, sprains, and experiencing mental health and substance use challenges.

This is the 21st urgent and primary care centre announced under the government’s primary care strategy. The UPCC in the Tri-Cities will be the sixth centre in the Fraser Health region, including two in Surrey, and one each in Burnaby, Maple Ridge and Abbotsford.

- Urgent and primary care centres are part of a comprehensive strategy to transform B.C.'s health system by bringing together and co-ordinating with health-care providers, services and programs to make it easier for people to access care, receive follow-up and connect to other services they may need.
