AMENDING AND RENEWAL AGREEMENT

MARCH

THIS AGREEMENT made the 15 day of February, 2017.

BETWEEN:

SHAW CABLESYSTEMS G.P. ("Shaw Cable") and SHAW SATELLITE G.P. ("Shaw Direct") Suite 900, 630 – 3 Avenue SW Calgary, Alberta T2P 4L4 (Shaw Cable and Shaw Direct collectively referred to as "Shaw")

and -

HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA, as represented by the MINISTER OF PUBLIC SAFETY AND SOLICITOR GENERAL, CORRECTIONS BRANCH
7th Floor - 1001 Douglas Street

("Corrections Branch")

WHEREAS:

Shaw and Her Majesty the Queen in Right of the Province of British Columbia, as represented by the Minister of Justice and Attorney General, Corrections Branch are parties to that certain bulk cable service contract dated December 20, 2012, as amended (collectively, the "Agreement") pursuant to which Shaw provides to the Properties during the Term, as more particularly set out in the Agreement;

AND WHEREAS:

The Agreement was transitioned from the Ministry of Justice and Attorney General to the Ministry of Public Safety and Solicitor General, Responsible for the Corrections Branch in December 2015;

AND WHEREAS:

Shaw and Corrections Branch desire to renew the Agreement and amend certain terms;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the mutual covenants set out below the parties hereto agree as follows:

- 1. All defined terms contained in the Agreement shall have the same meanings in this agreement, unless expressly defined otherwise herein.
- The effective date of this Amending and Renewal Agreement shall be April 1, 2017.

- The Term of the Agreement is renewed for a period of five (5) years commencing on April 1, 2017;
- 4. Section 7 of the Agreement shall be deleted in its entirety and replaced with the following:
 - "Shaw will, at its own cost, service, maintain and manage Shaw's Network to ensure the delivery of the Services."
- 5. Section 15 of the Agreement shall be deleted in its entirety and replaced with the following:

Shaw and Corrections Branch acknowledge and agree that Corrections Branch may terminate the Agreement at any time upon sixty (60) days written notice to Shaw and the Early Termination Charge will be payable as follows:

- (a) Fifteen percent (15%) of the remaining bulk rate charges otherwise payable to the end of the Term if terminated in the first year;
- (b) Ten percent (10%) of the remaining bulk rate charges otherwise payable to the end of the Term if terminated in the second year;
- (c) Five percent (5%) of the remaining bulk rate charges otherwise payable to the end of the Term if terminated in the third year;
- (d) Five percent (5%) of the remaining bulk rate charges otherwise payable to the end of the Term if terminated in the fourth year;
- (e) Five percent (5%) of the remaining bulk rate charges otherwise payable to the end of the Term if terminated in the fifth year.
- 6. The following clauses will be added to the Agreement:

"Shaw will provide all initial digital cable terminals (DCTs) required to receive the Services at the Nanaimo Correctional Centre. BC Corrections acknowledges that it is responsible for, and will at its sole cost and expense replace, any lost, stolen, or damaged DCTs. At the expiry or earlier termination of this Agreement, BC Corrections will be responsible for collecting all DCTs. Shaw will arrange to pick-up the DCTs from BC Corrections."

"Shaw agrees to grant to BC Corrections to a one-time right to change the service level to any Property under the Agreement to Personal TV (Shaw Cable) and English Essentials + Lifestyle (Shaw Direct) at the rates set out in Schedule "B" at anytime during the Term upon thirty (30) days notice to Shaw as the address set out above (Attention: EVP & Chief Legal and Regulatory Officer), and the parties will enter into a further amending agreement to address this change."

- BC Corrections has entered into a Service Order Form (SOF) dated November 21, 2016
 for services to 200 Enterprise Way, Oliver BC and hereby terminates the SOF effective
 March 31, 2017. The parties agree that this Property will be added to the Agreement.
- 8. Schedule "A" is hereby deleted in its entirety and replaced with Schedule "A" attached hereto to include this additional Property.
- Schedule "B" is hereby deleted in its entirety and replaced with Schedule "B" attached hereto.
- 10. The parties acknowledge and agree that Schedule "C" of the Agreement is no longer applicable.
- 11. Except as amended by this agreement, the terms and conditions of the Agreement shall remain in full force and effect with the intention that the Agreement should be read in conjunction with and construed with this agreement.
- 12. This Agreement shall be binding upon the parties hereto and their respective successors, assigns and permitted assigns as the case may be.

Shaw shall increase or decrease the monthly service charge as applicable by the number of rooms added or removed multiplied by the bulk rate shown below. Corrections Branch acknowledges that TMN is not available on a per room basis.
